ORDER

Sub: Regarding termination of jurisdiction and affiliation of the colleges situated in Bikaner Division from M.D.S.University, Ajmer and for affiliating them with the University of Bikaner.

Under provisions of section 4(1) and 50 (1) of University of Bikaner, Act 2003 (Act No. 14 of 2003) read with section 6 of the University of Ajmer Act, 1987 (Act No. 38 of 1987), the State Government hereby terminate the territorial jurisdiction and so also the affiliation of the University of Ajmer over the colleges specified below, situated in the jurisdiction of the University of Bikaner and also hereby extend affiliation of the University of Bikaner over them with immediate effect, namely:



6. The results of supplementary examinations-2003, results of revaluation in respect of 2003 or earlier examinations of the students of Bikaner Division enrolled in the M.D.S. University, Ajmer, shall be processed by the M.D.S. University, Ajmer and the same shall be treated valid for all purposes by the University of Bikaner even if such results are declared after the issue of this order..

7. The M.D.S. University Ajmer shall complete remaining examinations, if any, of the year 2002-03 of the regular and non collegiate students of Bikaner Division and declare their results, which shall be treated as valid for all purposes, even if they are declared after the issue of this order.

8. The students of the Colleges situated in the jurisdictional area of the University of Bikaner, registered with the M.D.S. University, Ajmer for Ph.D. degree or any other research degree shall continue to remain under the control of M.D.S. University, Ajmer and the evaluation of their thesis and viva-voce examination shall be conducted by the M.D.S. University Ajmer, who will also issue their degrees. However, the new candidates of Bikaner Division shall be registered by the University of Bikaner.

9. Till such time as the University Grants Commission provides its approval to the University of Bikaner under section 2(f) or 12 B, as the case may be, the M.D.S. University, Ajmer shall continue to deal with the case of Development Grants or project grants being received or to be received by the above mentioned colleges or their teachers, so that there is no interruption or hardship in receiving grants from the U.G.C. by such Colleges or the teachers of these colleges.
