The internal assessment within the college primarily includes term tests, and group discussions at the department level. The term tests are becoming popular . Surprise tests are conducted during the class hours for assessing the performance. The pattern, nature and structure of evaluation of the surprise tests are designed by the concerned teaching faculty. It was felt necessary to give assignments and conduct Extension lectures for the students in order to provide a platform for free expression and exchange of ideas. Tutorials and informal discussions are held for slow learners by giving them small and easy assignments and also motivating them, rewarding them by a token of appreciation for their achievements. The seminars and discussions are a later addition to the practice of internal assessment as an improvisation upon earlier practice of conducting tests alone. It has been realized that an active and participative method would prove more fruitful.
