Title of the practice :- Best practices followed for developing ecofriendly green campus as- Goal- To maintain the campus green and clean Despite of the unfavorable conditions like scanty rainfall throughout the year our chief goal is to beautify the college campus by planting trees inside and outside the college campus with the help of students, teachers and other staff members. Our Water Harvesting System has helped a lot to preserve this greenery in our surroundings. NSS students and other students of this college are motivated for the planting of trees as well as perform the responsibility to take intense care of the trees they planted. The effort is made to make them aware about the importance of plantation to nature and motivated to plant at least two plants on his/her birth anniversary. In several environment awareness program students are asked to take pledge for not harming nature or exploit plants for religious occasions. During one day or seven days camp of NSS activities general public is also made aware through slogans in rallies to make the environment green, clean and free from pollution. College contributes to greenery by planting approximately more than 200 plants during the monsoon months and for this plantation program is also organised every year in the month of July. Physical features of khetri land is quite hilly or rocky so not supporting vegetation much as well as the source of water for irrigating plant is not accessible and available water is also rich in fluoride. Planted trees are injured due to intense heat and are also destroyed by stray cattle which enter the building. Therefore in such critical situations by taking the help of local Administration and municipality solutions are made. For irrigating plants electric motor/generator has been set in the old well. Enclosing the college campus by strong and high boundary wall which prevents the stray cattle from entering inside the college campus and college development committee has appointed a fourth class employee for preventing the intruders and taking care of the plants. Dustbins are kept at various places in college corridors to make the environment clean and healthy. II. Title of the practice - To impart value
