

Dear Sir/ Madam,

This has reference to your communication recommending **five** colleges for selection under the scheme "**Colleges with Potential for Excellence**" (CPE) during Round-IV, for which applications were invited upto **30th September, 2010**.

The proposals of the colleges recommended by your University were evaluated by the Working Group on CPE appointed by the Chairman, UGC, using a scoring scale. Based on the above evaluation, the Standing Committee on CPE had shortlisted 56 Colleges to be awarded CPE status. These 56 colleges were invited to UGC office during 30th May, 2011 to 2nd June, 2011 for an interface meeting with an Expert Committee for a presentation of their Action Plan and Budget. Based on the discussion, the Expert Committee recommended only 50 colleges for the award of CPE Status. This was placed before the Standing Committee on CPE at its meeting held on **8th August, 2011**. The Commission at its meeting held on **24th August, 2011** considered and approved the recommendations of the Standing Committee on CPE.

I am happy to inform you that the following college(s) affiliated to your University have been selected for the award of CPE status during Round-IV.

Kindly ask the Principal(s) of the above College(s) to send a Certificate to the undersigned that (a) the data provided by them in the proposal are factually correct, (b) the college is a grant-in-aid/Government/Constituent college and (c) the college agrees to abide by the decision of the Commission in revoking the CPE status, if it is later found that the data submitted by the college are found to be incorrect.

If the selected college(s) have not **obtained autonomous status so far**, you may advise them to take immediate steps in this regard. In case your University Act does not provide scope for conferring autonomous status to the colleges, I request you to take necessary steps to introduce suitable amendments in your University Act.

Finally, wherever all the slots allocated to a State/Union Territory have not been filled up during the fourth round, fresh proposals will be invited to fill up the vacant slots. You may advise your colleges accordingly. The details regarding vacant slots may be seen on the UGC website www.ugc.ac.in.

You may be happy to know that your College is one among the 50 Colleges identified under the scheme "Colleges with Potential for Excellence" (CPE) during Round-IV.

Based on the discussion the Expert Committee had with you, the following budget has been recommended under the above scheme.

Subsequent to the above meeting, the UGC has received a letter No.G-23011/13/2011-IF.I dated 13th June, 2011 (copy enclosed) from MHRD requesting the UGC to re-classify all the Non-Recurring and Recurring budget under 'Grant-in-Aid General', 'Grants for creation of capital asset' and 'Grant-in-Aid Salary'. Subsequently, another letter has been received requesting to allocate 15% for SC, 7.5% for ST and 77.5% for General in respect of all the Schemes of UGC. A copy of OM No. F.7-3/2010 (CPP-II) dated 2nd August, 2011 is enclosed herewith.

Since the above communications have been received after the Expert Committees' work, **it has been decided that Colleges may be requested to re-allocate the budget already approved by the Expert Committee as per above recommendations.** Accordingly, you may give the budget for your college as per the format given in the following table:-

- # All expenditure related to Building, Equipment, Books, Computers, Language Lab., ICT tools etc. (which are one-time expenditure) are to be included under "**Capital Assets**" headings.
- @ Maintenance of Lab. equipments, Consumables for laboratories Chemicals etc., Software, Faculty improvement, Seminar, Field work, etc., be included under **Grant-in-aid General**.

A copy of Govt. of India Rule **90 & 91 of GFRS** indicating Principles of clarification of Capital & Revenue Expenditure is also **enclosed** for guidance.

Further, the relevant budget head as required by you under the different items be indicated **as the budget heading given by the Expert Committee at pre-page is too general in nature**, which will come in the way of implementing the CPE status. **However, the total allocation under Non-Recurring and Recurring may be kept intact while allocating the amount under various items, as per the format given above.**

Sub: Release of 15% "Adhoc On account grant" under the scheme of Plan Block Grant- in-aid during XII Plan period.

Sir/Madam,

As per the decision taken in the Commission meeting held on 19th July 2012, 25% of allocation of XI Plan College Development Assistance was released as "on account grant" for XII Plan period. Now the Commission has decided in the commission meeting held on 30th December 2013 to release up to 40% of GDA + merged schemes allocated to the individual colleges during XIth Plan period, including 25% of grant already released earlier to B.S.R. Govt. Arts College, Alwar, Rajasthan- 301001(Raj) the colleges during XII Plan. Accordingly, I am directed to convey the sanction of the Commission for payment of Rs. 1559400/- to B.S.R. Govt. Arts College, Alwar, Rajasthan- 301001(Raj) the for the XII Plan period as detailed below:



- The Sanctioned grant may be treated as "Adhoc on account" grant for XII Plan. The allocation made now is Provisional Allocation and the final allocation would be made on finalization of XII Plan Guidelines. The grants sanctioned now would be adjusted against the XII Plan allocation to be made subsequently on the basis of assessment.
- XIIth Plan may be treated as equivalent to GDA+ merged schemes of XIth Plan period, Ratio of allocation under budget heads 35 & 31 (Non-recurring & Recurring) may remain 80:20 as in UGC's guidelines. There should not be any re-appropriation from budget head 35 to 31 or vice versa. The release for SC/ST may be made as per the allocation of 15% and 7.5% respectively.
- The amount of the grant shall be drawn by the Account Officer CRO, UGC, Bhopal (Drawing and Disbursing Officer), University Grants Commission on the Grants-in-aid bill and shall be disbursed to and credited to the Principal, B.S.R. Govt. Arts College, Alwar, Rajasthan- 301001(Raj) by him/her through RTGS/NEFT.
- The Grant is subject to the Adjustment on the basis of Utilization Certificate in the prescribed Performa submitted by the College.
- The University/College shall maintain proper accounts of the expenditure out the Grants, which shall be utilized, only on approved items of expenditure and ensure proper labeling of the items purchased.
- The Utilization Certificate to the effect that the Grant has been utilized for the purpose for which it has been sanctioned shall be furnished to the University grants Commission as early as possible after the close of the current financial year. Balance grant will be released only on receipt of audited UC and Statement of Expenditure etc., signed by Chartered Accountant.
- The assets acquired wholly or substantially out of University Grants Commission's Grant shall not be disposed or encumbered or Utilized for the purpose other than those for which the Grant was give, without proper sanction of the University Grants Commission and should at any time the college ceased to function, such assets shall revert to the University Grants Commission.
- The University/College/Institute shall maintain a Register of Assets acquired wholly or substantially out of the Grants in the prescribed form.
- The grantee Institution shall ensure the Utilization of Grants-in-aid for which it is being sanction/paid. In case of non-utilization/part utilization, or mis-utilization of grants sanctioned by the Commission for the purpose for which these were approved and in accordance with the terms and conditions of the approval or does not furnish the required documents or is disaffiliated from the University the entire amount paid by the

Commission shall be refunded by the College with simple interest @ 10% per annum as amended from time to time on unutilized amount from the date of drawl to the date of refund as per provisions contained in General Financial Rules of Government of India will be charged.

12. The grant should not be used for Self-Financing/Unaided Courses.
13. It may be noted that the accounts of the grant-in-aid institution shall be subject to inspection by officers of the CRO, UGC, Bhopal
14. The interest earned by the University/College/Institute on this grants in aid shall be treated as additional grant and may be shown in the U.C./Statement of expenditure to be furnished by grantee institution.
15. The University/College/Institute shall follow strictly all the Instructions issued by the Government of India from time to time with regard to reservation of posts for scheduled Castes/Scheduled Tribes/OBC/PH/etc.,
16. The University/College shall fully implement the official Language Policy of Union Govt. and comply with the Official Language Act, 1963 and Official Languages (use for Official purposes of the Union) Rules, 1978 etc.
17. The sanction issues in exercise of the delegation of powers vide commission office order no. 25/92 dated May 01, 1992.
18. The funds to the extent are available under the Scheme.


