Qualitative analysis of Criterion 1

Curriculum is designed by the University of Kota, Kota (Rajasthan) and academic calendar is followed. There is no CBCS pattern but elective course system is followed in both Under Graduate and Post Graduate programs. In the introductory session in each year first few days of the academic session, students are oriented regarding the curriculum, syllabus, teaching and learning behavior bridge course etc.. The faculty members prepare the lesson plan which includes course outcome objectives, content topics, reference books and the expected outcomes from the students. The curriculum designed by the academic committees of the university makes room for sensitizing students with the cross-cutting issues relevant to gender, environment, sustainability, human rights and moral values, but the scope for academic flexibility is limited. A few of the departments are having internships and field projects.

Continuous Comprehensive Evaluation (CCE) pattern is followed for internal evaluation. Social responsibility in students is well invoked through NSS/NCC/Scout which is very active in giving the college campus a clean & green face. Formal mechanism to take feedback on curriculum from stakeholders is there but needs to be enhanced. Different committees are functioning well to monitor the implementation of curriculum, co curricular and other activities. Value added courses are yet to be implemented. Though the college is one of the old government colleges, few permanent faculty members are representing in the Board of Studies, Academic council and other statutory bodies of the University of Kota.

Qualitative analysis of Criterion 2

The college admissions are done as per the guidelines laid down by the both University of Kota and government of Rajasthan. There is continuous decline in the admissions in some of the courses. There is overall gradual increasing in students strength in the college during the last five years. College assesses the learning levels of the students. Extra Classes and Group Discussions were conducted for both slow and higher learners. However, student-centric learning activities through Audio-visual techniques are yet to be used for enhancing learning experiences. ICT enabled teaching through LCD Projector, power point presentations, e-books, websites and e-learning resources are yet to be used on comprehensive basis.

Educational tours, field projects, report writing is in practice. Continuous comprehensive evaluation (CCE) in internal evaluation system is followed. Transparency is followed in evaluation process. The college administration redresses the grievances related to examination under the supervision of the Principal.

Orientation programs were conducted for fresher's. Objective test, oral presentation, poster making, group discussion, assignments are being submitted by the students with the guidance of teachers. Redresser of grievances mechanism is to be strengthened. The college adheres to the academic calendar of University of Kota and Govt. of Rajasthan. Attainments of course outcomes are evaluated by the college. The pass percentage of students is also good over an assessment period of time. However, special efforts to be taken towards Coaching and counseling for the NET and competitive examinations. Admissions to all the programs are given through merit basis as per University rules. During last five years less no student from other state are admitted in the college. In the beginning of new academic session special classes are organized to provide some useful & necessary information to the newly admitted students. Average passing percentage is good; however position of students in the university merit ranks is needs to increase. All important information also needs to be displayed on the college website regularly.

Qualitative analysis of Criterion 3

Research activities of the college are satisfactory and need to be monitored and should be promoted for research funding. Good numbers of teachers are recognized as research guide in various disciplines. Students are oriented towards to inculcate research concept through assignments, seminars, participating in conferences, webinars, training programs and workshops. A few publications are in the Scopus indexing and peer reviewed referred journals by the faculty members. More number of teachers has contributed chapters in books and national seminar proceedings.

College has organized some awareness and extension programs like Blood donation, Tree plantation, health, hygiene, sanitation. NSS unit of college has conducted various programs related to Swachha Bharat Abhiyan, Plantation and Social awareness etc. programs in nearby villages. There are five MoUs with institution of academic importance, other universities, industries and corporate houses. Collaboration and consultancy based on local expertise knowledge need to be explored and used for the development of the college.

The college has spread over 10.85 acre of land with 6079 square meters built up area with four entrance gates along with compounded premise. A Block of 08 rooms were constructed during the last five years under RUSA scheme.

College has 60 classrooms, 12 laboratories, and sports facilities, 1 Seminar halls, girls' common room, staff room, washrooms, playgrounds, one Recreation room with gym facilities. Few class rooms including Seminar Hall with ICT facilities, 80 computers, 10 LCD Projectors, 17 laser printers, 5 VPN connection, 3 Broad band connection and 1 Lease Line (1:1) for internet access. Interactive board as a teaching tool is also available in laboratories. Two points in the campus are spotted as Wi-Fi. Overall maintenance work and Class room furniture and fittings need to be improved. Science laboratories required more spacious to accommodate large number of students. Sports Committee and cultural committee are at place and doing their good job. The college has sufficient ramp facility for physically disabled students. The college has badminton court & a basketball court, volleyball, football, Handball; Kho-Kho & Kabadi are also available. Indoor game facility for chess, table tennis, carom exist which needs to be further improved. Students are encouraged to participate in sports and cultural activities. College has spacious separate library, reading hall is available. Library is partially automated with Alice for Window. College Library has total 81482 volumes of books and subscribes 11 journals, 08 magazines and 9 daily news papers. However, library should have science faculty research journals and latest books for competitive exams yearly basis. Magazines and Text Book collection needs to be improved on par with UG, PG Programs offered and number of students enrolled. A Few e-books are procured and access enabled. E-resources and N-LIST subscription is available with DELNET facility. Awareness programs on teaching learning resources need to be organized. 42 CCTV cameras are installed in the premises. Power Backup facility is existing but which need to be improved as per environment friendly. College has only boys Hostel having capacity of 52 for students.

The large number of students of the college got scholarships & free ships during the last five years. Besides the govt. schemes some faculty provide financial aid to the needy students during the last five years. Total number of 548 scooty distributed amongst girls students under Government of Rajasthan schemes. A few of the students pursuing post-graduation and research programs in various universities and nearby colleges. The Placement Cell in the college needs to be strengthened and should be student oriented. The Alumni Association is registered but need to be renewal and also office bearer of alumni to be nominated for its effective operation and to be contributed towards the academic upliftment of the college. Presently there is student council.

Qualitative analysis of Criterion 6

The governance of the college is reflective in tune with the vision and mission of the college. The Principal is looking after the day-today administration of college. The college practices decentralization and participative management through faculty and college has formed various committees. E-Governance is yet to be regularly introduced in practice in the college. The college follows state govt. policies & rules. The various committees, cells and bodies are constituted as per requirement to take care of academic and administrative to be smoothly executed at the college. Though some main committees are IQAC, Mahavidyalay Vikas Samiti, Building Construction and Maintenance Committee, Sports Committee, Examination Committee, Anti-Ragging Committee, Nature Club etc. do exists and working properly. Limited Financial support is given to teachers to

attend workshop and training programs organized by State Government. College has Performance Appraisal System for teaching and non-teaching according to UGC and State government norms. Institution conducts internal and external financial audits regularly. Internal Quality Assurance Cell (IQAC) is contributing for institutionalizing the quality assurance strategies and processes in the college but need to be improved. Feedback mechanism follow for continuous review for teaching learning process and follow up actions are taken after analysis of the feedback. Though Incremental improvements are made during the preceding five years yet there exists a huge scope for the betterment of the college. IQAC needs to be strengthened and need to organize various programs as per NAAC norms. The periodic review of academic and administrative audit is to be made for the enhancement of quality education.

The college has facilities for gender sensitivity. The college has organized some gender equity promotion programs also during the last five years.

Regarding safety security of women the college has women grievance cell. Common room for girls exists. The college uses LED's for energy savings. The no solar plant is installed to promote non-conventional use of energy. Most of the students of the college use bicycles & public transport. Presently rainwater harvesting

system is not in existing in the Camus and need to be developed. Activities like Tree plantation and plant protection programs need to be promoted on large scale. The college should develop solid waste management system to dispose of the waste with help of Municipal body. The college has transparency in its financial, academic, administrative auxiliary functions by following the rules and norms of govt. , UGC and University. The college educates and uplifts the downtrodden students to bring them into the main stream of development and to inculcate ethics and values to retain a long-cherished legacy and heritage of the country. The college provides financial aid to several deserving students under several scholarship schemes. Best Practices in the college takes initiative to engage with and contribute to the local community for promotion ofeducation. The institutional distinctiveness is to attend social upliftment by empowering weaker sections through value-based education by providing liberal help to needy and deserving students. The College has established two study Centers such as IGNOU and VMOU.
