


BOARD OF TECHNICAL EDUCATION, RAJASTHAN, JODHPUR
RULES AND REGULATION (Revaluation)
FOR DIPLOMA COURSES IN ENGINEERING AND NON ENGINEERING
SEMESTER SCHEME 2020-21
FOR THE SESSION 2020-2021 AND ONWARDS

1. A student who wishes to apply for revaluation of his answer-book(s) must submit his application in the prescribed form together with the requisite fee to the Principal of the college, where student is studying, before expiry of 15 days excluding the date of the declaration of his examination result. Application not received in the prescribed form or by the due date or without the requisite fee shall be rejected. Incomplete application forms will be rejected.
Seperate Application should be submitted for each semester in which he/she is appearing as regular and/or Ex student in an examination.
2. The fee for revaluation will be Rs. 1000/- per paper.
3. The revaluation fee will not be refunded in any case.
4. Revaluation of answer books shall not be permitted in more than 25% of the theory papers in which a student appeared for each semester in which he/she is appearing as regular and/or Ex student in an examination, With minimum 1 and maximum 2 Answer Books .
5. Notwithstanding the aforesaid provisions, revaluation of answer-books shall not be permitted in respect of practical examination/ Internal Assessment /class tests /seminar/Summer Internship , and viva-voce .
6. Student has to submit his/her original marks sheet along with the application for revaluation, in absence of which his/her application shall stand rejected.
7. The Principals of the colleges are required to send all the applications positively on the next day of the last date so as to reach Joint Director (Confidential) Board of Technical Rajasthan, Jodhpur.
8. Forms sent directly by the students to the Board will not be considered in any case.

9. The marks awarded by the re-evaluator will be the final marks of the student whether the marks awarded by the revelator is more or less than marks awarded by the main examiner.
10. The answer-book(s) shall not be subject to any inspection or production before any external or internal authority except at the instance of Chairman.
11. A student who is declared eligible for taking examination of back paper(s) as a result of revaluation shall be permitted to appear at the next main examination related to his/her back papers or if the same is already over, at the time of next main examination related to his/her back papers. Such a student will also be eligible to appear at the next higher examination as an ex-student, if such facility exists for the examination concerned.
12. A student desirous to apply for re-evaluation may treat his result as "No Change" for purposes of submission of application forms for appearing at the ensuing examination within due date.
13. Students should presume their result as unchanged for all purposes until declaration of the result of revaluation of their scripts.
14. All court cases shall be subject to the jurisdiction of the Board at Jodhpur not at any other place.
