

NOTIFICATION

A question has arisen as to how the seniority of two officers (or more) in different subjects is to be determined in cases of appointments on the same date from out of different merit lists or appointments made on different dates from out of one and the same merit list recommended by the Rajasthan Public Service Commission.

After careful consideration in consultation with Department of Personnel, it is hereby clarified under rule 37 of R.E.S. (C.B.) Rules, 1971 that seniority of officers in the aforesaid case shall be determined under rule 30 of R.E.S. (C.B.) Rules, 1971, on the following principles:-

- i) Where date of order of appointment happens to be same for appointment of persons from different subject-lists recommended by the R.P.S.C.
-- Date of birth.

- ii) Where more than one person is appointed on the same date from different subject-lists.

----- Persons assigned first position in merit list prepared by the Public Service Commission in each subject shall be grouped together and assigned inter-se seniority with reference to their date of birth. Similarly persons assigned second position shall be grouped and assigned inter-se seniority with reference to date of birth and so on.

- iii) Where some person, occupying higher merit position in the selection list recommended by the Rajasthan Public Service Commission, is appointed later, on account of late clearance of his provisional selection, he shall be deemed to have been appointed on the day junior to him in the merit list, was appointed.

- iv) Where appointments are made on the same day from different subject lists as well as from reserve list, seniority shall be determined as indicated in (ii) above.

- v) Where appointments are made on the same date from two selection lists of the same subject:-

As in clause (ii) above.

- vi) Where appointments are made on the same date from two selection lists, for male and female, of the same subject as in Clause (ii) above.

- vii) In all other cases date of order of appointment irrespective of date of selection/recommendation by the Rajasthan Public Service Commission.

NOTICE

In compliance of the judgement dated 06.11.2012 passed by the Rajasthan Civil Service Appellate Tribunal, Jaipur in Appeal No. 1176/2011, the provisional seniority of lecturers appointed between the period 02.04.1994 to 01.04.2007 in various Govt. Colleges with the provision of Rule 33 of RES (Collegiate Branch) Rule 1986 and are working as such on 1.4.2017 after regular selection by Rajasthan Public Service Commission/Screening has been drawn up and is published as per appendix for general information.

The main principle for determining the seniority is date of order of substantive appointment and where two or more officers in different subjects were appointed on the same date out of different merit lists or appointments made on different dates out of one and the same merit list recommended by the Rajasthan Public Service Commission, the principles laid down vide Government Notification No. F.1(15)Edu/Gr. III/75 dated 24.10.75, have been taken into consideration for determining the seniority, and are reproduced below:-

- (1) Where date of order of appointment happens to be same for appointment of persons from different subject lists recommended by the R.P.S.C. - Date of Birth.
- (2) Where more than one person is appointed on the same date from different subject lists - Persons assigned first position in merit list prepared by the Public Service Commission in each subject shall be grouped together and assigned inter-se seniority with reference to their date of birth. Similarly persons assigned second position shall be grouped and assigned inter-se seniority with reference to date of birth and so on. To make it clear it has been marked with arrows.
- (3) Where some person, acquiring higher merit position in the selection list, recommended by the Rajasthan Public Service Commission, is appointed later, on account of late clearance of his provisional selection, he shall be deemed to have been appointed on the day, person junior to him in the merit list, was appointed.
- (4) Where appointments are made on the same day from different subject lists as well as from reserve list, seniority shall be determined as indicated in (2) above.
- (5) Where appointments are made on the same date from two selection lists of the same subject:-
As In Clause (2) Above :
- (6) Where appointments are made on the same date from separate selection lists, for male and female, of the same subject as in Clause (2) above.
- (7) In all other cases date of order of appointment irrespective of date of selection / recommendation by the Rajasthan Public Service Commission.

The Officers aggrieved as a result of the position assigned to them may submit their representations with documentary proof in support of their representation, within 30 days from the date of issue of this list to the undersigned through their respective Principals. No representation will be entertained after the stipulated period is over.

No representation against the principles on which seniority list has been drawn up will be entertained.
