1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Government College, Sujangarh was established in the year 1968 as two separate units with the title G.H.S. Arts and Commerce College and as Seth Moti Lal Bengani Science College, Ladnun. At the initial stage, arts and commerce classes were started with 66 students in Bhanwar Lal Kala Bal Mandir, Sujangarh. Later on, it was transferred in Raja ji ki kothi on 1.7.1969 On 28th January1974, the present building was constructed by Seth Gyaniram Harakchand Sarawagi trust and the college was shifted in it. With the herculean efforts of MLA Shri Phool Chand Jain and the honorable citizens of Sujangarh, then Chief Minister shri Mohan Lal Sukhadia laid foundation of the present building.

Similarly, the Science College started in Johri Higher Secondary School, Ladnun in the year 1968-69 and later on shifted in the building just opposite to the present Arts/Commerce College.

For almost one and a half decade, both Colleges were run separately and later on by the Government Notification, they were merged in a single College on 01/01/1982. Presently, Government College is a co-educational which is an integrated unit of both Colleges and called as "Sujla Mahavidhyalaya" by the local people.

Presently, UG courses are running in Science, Arts and Commerce and PG courses are running in Chemistry, Maths, Political Science, Hindi, ABST, EAFM and Buss. Management.

G.H.S. Government College, Sujangarh, has had a meteoric rise since its inception and has developed into a premier institution of education in west Rajasthan.

It is spread over 82 acres of land; boasts of a multi faculty co-educational post graduate studies in 07 subjects, It has 16 faculty members, 11 non-teaching staff members, and an enrolment of over 3125 regular students.

The college outreaches to the widest range of rural as well as urban youth.

The curriculum of the institution lays appropriate emphasis on curricular and co-curricular activities. It attempts to develop all-rounded personalities through teaching, well equipped library and laboratories, sports, NSS, NCC, Rover Scout, Women Cell, cultural, literary and academic activities.

Other than this the College is highly conscious towards environment and issues related to environment and environment awareness.

- Transfers by the State Government, leading to instability in academic environment.
- Some Posts of teaching and non-teaching staff lying vacant for a long time.
- Vacant posts of ministerial staff and supporting staff.
- Low employability due to non-availability of Professional programs.
- Low computer: student ratio.
- Limited industry participation through consultancy and projects in college.
- Inadequate documentation of post qualification employment status of students and insufficient student tracking system.
- Lacking adequate hostel facility.
- Lacking hostel facility for girls.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

- G.H.S. Government College offers a wide range of **Under Graduate and Post Graduate Programmes**. The College is affiliated to Maharaja Ganga Singh University, Bikaner, Rajasthan and implements the curriculum prepared by the University.
- The College has developed a structured and documented process to ensure effective curriculum through a well-planned documentation process.
- At the beginning of the academic session, a class-wise and teacher-wise time table is prepared. The **timetable** is displayed on general notice board and departmental notice boards and is circulated in students' groups, college website and social media platforms.
- The college adopts **Elective Course System** and displays its subject combinations on the website. The four core subjects offered during the first year of graduation are Hindi, English, Elementary Computer Application and Environmental Studies. The students pursuing graduation choose from a range of 5 subject combinations in Arts. The Master's programs also offer elective courses of contemporary significance. Presently, the college offers Under Graduation in 15 subjects, Post-Graduation in 07 subjects. The curriculum is updated periodically by the respective **Board of Studies** of the Maharaja Ganga Singh University, Bikaner.
- Postgraduate and Undergraduate programmes are offered under the **Annual Examination System. Feedback** is regularly collected from the stakeholders and action is taken accordingly by the respective committees.
- The college does not have diploma, certificate or choice based courses. All classes are taught according to the syllabus prescribed by university. Some teachers also resort to modern technology. Departmental seminars are also organized in all postgraduate departments at regular intervals. Monthly class tests are taken every month. Special attention is paid to the students with low marks.
- All the teachers of the college are selected by Rajasthan Public Service Commission. Most teachers hold PhD degrees. Due to the qualification of the teachers, the Rajasthan government has nominated several teachers as state representatives in different universities of the province and many teachers are also members of various committees. Many teachers are nominated as members in committees of private universities.

Teaching-learning and Evaluation

- G.H.S. Govt. College, has 3200 students studying in different streams. The admission is highly competitive and based on merit and reservation norms. Being one of the top ten colleges of Rajasthan, the college hosted average 100% students from shekhawati area. For every available seat, the college received around three times more application. The average percentage of seats filled against reserved categories during the report period is more than 100% because some students stands in general category as their percentage marks are more better than general category students.
- The institution has an online transparent procedure for admissions into different programmes. A duly

constituted **Admission Committee** ensures that the admission process strictly adheres to the statutory **reservation provisions**, Women candidates are given 3% bonus marks in admissions.

- The college is affiliated to MGSU, Bikaner, Rajasthan and the students are assessed during the **annual examination**. The **results** are displayed on the university website.
- The institution has qualified and committed teaching faculty members.
- It is equipped with the necessary and updated infrastructure in E-resources and **ICT** like Audio-Video tools, LCD projectors, Smart boards, Computers with LAN connections in every department.
- Students can approach the teachers for teaching-learning and counseling through mobile calling, whatsapp, face book messenger, YouTube and text messaging and various counseling cells and mentors.
- The institute adopts measures to support both advanced and slow learners, such as orientation programme, seminars, interaction with eminent personalities and remedial classes, e-classes and competitive coaching classes. Special evening camps were also conducted in one course (spoken English) without any fee from students.

The examination management system is well maintained. During the report period assessment is incorporated into the learning process to achieve the learning goals of the courses. Continuous internal evaluation is done periodically and transparency and fairness of evaluation system are ensured through committee. The college has an effective mechanism for Redressal of grievances. Examination results display exemplary performance of the students who largely occupy the top merit position in the M.G.S. University, Bikaner on honour board and in P.G. departments. Our alumni members represent benchmark and doing outstanding work both nationally and internationally.

Research, Innovations and Extension

- **IDEA- Inter Disciplinary Educational Association** conducts regular seminars on interdisciplinary themes and subjects touching diverse areas of higher education.
- **Innovation and Skill Development Committee** plans and conducts the activities in alliance with the IQAC, distributing the student-centered activities to several committees specialized in their respective tasks.
- Study material in the form of PDF notes and other material was shared with students through social media platforms like Whatsapp, face book, You tube channels etc as a medium of teaching during Covid-19 pandemic times.
- 31 books and chapters in edited books were published by the faculty. Over 65 articles were published in UGC, listed, refereed and peer reviewed journals.
- The faculty members attended workshops, trainings, induction programs.
- The institution has one NCC unit and two NSS units that conduct several extension activities and community services.
- The students earned laurels by winning over 24 awards in national and state level games apart from an active participation in Inter-College and Inter-University Tournaments.
- Two NCC cadets took part in the prestigious Republic Day Parade.
- The State level Inter-College Debate and Inter-Faculty Literary and Cultural event- **Sujla Sargam** is held every year providing platform and attracting students from the entire state.
- Diverse activities are organized in Women Cell, Planning Forum, YDC, Literary and Cultural and other cells.
- Three Books edited by faculty members are in the syllabus of RBSE, Ajmer.
- College faculty member Dr. Gajadan Charan received financial assistance of Rs.21500/-.

Infrastructure and Learning Resources

- The institution has been keeping pace with the changing needs and the environment to meet the required infrastructural facilities. The total area of the campus is 331842.23 sq.m with a built-up area of 20234 sq.m. It has seven buildings administrative block, science block, library block, commerce block, arts block. There are 30 traditional classrooms, 5 Practical Laboratories, 01 Smart Classrooms with Interactive Board. Each department individually is equipped with at least one computer and internet facility.
- It has 07 departmental staff rooms and one common staff room, one seminar hall, one room each for NSS, NCC, Student Union, Sports, Girls Common room. Chamber of Principal and Vice-Principal and Accounts section. The college campus has one parking stand for two wheeler as well as four wheeler vehicles. Solar System is also working in both the building to save electricity.
- The College has adequate facilities for indoor games and outdoor games. There are Volley Ball, Basket Ball, Kho-Kho, Kabaddi, Shuttle Badminton courts, Cricket ground and One gym.
- The main library has 51346 books, many magazines and newspapers.
- The campus is pollution free, smoke free and environment friendly. It has a number of Trees of Pipal, Nim, Bad, Ashok, Gulmohar, kaner, etc with benches and seats for students.
- The Plantations Warrior of College works to make Campus green and clean.

Student Support and Progression

- The institution is linked up with the web portal of Commissionerate of College Education, Rajasthan which provides **on-line admission facilities** with admission policy and prospectus including welfare schemes, reservation policy etc.
- Scholarship in all categories of talented, disadvantaged and minority is provided through various schemes run by the state / central governments. It is estimated that more than 11,000 students have taken advantage of these schemes in the last five years. More than 500 students have availed free coaching for various competitive examinations through the Direction and Competition Efficiency Program. Similarly, students are also getting the benefit of various professional program (spoken english). Sports and cultural events are held in the college throughout the year. More than 10 youth have won medals / places in various sports at All India level.
- Fee charged by the institution is less than that of other institutions. 3166 students, that included SC, ST, OBC, General and minority students were benefitted from scholarships that included CM scholarship,

Social Welfare scholarship and NPS.

- Girls Mentoring Cell, Internal Complaints Committee and Grievance Redressal Cell, Sexual harassment Committee and Anti-Ragging Committees look after the grievances and resolve them in the minimum time.
- **Student Progression** 5% UG students opted for higher education and took admissions into PG Courses in our college in the last five years.
- **The Student Council** plays an important role in contributing to the growth and progress of the institution. The office holders take an active part in all the main functions and activities of the college. The Council shares equal responsibility in hoisting the grand event of Sujla Sargam cultural and literary competitions held in the college each year.
- **The Alumni Association** of the college is a registered body (S.NO. COOP2022/CHURU/200930 dated 8-8-22.

Governance, Leadership and Management

- The leadership and governance of the college is well reflected in its vision and mission. The College works under the Commissionerate of College Education Rajasthan, Jaipur headed by the Commissioner. More than 40 committees are framed at the beginning of every academic session. *Mahavidlaya Vikas Samiti* (College Development Committee) works as the liaison between society and the institution.
- Access, equity, inclusive education, regional development through better teaching learning and low fee structure are ensured at all times. The perspective plan is prepared by IQAC.
- With a vision to create a center of academic excellence imparting multi-faculty education of highest quality and standards our institute is working tirelessly for improving scenario of higher education in arid region of western Rajasthan.
- One such **strategic plan** and its implementation is well reflected in the construction of Three classrooms, Two Library halls, Two Labs, One Porch and renovation of Basket Ball Ground. PG departments, laboratories and purchase of books and equipment through the grant of Rs. 2 crore under **the RUSA Scheme**.
- The college implements all the **welfare schemes** of the State Government and also tries to facilitate the same through various effective welfare measures to empower its faculty.
- The performance of every employee, teaching and non-teaching, is **appraised** by the Principal and reviewed by the competent authority on an annual basis.

With the widespread covid pandemic in 2019 and 2020, the teaching-learning process went on ceaseless and smooth. As many as 1290 video lectures and over 1227 PDF files were prepared by the faculty and shared among whatsapp groups of the students and other social network sites. All these videos and PDF notes are available on the **Rajiv Gandhi E-Content Bank** for public viewing and benefit of students throughout Rajasthan. among students. Several activities were proposed and effectuated by IQAC.

Institutional Values and Best Practices

• The college takes continuous efforts towards gender equity and women's empowerment. Institute provides CCTV camera, girls common room and other facilities for girls. To provide safe and secure environment in campus, the college has formed various committees' like-Discipline and Anti-Ragging Committee and Committee for redressal of complaints of sexual harassment. The girls are enrolled in

NSS and NCC units and actively participate in sports. Women cell, platform for female students is made to express themselves freely and fearlessly on different issues related to women. College organizes many 'days of celebrations' to develop and enhance moral values among the students and faculty members.

- The college is aware about environmental issues. The institute has Water conservation system, Green campus initiatives, Tobacco and Plastic free campus for betterment of students. The college is concern about Divyangjan and provides facilities as possible.
- NSS volunteers and NCC cadets of the college actively contribute in tree plantation, cleanliness drive and other such activities. NSS volunteers of the college have adopted nearby village 'Asota' and 'Khanpur'. Various activities are organized here for environment protection.
- The college provides facilities for drinking water, girls common room, toilets, library, reading room, gymnasium etc. for all the students irrespective of cast, community, religion and language. All the students actively and enthusiastically participate in Literary, cultural and sports activities to increase tolerance and harmony. Women cell organizes many programmes of skill development for female students to encourage them.
- All Rajasthan Hindi Debate Competition and Girls Education and Skill Development are the two best practices of the college.
- The most distinctive area of the institute is its focus on education of youth of rural areas and to develop their skills. For this purpose various co- curricular activities are conducted. Many sports activities organized in the institute are evident of the fact that the students frequently participate in district and state level competition & win awards too. Along with this, for the skill development of the female students of the institute, 'Literary and Cultural Committee' and 'Mahila Prakoshth' organized various program such as Mehandi, Rangoli, Poster, Essay, art & craft and speech competition etc.

We try to enable our students to acquire desired competency levels and acquire additional skills to further upgrade their competencies through IDEA lectures (Inter- Disciplinary Educational Association), Weekly Webinars, Free coaching ANANDAM (projects in the areas of community engagement and services, Environmental Education (compulsory paper for all students), Community Connect Program etc.

Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

Holistic development is the motto of the institution and this is made possible through an atmosphere of support and students-teacher interaction. Adequate efforts are made towards the active involvement of students in the whole process of teaching and learning. Student-centric education is the most distinctive feature of the college. Other than traditional classroom teaching, the teaching-learning process in the college strongly focuses on enhancing skills, experience and knowledge. Experiential learning, participative learning, and problem-solving methodologies implemented inside and outside the classrooms include:

It is mandatory for students seeking admission at the first-year level to opt for any of the extra- curricular activities offered by the college. **Co-curricular activities** are undertaken with an aim to move beyond the realm of formal learning and foster creative and critical thinking. Activities like debates, quiz, poetry recitation, essay writing, declamations, class seminars etc give them the opportunity and confidence to display their latent creativity and energies.

Extra-curricular activities like, drama, rangoli, mehndi, poster making, song, and dance competitions are organized by various committees. Other platforms that focus on participative learning Youth Development Centre.

Experiential social responsibility plan was followed in **Aanandam project** in which the students took a first- hand experience of serving in society and putting their plans, proposals and learning experience in the form of a group project file. Several social themes like care and preservation of plantation, feeding birds and animals etc were covered in these projects. The students went out in groups, served the society in small and different ways, maintained diaries of doing tiny acts of kindness every day and felt elated in preparing project files on the same experience under the supervision of their mentors. This project brought them immense joy of active participation and giving their small contribution to society.

Our best practice- The main objective of higher education is to build better intellectual citizens who may have thoughtfulness, deep regard for democratic values, have skills of leadership and who may be curious to strike the path of innovation for acquiring more and more knowledge and have the capability to distinguish truth.

With these objectives, a number of educational institutes keep on organizing co-curricular activities besides the teaching practices. 2.5 Evaluation Process and Reforms

2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

The college is affiliated to Maharaja Ganga Singh University, Bikaner and it follows an annual examination scheme as per the University calendar. The senior faculty members of the institution take charge of the three shifts in which the Annual University examinations are conducted. They are assisted by the ministerial staff in the academic section.

The students' grievances at college level, are also dealt promptly by the Examination Committee.

In the case of University Annual Examinations, the time table is displayed on the university website.

Admit cards are generated online.

The **examination process** is looked after by Centre Superintendent and Assistant Superintendents. The answer sheets are distributed room wise along with question papers and attendance sheets to the invigilators.

After examination, the answer sheets are collected by the invigilators and submitted to the Examination Committee for further process.

The invigilation duties and **attendance sheets** are generated online. The payment for invigilation duties is done online.

The question papers are kept in safe custody in the strong room. The answer books are coded.

The answer books are evaluated fairly in time and results are declared and displayed on the University website.

Any representation regarding question paper, examination related issues and evaluation is forwarded to the University. The students give in writing whatever problems they face concerning the question paper and the same is sent/ emailed immediately to the concerned authorities in the exam cell of the affiliating University.

During the exams, unfair means case (UM) and grievance related to question paper are forwarded to the university immediately for necessary action. The examination procedure is completely transparent.

Students have an option of **re-evaluation** if they are not satisfied with the marks awarded in university examination.

Unsuccessful students in the final year of UG/PG degree courses are given a chance to appear in **Supplementary Examination** which are generally held in September-October in the same year. In addition, Students are, also, given a chance to improve their marks in 50% papers of previous year examination if they want to.

Rajiv Gandhi Student Service Centre assists and counsels the students concerning examination related and other issues.

The Course Outcomes (CO) are prefaced to each paper in syllabus and

shared with students and faculty. In general, the Course Outcomes of different programmes are intended to make the students capable enough for progression into higher degree programmes, research programmes, employment in private/public sector, self-entrepreneurship, and to have readiness for competitive examinations. The specific learning outcomes of various courses are built into the curriculum of each discipline and are available on the institutional website.

The college has 15 departments in all, 7 in Arts, 5 in science and 03 in commerce. The Under Graduate programmes are B. A, B.SC, B.COM, and Post Graduate programmes are M.A., M.COM and M.SC. The college is affiliated to Maharaja Ganga Singh University, Bikaner and it follows the curriculum prepared by it. The faculty members contribute in the capacity of members and conveners of Board of Studies for curriculum enrichment.

Course Outcomes of the programmes help the students update their knowledge about the concerned field and connect this the oretical epistemology to the scope of higher education and employability. The courses aim at honing the IQ, analytical aptitude, research analysis, market analysis, skill development and linguistic skills of the students.

Communication of PO/CO to students: The learning outcomes of final year UG and PG programmes are displayed on the college website. There is a help desk in the college where faculty members of all streams are available even during the summer vacations. The students seeking admission in the first year seek advice from teachers and discuss the CO/PO and POs. This helps them in selecting electives and extension activities offered by the institute. The admission committees of the respective programmes also educate the students regarding the programme outcomes and course outcomes to facilitate the right selection of courses to the students.

Communication of PO/CO to faculty: The faculty members discuss the programme outcomes in their respective departments. The department-wise time table is discussed and the teaching plan is prepared keeping in mind the results of the specific programmes. The outcomes for all courses, programmes and elective papers help the teachers to evaluate the objectives of the subject content. This evaluation also helps the teachers to identify the learning capacities of the students and take corrective measures accordingly. The mentors help the average achievers to attain better outcomes and motivate the advanced learners to aim for bigger goals. The students have shown brilliant performance in the University exams and the overall result percentage is above 90%.

Response:

The teachers and students of this college have a healthy tradition of taking initiative for research-survey, innovation-profession, development of quality education, and excellence in education. Although many challenges have to be faced due to being established in a remote rural area, the faculty members and students here have joined this eco-system by engaging in innovative research, survey, creation, editing, translation, and literary and competitive activities organized by excellent institutions. Attempts have been made to enrich the system. The faculty members here have taken part in online and offline seminars as subject experts and participants, as well as taking innovative initiatives by doing research-article writing, research paper presentation, and book and column writing. It is noteworthy that books written and edited by three faculty members were accepted as textbooks in the courses of the Rajasthan Board of Secondary Education, then one faculty member received financial assistance under two literary projects of Central Hindi Directorate and Sahitya Akademi, New Delhi and completed relative work, which is published as two separate books. The faculty members here have enhanced their abilities by participating in programs

like Gyan Ganga and Gyansudha, associated with excellence in teaching and learning in various disciplines run by the state government.

In order to ensure multi-disciplinary qualitative growth amongst the faculty members working in the college, a committee named 'Inter-Disciplinary Educational Association (IDEA)' has been constituted to take up innovative initiatives focused on inter-faculty discourse, and encourage interdisciplinary teaching and research by organizing talks, seminars, and discussions. It establishes interactive discourse sessions and classroom interactions between faculty members and students to exchange innovative ideas and research work.

The sports persons here have been selected every year in various sports at the college and university level and have been selected for state and national level competitions, while the NCC cadets here have participated in the Republic Day Parade, New Delhi. There has been commendable participation of the students here in various activities related to skill development, language proficiency, social harmony, national integration, public awareness, cleanliness, environmental protection, and intellectual and skill development. The students here play an active role in voter awareness, drug de-addiction, covidmanagement, and all other programs of national importance.

Here special lectures by subject experts are organized to promote entrepreneurship development and entrepreneurial spirit among the students, while entrepreneurship and employment fairs have also been organized. During the session 2020-21 under the ANANDAM curriculum, more than 900 students completed project work in various important topics under the guidance of their respective mentors, which is a commendable step for the development of research fellowship among the students. 3.4 Extension Activities

3.4.1

Outcomes of Extension activities in the neighborhood community in terms of impact and sensitizing the students to social issues for their holistic development during the last five years.

Response:

The college makes continuous efforts to promote a community network between the college and the community through various extension programs. Since the extension activities were stopped due to Covid-19 so many activities could not be organized, then some of the selected activities which were completed are as follows-

Intensive Tree Plantation Program:- This college with rural background has a huge plot of 82 acr, in which every year during the rainy season, efforts are made to realize the dream of a green campus. In the last five years, more than 1000 saplings have been planted on different occasions. A barbed wire mesh has been installed to protect the plants. Keeping in mind the plan of more irrigation with less water, a drip system has been installed for these plants. The students and officers and staff of the college do the work of maintenance of these plants voluntarily and continuously.

Cleanliness Campaign:- During the Swachh Bharat Abhiyan, programs like, rallies, lectures, oathtaking, etc. were organized on the college premises. NSS volunteers in their adopted villages and slums and students of the Anandam Project is other public use places carry out cleanliness campaigns and spread awareness. For this, students are motivated to participate in cleanliness campaigns through extracurricular activities like poster-making and slogan writing.

Blood Donation Camp:- Blood donation is an important activity in the college. In the last five years, the

students, faculty members, and staff here have volunteered to organize blood donation camps in association with blood banks of the local civil hospital and some non-government organizations and also in camps organized at other places. To motivate the students and parents for this noble cause, extension lectures, debate competitions and rallies on blood donation have also been organized.

Organizing intellectual and skill development competitions:- Many competitions are organized by various enterprises of the college for the intellectual ability and skill development of the students, including Mehndi, Rangoli, Salad decoration, Graffiti, Painting, Essay, Speech, Debate, Poster- Creation, Poetry, Dance, Singing, Slogan, etc. are remarkable. For the last four decades, the 'Seth Kundanmal Sethia State Level Hindi Debate Competition' is organized every year by the college with the courtesy of the local Bhamashah, in which selected participants from higher educational institutions of the entire state participate.

Organizing Yoga and Sports Activities:- Sports exercises and competitions are organized regularly in this college. Sports grounds for more than 7 different sports, trained and skilled sports officials, availability of sports equipment, and gymnasium and Badminton court are the center of attraction for young players. Along with sports, yoga exercises and yoga camps are organized here.

National and social issues:- The college organizes necessary activities based on various issues related to social concern and upgradation, such as national integration, social harmony, girl child education, women empowerment, clean India, literacy, road safety gender sensitivity, blood donation, polio vaccination, voter awareness, environment protection, covid-19 advisory, drug prevention, etc. Various rallies, slogans, and programs like 'Run for Unity' related to social issues are organized.

6.1.1

The College has a defined organizational structure for effective decision making and execution of responsibilities to meet its goals and mission.

Vision

In the present scenario of globalization and a competitive market, our students have to undergo strenuous ordeals to reach out to their dreams. It is here that we prepare them for the competitive world ahead, with their cultural and social values preserved within them.

Mission

Youth education and empowerment

The institution looks upon its students as living souls rather than as materials for manipulative fabrication. A substantive part of the enrolment comes from semi-urban and rural locales of the district. They undergo a dynamic and humanizing process of education before stepping into the competitive word. The institution encourages dialogic relations between teachers and pupils, taking into consideration their past limitations yet immense intellectual resources. He decentralizes duties, the senior faculty members are given charges of Establishment section, Accounts section and Academic section to shoulder various administrative responsibilities. The Incharges of various departments act so by virtue of their seniority and are responsible for the functional activities of the Departments. Regular meetings of the college development committee and stakeholders play a significant role in overall governance viz. planning, deployment, monitoring and execution of agendas pertaining to development, teaching, social responsibilities, and innovative practices.

Perspective plans:

The administrative strategies are planned and executed both at the Commissionerate and at the institutional level. Feedback is taken from students, teachers, alumni and parents. Action is taken on the feedback regarding teaching, institutional social responsibilities, augmentation of facilities and other areas within the purview of the principal. Matters and requirements related to finance are forwarded to the Commissionerate for further action.

Participation of the teachers in the decision making bodies of the institution:

The constitution of committees for specific purposes clearly reflect effective governance. More than 50 committees are framed at the beginning of every academic session. The Staff Council and respective committee meetings are called periodically for efficient implementation of agendas related to teaching, curriculum, admission, examinations, students' union elections, activities and any other significant matter related to the development of the institution.

6.2.1

Response:

The Organgram on the college website elucidates the administrative setup. The key aspects of the organizational structure of the college are as follows:

Administrative set up and function of various bodies:

The College works under the Commissionerate of College Education, Rajasthan headed by the Commissioner. The Principal is the head of the institution and all the faculty members, the ministerial staff and other staff works under the guidance of principal. Many committees formed at the beginning of the session. The senior members of the faculty are given charges of the Establishment section, Accounts section, Academic section. The staff members include teaching staff, office support staff, Librarian, Laboratory Assistants etc. As the PTI is presently Working he looks after all the sports activities. AAO

deals with the financial matters. Besides, staff is recruited on contractual basis via College Development Committee like the Safai Karamcharis, office typists etc. The teaching staff is assigned various responsibilities as conveners and members of committees. The Administrative structure of *Vikas Samiti* comprises of Principal as the Chairperson and senior faculty members as Secretary and Treasurer. Member of Parliament, local MLA, representative of the district collector (SDM), two prominent educationists, a student representative nominated by the Principal and two parents are among the members. The function of the committee is to provide and maintain basic infrastructure.

Service rules:

The College is a Government institute and therefore it is mandatory to follow the rules, regulations, policies framed by the State Government (RSR). Nevertheless, whatever best can be implemented at its level is always carried out by the college to achieve the ascertained goals.

Recruitment:

The teaching staff is recruited by Rajasthan Public Service Commission. The Class IV employees are recruited by the State government and contractual workers are appointed through the Employment Agency. In addition, there is a provision of Compensatory appointment in place of the demise of a close relative, based on the Govt. policy.

Promotional policies:

The regular promotions of teaching faculty are done after the calculation and validation of the API score and recommendation of the Commissionerate based on the UGC guidelines to the RPSC.

Grievance redressal:

The college has framed Internal complaints, Girls Mentoring and Grievance Redressal Committee and an Anti-Ragging cell to look into complaints and solve such issues. The complaints are received by any of these three committees based on the nature of the complaint and action is taken after due consultation with the Principal. Besides, for grievance redressal related to G.H.S. Government PG College, the Employee ID of the Principal of the college is mapped by the *Rajasthan Sampark Department*. Anyone having a grievance against the college can file a complaint from anywhere in India. The complaint is forwarded to the college through the central office. Besides, a committee called Legal Cell is also constituted to look into court cases. The students can directly approach the Principal with their doubts and grievances. The matter is discussed with the related Committee and action is taken accordingly.

6.3 Faculty Empowerment Strategies

6.3.1

The institution has performance appraisal system, effective welfare measures for teaching and non-teaching staff and avenues for career development/progression

Response:

The college implements all the welfare schemes of the State Government and also tries to facilitate the same through various effective welfare measures. **GPF/NPS and SI** are compulsory deductions for future security. In addition, annual '**Group Insurance**' is also deducted. **Medical claims** are reimbursed by the State Government as part of the health expense incurred by the employee. **The superannuated employees of the College are benefitted from the Rajasthan Pensioner's Medical Fund, besides being given Gratuity and Pension.** As an affiliated College, the University deducts 6% of the amount in the form of '**Teacher's Welfare Fund**' from the remuneration of the teachers which they earn during the evaluation process, which is provided to the family of the needy faculty member, based on the policy of the fund. Provident Fund is also deducted, which is also associated with long term future benefits of the employee.

Some of the other benefits include:

Leave for teaching staff:

15 P.L. - privilege leave earned after completion of calendar year

20 HPL- half pay leave after completion of the year can be commuted on medical.

Leave for non-teaching staff:

15 PL- advance credited two times in a year HPL same as teaching staff

15 CL- in a calendar year

Leave for female staff:

Maternity leave, two times in service period for 180 days

Child care leave, 730 days in whole service period

Leave for male staff: Paternity leave of 15 days, two times in the whole service period

Staff Club has been formed with a Secretary appointed from amongst the faculty members, who looks after the functions, valedictory and retirement ceremonies of the staff. The staff contribute money for these ceremonies and also for the gifts for the weddings of the children of the faculty members.

6.4 Financial Management and Resource Mobilization

6.4.1

Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

Response:

The funds are utilized as per GF & AR of the State. The principal is the DDO and looks after the financial matters including the salary of the college employees. The AAO maintains proper ledger with details of the financial support received and utilized under different heads from various agencies. The funds are received under the following schemes/heads:

State Government allocates a specific amount to Govt. Colleges for overall development and maintenance. The committee constituted for college developmental purpose puts forth the demand and requirements before the Principal. The state budget and grants are released for salary, TA, medical, office work, construction and maintenance, lab grant, books and journals, etc. This is disbursed as per allocated heads. The proposals for requirements related to maintenance are also submitted to CCE and College Development Committee.

State Government Scholarships: Payment of fellowships and scholarships of UGC, ICSSR, and CSIR etc. is through PFMS. The payment of various Scholarships is online and executed through the SSO module.

UGC has been providing assistance till 2017 under the XII Plan Period. These funds were disbursed by the planning board of the college for various purposes viz instrumentation maintenance facility, competence building initiatives in college, educational innovations, extension activities like career and counseling, minor research projects, TRF. The UC was submitted timely to the office of the UGC.

RUSA: Funds amounting to Rs 2 crore were allocated to the college under three major heads-new construction, renovation and equipment. The fund was judiciously utilized and UC has been submitted. Governing and Monitoring bodies- Board of Governors (BOG) and Project Monitoring Unit (PMU) monitor the progress of projects initiated by RUSA.

Vikas Samiti: Requirements and urgent needs other than these are fulfilled by funds generated through Vikas Samiti (College Development Committee).

6.5.1

Response:

The College is member of Divisional Level Quality Assurance Cell (DLQAC) of Bikaner Division of Rajasthan and SLQAC, state level coordinated at Jaipur. Principal and Coordinator, IQAC attend regular meetings conducted by the Convener, DLQAC as well as SLQAC. The IQAC also conducts the screening of the CAS applications of these colleges.

The contribution of IQAC in implementing and driving resourcefulness to the growth and development of the college is conspicuous. Out of the many initiatives, the two major contributions of IQAC in institutionalizing the quality assurance strategies are:

1. Teaching-Learning: The exigent task of catering to the diverse needs of students coming from diverse groups and rural background is well managed and manifested in the college and learning outcomes. The strategies proposed and executed during the last five years with reference to teaching-learning include:

Effective and optimum use of ICT tools for teaching despite the limited availability of resources. Innovative and demonstrative pedagogies: the degree of student engagement, clarity of objectives, identification of aptitudes and fostering confidence.

Teaching through Online tools and Resources: With the widespread covid pandemic in 2019- 2020, the teaching–learning process went on ceaseless and smooth. There was no break in curriculum coverage of the students. YouTube channel of the college were created to facilitate the dissemination of information to the students as widely as possible. To speed up the process, individual YouTube channels were created by all teachers to continue teaching through video lectures trying to reach out to a wider audience and a majority of students. Over 1290 video lectures and more than 1227 PDF files were prepared by faculty and shared among whatsapp groups and other social network sites. Weekly assignments were given to provide an idea of the examination pattern.

1. Research:

IQAC encouraged research related to issues of contemporary relevance as well as global significance. The following activities were proposed and effectuated by IQAC:

IDEA lectures on multidisciplinary themes like Inter-Disciplinary Perspectives of Higher Education, Importance of Education Day, GST, Science and Today, Indian Economy, Health Benefits of Yoga etc.

Best practice 1

1. Title of the Practice

Girls education and skill development programmes

2. Objectives

Our college strives to promote girls education and their skill development. Through higher education girls will certainly get gender equality in the society, they will be able to earn and will raise their socioeconomic condition. When women are educated, they will be able to live the life full of dignity.

3. The context

To develop a country socially and economically strong, girl's education is very necessary. Girl's education helps in breaking orthodox thinking of rural people, in eliminating illiteracy rate and developing self-esteem and self-confidence of half of the population. Some of the main challenges for girl's education are poverty, lack of means of transportation, social customs, budget deficiency for skill development, gender discrimination, lack of security, lack of infrastructure etc.

4. The Practice

If a woman is educated, she uses education for the benefit of society and family. Due to an educated woman, the economic condition and domestic production of the country increases. For the education of girl students, all the three streams of arts, commerce and science are running at the graduate and post graduate levels in the college. Along with academics, co-educational activities are organized through NSS, NCC, Literary Cultural Committee and Women's Cell etc. A library equipped with more than 50,000 books is available for the intellectual development of the girl students. Various sports activities are also organized for the girls students by the sports department. Girls have participated in sports competitions at the divisional level. In 2019-20, state government launched MMYKY. Under this plan, English spoken and communication skill development programmes were conducted. Since our available resources are limited we cannot conduct this type of program consistently, but the institute ensures organizing the other possible activities like Art and Craft Workshop, Mehandi, Rangoli, Wall painting, Salad decoration competitions etc. under the platforms of Women Cell.

5. Evidence of success:

Government College, Sujangarh is located in rural zone. Due to the safe and well equipped college Campus and excellent education results, the percentage of girl students has increased in last 10 years. After getting educated from here, girls have made their mark in various fields like banking, school and College education, C.A. etc. Along with this, due to participation in various activities of skill up gradation, skills have developed in girl students, their confidence has increased. Due to continuous participation in sports activities, girls have also become better and aware in terms of physical health.

6. Problems encountered and Resources Required

Education and skill development is the key to women empowerment. The main problems faced by most of girls are that they belong to interior rural areas, not having enough transport facilities and they are also from poor background families which can't afford daily fare charges of buses. Lack of social consciousness in rural areas for girl education, Infrastructure, budget and trainer for skill development programmes etc. are the main problems for implementing the practice.

Best practice -2

1. Title of the practice

Seth Kundanmal Sethia Smriti State Level Inter-colleges Hindi Debate Competition

2. Objectives of the Practice

The main objective of higher education is to build better intellectual and responsible citizens. This institution organizes one such activity and that is a literary activity 'State Level Inter-colleges Debate Competition' which focuses on developing and enhancing oratory as well as debating skill among the students.

3. The Context

In debate competition, the participants of two conflicting views put forward their arguments and refute each other's views. Such type of activities not only enhances the critical thinking of the participants but also provides a chance to the audience to understand the importance of listening with the touch of respecting different point of views. The challenges that the institute face in organizing such activities are limited sources and geographical location of the institute.

4. The Practice

Generally debate competition is helpful in improving the tempo and level of understanding of the students. It enhances subject related thoughts, analytical power and evidence based reasoning etc. Such practices enhance and promote quality education. It is also observed that students actively participating in such activities have made identity at higher level too by working with self-confidence and exhibiting better leadership skill in whatever fields they have entered. In the context, if we look at the objective of higher education, then it is to help building such a personality that is psychologically enlightened. Students very actively and enthusiastically participate in the programme as speakers/debaters as well as listeners. Topic of the debate is selected from the current social and political events with the aim to make the students acquainted with the activities and events taking place around them and create awareness about the social, political and cultural activities of India and the world. Students develop mutual cooperative skills and endurance through such activities besides getting acquainted with the nationally and internationally significant issues.

5. Evidence of success-

The institute has been organizing this State Level Debate Competition in the memory of Seth Kundan Mal Sethia for last four decades. Those students, who have participated in such activities, are working successfully in various fields. A prominent and well known name among them is Dr. Ajay Choudhary, working as deputy director, Medical and Health services, Jaipur. At present he is successfully working as President of All Rajasthan in Service Doctors Association (ARISDA). In this sequence, Mr. Abhishek Charan who has been a participant in our debate, today he is an assistant Professor in JVB Deemed University, Ladnun, Rajasthan.

6. Problems Encountered and Resources Required

The major problem that the institute faces is the sudden unfavorable weather condition during the co curricular programmes as there is no auditorium. Large scale activities are to be organized under tents.

Hence the most essential requirement for this institution is a large auditorium with excellent sound system. They lag behind the student of other big cities when they face interviews, group discussion and other presentations.

- Specified by the Commissionerate college education, Rajasthan and art, literature, cultural, archaeological department, Rajasthan, college organized Drawing, Slogan and Essay writing competitions regarding covid awareness.
