Sub.: Regrading submission of Dissertation of LL.M. Pt II (Two Year Programme) of Session 2023-24.
Ref.: Guidelines relating to conduct and evaluation of examinations for LL.M. Degree Two Years Degree programme of affiliated colleges for the session 2023-24.

Dear Sir/Madam,

In reference to subject cited and above referred guidelines issued for conduct and evaluation of examinations for LL.M. Two Year Degree Programme, kindly find below the abstract of guidelines relating to Dissertation.

01. "PAPER 5 (COMMON FOR ALL BRANCHES) DISSERTATION: Four Copies of Dissertation shall be submitted by the candidate to his/her institution. One for Supervisor and rest three for external evaluation. It shall be the candidate's original work carried out under the guidance or supervision of a person who is recognized by the University to supervise research. **The Dissertation shall be submitted so as to reach the Registrar, ALU at least 30 clear days before the commencement of the LL.M. Part-II Examination."**

02. GUIDELINES RELATING TO DISSERTATION:

- All the titles of the individual chapters shall establish a link with the main title of the research work.
- All chapters shall have an "introduction" and a "conclusion" describing the work to be done by the candidate in that very chapter.
- Before closing of the individual chapter summarize the chapter in few lines giving a hint as to what will be researched by the candidate in the coming chapter.
- Similarly in the next chapter candidate shall mention as to what he/she did in the last chapter and what is to be proposed and attempted in this chapter.
- The page numbers in this second document (associated pages) shall be in roman numbers and when the candidate starts writing the third document i.e. The dissertation starting from chapter one the page numbers shall start with 01, 02 and so on.
- The dissertation should be around 120-130 pages in total shall be hard bound and top cover page shall be black with silver embossing of letters.
- The entire proposed research work should be in double spacing, times new roman 12 format justified with page borders and footer as shown in this document.

Keeping in view of the future of the students, the last date for submission of Dissertation at University Office is hereby extended and decided as 31.07.2024. Principal of the concerned colleges are requested to ensure the extended deadline and must deliver the hard copies of the Dissertations which were prepared in prescribed proformas and submitted at the college, latest by 31.07.2024 either through messenger or through post.

It is also hereby mentioned that the colleges should collect 4 copies of Dissertations from each student and retain 2 copies at the college itself (one for supervisor and another one for viva-voce of external examination) and send 2 copies of the Dissertations to the University office for evaluation purpose latest by 31.07.2024 and on cover page and one first inner page of each Dissertation should compulsorily have Title of Work, Collage Name, University Name, Student Name, Roll No., Class with year, Enrollment No., Supervisor Name and Designation. Certificate of College Supervisor must be enclosed inside the Dissertation.
