The MY Bharat Portal also offers distinct advantages for institutions. It provides a unique opportunity to register as a **Knowledge Institution** and gain access to a dedicated web page. This partnership will expand your institution's visibility across India and help build a strong network with both current and former students. By showcasing your institution's activities on the portal, you can engage more youth and attract them for enrollment and other opportunities.

One of its immediate opportunities on the portal is regarding the **Viksit Bharat Young Leaders Dialogue**, i.e., the reimagined National Youth Festival, 2025. A significant highlight of the festival is the **Viksit Bharat Challenge**, comprising a quiz, an essay writing segment and development of a vision deck. Youth selected through this multi-tiered challenge will get an unprecedented opportunity to present their vision of Viksit Bharat directly to the Hon'ble Prime Minister during the two day national level dialogue to be held in New Delhi on 11<sup>th</sup> and 12<sup>th</sup> Jan 2025.
