Guidelines relating to conduct and evaluation of examination for P.G. Diploma Courses (One Year Diploma Programme) for affiliated colleges for the session 2023-24 available at ALU website.

Dear Sir/Madam,

From the Academic Session 2023-24, the University has added Dissertation as a compulsory VI Paper in all P.G. Diploma Courses (One Year Diploma Programme) for affiliated colleges. Necessary guidelines were issued for conduct and evaluation of examination for P.G. Diploma Courses (One Year Diploma Programme). Kindly find below the abstract of guidelines relating to Dissertation.

The dissertation should be minimum of 100 (one hundred) pages in total, shall be hard bound and top cover page shall be DARK NAVY BLUE with SILVER embossing of letters.

The Viva-Voce for the Dissertation shall be conducted by One Internal and One External Examiner.

For the Viva-Voce, the candidate shall prepare a 10-15 Minutes PPT or Oral Presentation of the research work in consultation with his/her supervisor which he/she shall be required to present before the External Examiner on a date fixed by the University in each Academic Session as per

To pass this paper, it is mandatory for the candidate to appear in the Viva-Voce personally, in the same academic session, on the date notified by the University,

No Grace Marks shall be awarded for Viva-Voce Examination.

Four (04) Copies of Dissertation shall be submitted by the candidate to the University on or before the last date mentioned in the notice issued by the University [Three for External Examiners and One for Supervisor].

There shall be no revaluation of the dissertation.

EACH SUPERVISOR SHALL ENSURE THAT THE DISSERTATION SUBMITTED BY THE CANDIDATE QUALIFIES THE RESEARCH ETHICS.

In view of guidelines as mentioned above, it is further notified that the submitted dissertation must be candidate's original work under the guidance or supervision of a faculty who is recognized by the University to supervise research.

The Dissertation shall be submitted by the candidate to his/her concerned college timely so as to reach it at the Office of the Registrar, Dr. Bhimrao Ambedkar Law University, Jaipur at least 30 clear days before the commencement of the P.G. Diploma Examinations."

Keeping in view of the future of the students, the last date for submission of Dissertation at University Office is hereby extended and decided as 31.07,2024. Principal of the concerned colleges are requested to ensure the extended deadline and must deliver the hard copies of the Dissertations which were prepared in prescribed proformas and submitted at the college, latest by 31.07.2024 either through messenger or through post.

It is also hereby mentioned that the colleges should collect 4 copies of Dissertations from each student and retain 2 copies at the college itself (one for supervisor and another one for viva-voce of external examination) and send 2 copies of the Dissertations to the University office for evaluation purpose latest by 31.07.2024 and on cover page and one first inner page of each Dissertation should compulsorily have Title of Work, Collage Name, University Name, Student Name, Roll No., Class with year, Enrollment No., Supervisor Name and Designation. Certificate of College Supervisor must be enclosed inside the Dissertation.
