Rajasthan College Education Society (Raj-CES)

1. संस्था का नाम:— इस संस्था का नाम Rajasthan College Education Society (Raj-CES) है व रहेगा।

2 संस्था का पंजीकृत कार्यालय तथा कार्यक्षेत्र:— The Registered head office of the society shall be at the Commissionrate/Directorate, College Education, Shiksha Sankul, Jaipur. The Society may open its operational office at Districts and any other location in the State of Rajasthan as per requirement. The area of operation for the Society shall be entire Rajasthan and any other place as may be decided by the Governing Board of the Society time to time.

3. संस्था के उद्देश्य:— इस संस्था के निम्नलिखित उद्देश्य हैं:—

1 To provide education of high quality and enhance prospect of value research in the State of Rajasthan.

2 To establish, operate, maintain & manage College under society.

3 Enhance employment potential of the youths of Rajasthan in higher education sector.

4 To render facilities for conducting research activities relating to various specialties.

5 To put best endeavour to maintain and run Colleges under society in the State of Rajasthan.

6. To organize and run services like seminar, workshop, symposium, conference etc. to strengthen analytical approach in the field of research.

7. To synchronize with other specialty education institutes situated in Rajasthan or elsewhere.

8 To perform the other objectives associated with the objectives mentioned above and also to perform the any other objectives assigned in the related field by the State Government.

9 To develop such management as to encourage faculty for scholarly achievement, creativity, collegiality, professional competence and leadership ability and desire to teach and willingness to cooperate with other institutions in promoting the work and welfare of the college as a whole.
