

The programme included talks on importance of IPRs and their protection, Patenting procedures and Patent informatics, role of innovation, Patent searches and invention in the academia-industry collaborations, trademark and copyright protection, issues of do's and don'ts for a researcher in the context of publishing and patenting, overall Intellectual property rights etc.. The resource persons included IPR experts from National Law Universtiy, Jodhpur (Raj) Dr. Gargi Chakrabarti , two IPR experts from MNIT Jaipur one was Prof. Dilip Sharma In assistance with *Technology*

Information, Forecasting and Assessment Council (TIFAC) and other one was Dr. Amar Patnalyak who manage IPR cell in MNIT, Jaipur.

- ☉ Our chief guest was Prof. Dilip Sharma from MNIT who deliver very informative two lecturers regarding Intellectual property rights he says **Imagination is more important than knowledge**, the basic aim of conferring an IPR upon the person owning the same is to give a social recognition to its holder.



This social recognition can further bring economic benefits to its holders. It is just and reasonable to award a person an IPR in the form of 'limited monopolistic rights' for his/her labour and efforts. He explains Nature of Intellectual Property Rights like patents, copyright, trademarks, industrial design; lay out design of integrated circuits, protection of undisclosed information, geographical indications, Plant Variety Protection and Farmers Rights etc. He explains regarding the life span of the different IPR. The participants were made aware of

patent filing its important and different law to save his or her intellectual rights. The session were chaired by Dr. Amar Patnayk (Assistant Prof.) from MNIT.

- ☉ Second invited lecturer was of Dr. Gargi Chakrabarti is an Associate Professor at the Faculty of Law at National Law University, Jodhpur. She is also the Chair Coordinator of the Ministry of Human Resource Development Chair on IP at the university. Her expertise lies in intellectual property, cyber law and environmental law. who delivers fantastic three lecturers consecutively and give updated information regarding the patent position in India and the overall patent filing procedure.



The law behind the rights how, when and why all the questions were solved in the lecturer and the audience was mesmerize with her effective and informative presentation. The session was chaired by Eminent Scientist of Botany Dr. B.L. Yaday.

- ☉ Third invited lecturer was of Dr. Amar Patnayak who deliver two talks on the topic **Intellectual Property Right & indian patent system** the session was **interactive and question answer type he gives solutions to various curious**

question like what is Objective of IPR ? I have an innovation How do I protect it in the market? Rights available to a patentee? Why are patents necessary? What role do patents play in everyday life? Stages from filing to grant of a patent? Etc.



He give glimpses of patent office in India like where they are, how to approach, what exactly is the procedure and how much time it has to be taken. He explains this entire thing with informative flow chart. He state that 25% of all R&D efforts are wasted each year on inventions that have already been invented so Don't start your R&D until you have done a search! In last he also showed how his institution helping the needful for filing a patent. The session was chaired by Eminent scientist of Chemistry Dr. R.L. Pitliya.
