# 1. EXECUTIVE SUMMARY

---

## 1.1 INTRODUCTION

**M.L.V. Government College, Bhilwara** was established in **1951** as an affiliated college of **University of Rajasthan, Jaipur**. Since 1988, when **M.D.S. University Ajmer** came into existence; it has been affiliated to it. In the past this institute was having the status of **Autonomous College** among six autonomous colleges of Rajasthan. Spread in a campus of **21.30 acres**, the college has total student strength of **7852** including girls at both P.G. and U.G. levels, in all three streams, viz **Science, Arts and Commerce**. It is basically funded by the government and offers 17 UG, 16 PG programmes. Thirteen departments are actively engaged in research activities and having registered research guides. The institution was accorded UGC recognition under section 2 (f) and 12 (B). M.L.V. Government College has a permanent teaching faculty of 70, of which 45, 03, and 22 having Ph.D., M.Phil., and NET/SET/SLET, respectively. Number of recruited administrative, and technical staff is 08 and 16, respectively. Physics, Chemistry, Mathematics, Zoology, Botany, Hindi, English, Economics, History, Geography, Political Science, Sociology, Public Administration, ABST, EAFM, Business Administration are the PG programmes subjects whereas Sanskrit is an additional UG level subject. The college has 42 classrooms, 30 laboratories, Research Laboratories 13, Administrative Block (11 rooms), Departmental Rooms 17, ICT enabled facilities 34, Conference room 01, Stage/theatre for cultural activity 01, Communication skill development Language lab 01, DST-FIST Computer Networking Lab, Computer Labs 02, E-Class Room: 01, 8 MBPS Leased Line Connection, Campus Wi-Fi, Power Backup G SET 01( 65 KW), Seminar Rooms, 01 Mini-auditorium, Girl's Common Room, Teacher's Staff room and a Botanical Garden. The College has a hostel to house 144 students from economically challenged backgrounds. The Central Library of the college is enriched with over 1,25,214 books and has a reading room and a research section. The college has a large playground sufficient for a 400 m track, two Basketball courts, Hockey, Football ground, Tennis and Hand ball court. The college also has facilities for indoor games like Badminton, Table Tennis, and Weight Lifting etc. Canteen facility and parking for two/four wheelers is also available.

### Vision

M.L.V. Government College, Bhilwara is one of the pioneering institution of education in Rajasthan with a vision which emanates from its motto “?? ?????? ?? ?????????” (“savidya ya vimuktaye”). This institution, envisions a system that strives for deliverance of education which shapes objective, empathetic, unprejudiced and enlightened young learners. The vision is to become the preferred destination for young one aspiring for higher education that will empower and shape their future with nationality, moral and good values.

Vision and Mission Statements are displayed at various places in the college campus helps the students and other stakeholders to familiar with the objectives of the institution. Activities of the Students' Union and societies and clubs also reiterate the vision and mission. During important academic functions—annual awards day, Principal highlights the vision and mission statement of the institution to the audience.

### Mission

It is one of the largest institution of higher education in Rajasthan, serving the cause of education with vigor and grit to reach out to learners from diverse backgrounds with a large number of first generation learners. An

erudite, competent, dedicated and focused pool of faculties strive to equip and load the students with knowledge, skills and groom them into responsible citizens. In order to be relevant to the ever evolving world of science, the institution endeavor to impart dialogic and participatory education to encourage critical temper with the help of class room lectures and modern curriculum. Thus, we enables the students to evolve into unprejudiced yet competitive individuals to productively serve the society.

- Provide quality education with focus on moral and ethical orientation.
- Cater to the needs of students with a rural background and from socio-economically challenged strata of the society.
- Foster global competence through skill based vocational training programmes.

- Encourage the holistic development of students by following an eclectic approach.

- To create and promote opportunities for learners to engage in pedagogical evaluation.
- To nourish and inculcate values and ethics to promote unity, equality and respect for the great nation.
- To inculcate feelings of thinking and working for environment and nature for a greener and cleaner world.
- To nurture and create 'change- tool' creed, which makes the 'world a better place' to live.
- Finally, to develop sensitive, responsible and progressive citizens – who can contribute meaningfully towards nation building.

## 1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

### Institutional Strength

The SWOC Analysis of our institution for the period under NAAC analysis 2017-2021 is presented below:

- We have a spacious, well developed, city centered and eco-friendly **86198 Square meters** campus to provide a favorable environment for the holistic growth and development of the students.
- We firmly favor inclusive education and equality. All students from different financial, social and academic background are provided equal resources. State government reservation policy for SC, ST, OBC/SBC and physically challenged, nominal government fee structure, transparent merit-based online admission procedure are adopted to attain this objective.

- Monetary assistance is provided in form of various scholarships such as scholarships of social welfare department and chief-minister's scholarship.
- Students from diverse cultural, educational socio-linguistic and from dis-advantaged sections of society study together. Co-education is available at both UG and PG levels.
- The dedicated and qualified faculty of the college comprising 70 permanent and 06 temporary faculty members (under Vidhya Sambal Scheme).
- We have an inspiring environment of research in our institution. One major project of Atomic Energy Department has been appreciated by 2016 NAAC Peer Team, and we have also received a Grant of Rs. 50 Lakhs under DST-FIST scheme 2016. Besides 55 scholars are pursuing doctoral degree under **28 Research Supervisors in 13 various Departments.**
- One international level seminar has been successfully organized by the Department of Political Science in 2019.
- Personalities of literature, fine art, and conservation field and motivation guru are invited frequently to interact with the students to grow interest and to develop communication skill.
- We have excelled in many sports events particularly wrestling and volleyball.
- To facilitate the academic, curricular, co-curricular and extracurricular activities our institution has an impressive infrastructure.
- In addition to a well-stocked central library connected with INFLIBNET, our college also has separate departmental libraries in science departments.
- Majority of the faculty members are acquainted with ICT tools.
- Students in some departments are taken for field tour and excursion.
- Our learned faculty members have prepared more than 4200 videos which are available on 30 different YouTube channels of the College.
- High-speed internet connectivity (Leased line with 8 MBPS speed and Wi-Fi campus).

### **Institutional Weakness**

- Skill developing courses may be introduced as most of the courses are content based.
- Optimum use of research facilities is yet to be achieved. Faculty members are assigned other administrative tasks which really an obstacle to achieve desirable research goals.
- The institute is a state funding body and governed by the policies and decisions of Commissioner, Higher education which curtails full autonomy of the institute and faculty members.
- Funds are not available for developmental activities as the students number are increasing day by day.

### **Institutional Opportunity**

- Bhilwara is famous as 'Textile City' and offers opportunity for placement to the pass out students.
- Being a PG college and having huge research facilities, students interested in persuing research have the opportunity to get benefit of it.
- Its a multi faculty institution offers the opportunity for the student to meet NEP 2020 crriculum framework requirement.
- For fresh science graduates Vedanta group and Jindal Group offers jobs on regular basis.
- Opportunities are also there in Saras dairy plant and in textile field for science and commerce students.
- In commerce streams, diploma holders, graduates and post-graduates with exceptional skillfulness in finance, accounts and marketing coupled with excellent communication skills are hired by the local banks and insurance companies.

- Indian Army and Rajasthan police provides job opportunities to the cadets who have qualified the NCC “C” certificate and achievers sportsman.
- We are having a great sports infra structure.
- Being a co-educational institution this provides gender sensitization to all stake holders, and give opportunity to girls for higher education particularly in science streams which are not available in this geographical area.
- Well established pool of earlier students may give opportunity for present students for career opportunity and placement.

### **Institutional Challenge**

- A major challenge faced by our institution is to increase stay of the students of rural background.
- The University couldn't hold regular research entrance exam and course work programme from last few years. It affected the research environment of the institution.
- Non availability of a regular sports officer and coach facility is a major hindrance for achievement in sports. The institution is seeking hiring services in sports field.
- This academic system is out dated and we must shift to NEP as soon as possible.

## **1.3 CRITERIA WISE SUMMARY**

### **Curricular Aspects**

As an affiliated college of the M.D.S. University Ajmer, the college follows the syllabi and scheme of examination prescribed by the University for all the streams for UG and PG programmes. The college offers 17 UG, 16 PG programmes. Thirteen departments out of 16 PG departments offers Ph.D. programmes as 26 registered guides are available in these departments. In some of the departments options for special papers are available to the students at the PG level. Within the regulations of the University, the college does not have a vital role to play in the framing of subject syllabi, but some of the senior faculty contributes as members of the BOS of the University. The college encourages research culture and teaching faculty in most of the departments is either engaged in research or supervises students for Ph.D. degree. The college runs classes from 8:00 AM to 1:00 PM for the **Faculty of Commerce** and from 11:00 AM to 5:00 PM for the **Faculties of Arts & Science** to make the optimal utilization of physical and infrastructural resources.

### **Teaching-learning and Evaluation**

Admission to the various courses in the college is in accordance with the policy of Department of Higher Education, Government of Rajasthan and the regulations of M.D.S. University, Ajmer and strictly on the basis of merit and academic achievements. However, final selections are made only after personal interviews. The counseling for different programme options is provided to the candidates at the time of admissions. Remedial classes are arranged for the educationally disadvantaged and slow learners. Seminars, excursion and tours under the supervision of teachers are organized to train the students to hands on experience and successfully face the challenges of life.

The overall development of the students is gauged by the annual examination system. In Post Graduate Science Departments Semester Scheme has been implemented since 2018. The examination results of the past few years

show a good pass percentage of over 80% in the faculties of Arts, Science and Commerce. The teachers prepare and circulate a teaching plan and adhere to it within the limitations of academic and other activities of the college. The college has 70 permanent teaching faculties, as many as 45 have doctorate degrees and are pursuing and supervising research. Many of these have attended national and international conferences seminars besides their participation in the refresher and orientation courses.

There is a mechanism for faculty appraisal through the submission of self-appraisal report by all teachers. An informal method of receiving feedback from the students regarding the teaching based learning through suggestion drop box and personal interaction with faculty members and the Principal. To further enhance the quality of education, the college has taken steps to establish linkages with the local industries.

### Research, Innovations and Extension

The college offers Ph.D. programmes in 13 PG departments out of 16. The institution provides laboratory and library facilities to scholars and faculty members. Faculty Members are permitted and encouraged TRF scheme for pursuing research work. 145 students have been awarded M.Phil., 95 research scholars have been awarded Ph. D. degree since the establishment of college. Presently 28 faculty members are registered research guides belongs to 13 departments of all the three streams. 54 students are registered for Ph.D. degree and pursuing research. Faculty members and researchers have published **179** research papers in journals of national and international repute in last five years. Teachers have authored 133 books/ book chapters or papers in conference proceedings, some of which have received recognition in the state as well as elsewhere. One major research project funded from DAE- BRNS have earned a reputation. We have also received a grant of Rs. 50 Lakh under DST-FIST scheme 2016.

The college has **04 units of NSS (three for boys and one for girls), NCC, one platoon and one company, and two units of Rover and one unit of Ranger.** NCC, NSS, Rovers and Ranger volunteers are involved in many social outreach activities like literacy program, hygiene awareness and tree plantation and environmental consciousness. They have adopted some villages and continuing extension activities in these villages. Blood donation camps, Polio eradication and AIDS awareness campaigns are also being conducted regularly.

### Infrastructure and Learning Resources

With a total area of **21.30** acres (86198 sq.m.), the college has excellent infrastructural facilities. The college has **42 classrooms, 30 laboratories, Research Laboratories 13, Administrative Block (11 rooms), Departmental Rooms 17, ICT enabled facilities 34, Conference room 01, Stage/theatre for cultural activity 01, Communication skill development Language lab 01, DST-FIST Computer Networking Lab 01, Computer Labs 02, E-Class Room: 01, 8 MBPS Leased Line Connection, Campus Wi-Fi, Power Backup G SET 01( 65 KW), Seminar Rooms 04, 01 Mini-auditorium, Girl's Common Room, Teacher's Staff room and a Botanical garden.** The College has a hostel to house 144 students from economically challenged backgrounds. The Central Library of the college is enriched with over **1, 25, 000** books and has a reading room and a research section. The library is fully automated and as many as **32 Journals/Periodicals** and **INFLIBNET** facility has been subscribed. There is also a **Book Bank** facility available to the financially weaker students. **Departments of Physics, Chemistry, Botany and Zoology (Science Departments) and Economics Department (Arts Stream) have their own departmental libraries.** One Community library has also been set up.

The college has a large playground sufficient for a **400 m track**, two Basketball courts, Hockey, Football ground, Tennis and Hand ball court. The college also has facilities for indoor games like Badminton, Table Tennis, and Weight Lifting etc. The students of the college have earned distinctions at the national level and one of its old students has been awarded "Arjun Award" while two of them have earned the recognition as international referees. **Canteen facility and parking for two/four wheelers** is also available.

### **Student Support and Progression**

The college has a good reputation for its academic standards. The results are consistently good (above 80%) in Science, Arts and Commerce streams at UG and PG levels. As many as 10 students have been selected as assistant professors in state funded university and or government colleges in past five years. The students are offered counseling at the personal level by the faculty members and through Placement cell and Student counseling cells. The college has grievance redressal cells for staff as well as students. Alumni association is active in many institutional welfare activities.

### **Governance, Leadership and Management**

**The M.L.V. Govt. College Bhilwara** is a Government funded institution and has to function, organize and manage within the regulations of the State Government. For academic programmes the regulations of the **M.D.S. University, Ajmer** prevail while internal coordination and monitoring is done by the Principal. Various committees are constituted by the Principal for smooth and efficient functioning of the college. The financial management is achieved through the grants from the State Government and RUSA scheme. Funds are also being generated through college fees, college development head etc. The accounts of the institution are well maintained and audited regularly.

### **Institutional Values and Best Practices**

- The college-has shown consistently good examination results.
- As many as 10 students have been selected as assistant professors in state funded universities and government colleges in last four years.
- Consistent and good research work and a good number of research projects in a number of departments.
- College follows annual gender sensitization action plan.
- We follow scientific method for solid/liquid/chemical waste management.
- The College has two water conservation recharge systems (Open well type facility)
- Under green campus initiatives we conducted **Green and Environmental Audits, Energy Audits, Plantation Drives, Promotion to use of bicycles, Bird and butterfly conservation, Ban on use of plastics etc.**
- The Institution has disabled-friendly, barrier free environment: 05 Ramps and wheel chairs, provided assistance during examination.
- This institution has a 40 kw Solar power generation system.
- The campus has around 700 trees growing all around the campus.

**Practical sessions and lab activities:** Lab manuals are prepared containing experiments based on the syllabus.

**Assigning projects to the students:** Field work, case studies, social surveys are part of the curriculum in many subjects like Physics, Chemistry, Geography, Botany, Zoology, Sociology, Economics etc.

**Extension/Guest Lectures** by subject experts.

**Interactive sessions** inside/outside the classrooms.

**Application of theoretical knowledge** through fieldwork and practical /experiments.

**Provision of extra/remedial classes for slow learners.** Resources like relevant websites and e-resources are made available for advanced learners.

The institution deploys the following well-chalked out action plan for effective implementation of the prescribed curriculum.

**1. Time Table:** At the beginning of each academic session, academic calendar along with the timetable is prepared according to the number of the students admitted, and is displayed on the student notice boards and Institutional Webpage.

**2. Formation of sections:** Sections are formed on the basis of the subject combinations and students' strength.

**3. Curriculum Delivery Planning:** At the beginning of the each academic session, meetings are held at the departmental level for curriculum delivery and planning. The schedule of work is allotted to the teachers.

**Response:**

Holistic development and meaningful learning is the motto of our College and this is made possible through an atmosphere of support and students-teacher interaction. Every effort is made towards the **active involvement of students** in the whole process of teaching and learning. **Student-centric education is the most distinctive feature of the college.** Other than traditional classroom teaching, the teaching-learning process in the college strongly focuses on **enhancing skills, experience and knowledge.** Experiential learning, participative learning, and problem-solving methodologies implemented inside and outside the classrooms include:

**Providing a conducive and opportune teaching-learning environment:** Extending an atmosphere for nurturing values, skills, and critical /creative thinking is the first step towards making learning experiential.

**Activity Learning through Educational Tours and Excursions:** Field trips, excursions, educational tours are conducted regularly in Chemistry, Physics, Botany, Zoology, Geography, Economics, and Sociology. Role plays, games and interactive sessions in the classroom also initiate participatory learning.

**It is mandatory for students seeking admission at the first-year level to opt for any of the extra-curricular activities offered by the college. Co-curricular activities are undertaken with an aim to move beyond the realm of formal learning and foster creative and critical thinking.** Activities like debates, quiz, poetry recitation, skits, drama, song, and dance competitions are organized regularly. Other platforms that focus on participative learning include college magazine *Ankur*, **Departmental Societies, Red Ribbon Club, Eco Club** etc.

**Guest/extension lectures by experts:** The subject experts are invited periodically and these help in providing added and updated knowledge of the subject and enhances the learning experience.

**Departmental Libraries:** Some departments have their own libraries giving access to PG, and Ph.D. students.

**Practical in Laboratories:** The practical in laboratories is performed in batches where students learn from each other thereby encouraging participatory learning.

**Case Studies:** Case study has been made mandatory in few PG programs in Social Sciences and Humanities.

**Communication skills' training** is provided to students during Language lab sessions.

**Project-based learning** - Certain courses related to Physics, Chemistry, Zoology, Botany and Geography demand project-based Learning. The teachers are the guides to the students in the process of preparation of projects. All the PG Departments conduct student seminars regularly.

**Laboratory facilities in all science subjects are well equipped.** Sophisticated and specialized laboratories are available for PG and Ph.D. students in Chemistry, Zoology, Botany, Physics, Geography, and Political Science Departments. Geobotany Research Centre and Herbarium have been established in Department of Botany.

## 2.5 Evaluation Process and Reforms

### 2.5.1

**Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient**

**Response:**

The college is affiliated to Maharshi Dayanand Saraswati University, Ajmer and the students are assessed either through annual examination or semester scheme (Science PG only). Our Institution does not have any formal process of continuous internal evaluation but the college has its own modus operandi for the same and implements evaluation procedures during the course of the academic session to evaluate the learning capacities of its students at various levels :

As per the curriculum, in all the science subjects it is mandatory for PG students to participate in the departmental seminars and students are evaluated on the basis of their presentations and marks are included in their practical exams.

The Head of respective Departments call a meeting at the beginning of the academic session and discuss the previous year results and chalk out the teaching plan for the current year. The suggestions received are then implemented to improve the performance of students and for the effective execution of the curriculum.

In all the subjects where practical exams are part of the curriculum, it is mandatory to submit a practical record that is evaluated and marks are added during the final consolidation of results. The project report is also compulsory in some of the subjects and is considered for assessment.

Periodical class tests are also conducted on regular bases which help the students in their preparation for the final exam.

Three term test are also conducted in every session. Home assignments were given during COVID period.

All the teachers are in the examination panel of the University and they render their services in setting the question paper and evaluating answer books. The college acts as an important center for assessment of answer books of the University Annual Examinations. The Principal acts as the coordinator for the assessment center.

**The college is a big examination center and almost 2000-2500 students appear for their exams every day during annual examinations.** Almost all the teachers are in the panel of examiners for paper setting and evaluation of answer books. **Any representation regarding question paper, examination related issues and evaluation is forwarded to the University. During the exams, unfair means case and grievance related to question paper are forwarded to the university immediately for necessary action.** The examination procedure is completely transparent:

- The time table is displayed on the university website.
- Admit cards are generated online.
- The examination process is looked after by center superintendent, additional centre superintendent, and assistant superintendents. Answer sheets are distributed room wise along with question papers and attendance sheets to the invigilators. After examination, answer sheets are collected by the invigilators and submitted to the Examination Committee for further process.
- The invigilation duties and attendance sheets are generated online.
- The payment for invigilation duties is done online.
- The question papers are kept in safe custody in the strong room.
- The answer books are coded.

The answer books are evaluated fairly in time and results are declared and displayed on the University website

The UG programmes are B.A, B.Sc, B.Com, and PG programmes are M.A, M.Sc., and M.Com. The college is affiliated to **Maharshi Dayanand Saraswati University, Ajmer** and it follows the curriculum of it. The faculty members

contribute in the capacity of BOS members and conveners for curriculum enrichment.

**Communication of PO/CO to students:** The results are displayed on the university website. The learning outcomes of final year UG and PG programmes are also displayed on the college website. There is a Students' Help Desk where faculty members are available even during the summer vacations. The students seeking admission may seek advice from teachers and discuss the COs and POs. This helps them in selecting electives and extension activities offered by the institute.

**Communication of PO/CO to faculty:** The faculty members discuss the programme outcomes in their respective departments. The department-wise time-table is discussed and the teaching plan is prepared keeping in mind the results of the specific programmes. The outcomes for all courses, programmes and elective papers helps the teachers evaluate the objectives of the subject content. This evaluation also helps the teachers identify the learning capacities of the students and take corrective measures accordingly. The mentors help the average achievers to attain better outcomes and motivate the advanced learners to aim for bigger goals. The students have shown brilliant performance in the University exams and the overall result percentage is almost above 80%.

We Organize various events under **SVEEP Program**.

**Social Issues of concern:** Camps on different social issues are organized from time to time on topics like “Saving the girl child”, awareness towards ‘AIDS’ and so on. Various competitions related to this viz. Rangoli, slogans, posters etc. are also held to percolate the message related to the concerned issue in the Society.

Overall, the aim of inculcating social values among students, making them aware towards social issues and solving them with the help of local community, nurturing them towards social justice and cause and enhancing their responsibility and personality, resulting in a socially mature individual intellectually as well as emotionally and making them a worthy citizen of the Society is thus achieved by the College.

To cater to the needs of the students, the college offers good reading material in the form of books, periodicals, encyclopedias, magazines, newspapers etc. It is a place that is used for acquiring knowledge and gathering information. The college library is neat and clean and with comfortable furniture. It provides a peaceful and scholarly environment which is an incentive to study. There are separate reading and reference rooms. The library staff is also very co-operative and renders all sorts of help needed by the students and faculty equally. The students are issued library cards and besides reading in the library they can also get the books issued, carry them along and return them after reading, limited time is of course given to restrict unwanted keeping the

books by students and bringing them back for rotation among other students. Undoubtedly, the college library is a boon to students in this region as the college has the maximum number of students from a rural background and poor economic status:

The college library has about 1, 25,214 books classified and indexed as well as and 46 journals and 36 periodicals and magazines. The library is situated in a separate independent building which includes two reading halls, one reference room and two rooms with computer facility.

The whole library is facilitated with Wi-Fi network and is fully automated since 2018. The library is fully automated with Raj e-Library Management web-based software hosted by RSDC, DoITC, Jaipur.

This College is a registered beneficiary of the project National Library and Information Services Infrastructure for Scholarly Content (N-LIST), which is jointly executed by the e-Shodh Sindhu Consortium, INFLIBNET Centre and the INDEST-AICTE Consortium.

The scheme provides access to e-resources to students, researchers and faculty from colleges and institutions through servers installed at the INFLIBNET Centre. The authorized users from colleges can access e-resources and download articles required by them from the publisher's website through servers at the INFLIBNET Centre. The scheme provides access to more than 6000 +ejournals along with back files for 10 years and 97000+ebooks.

In our Institution we have a community library having 326 books.

A library committee is constituted for smooth functioning of the library.

**Studios:** Two lecture recording studios are available one each in Department of Botany and Physics.

**The E-Class Room:** The room is equipped with interactive panel, cameras, projector, lights and furniture for live telecast.

**High Speed Internet:** A High speed internet BSNL leased line with 8 Mbps speed and access to free internet through Wi fi.

**Biometric machines:** Biometric machines have been installed.

#### **Learning Management System (LMS)**

### 6.1 Institutional Vision and Leadership

#### 6.1.1

#### Response:

M.L.V. Government College, Bhilwara is one of the pioneering institutes of education in Rajasthan with a **vision** which emanates from its motto “?? ?????? ?? ?????????” (“*savidya ya vimuktaye*”). This institution, envisions a system that strives for deliverance of education which shapes objective, empathetic, unprejudiced and enlightened young learners. The vision is to become the preferred destination for young ones aspiring for higher education-education that will empower and shape their future with enough nationality, moral and good values.

Our mission is-

- Provide quality education with focus on moral and ethical orientation.
- Cater to the needs of students with a rural background and from socio-economically challenged strata of the society.
- Foster global competence through skill based vocational training programmes.
- Promote the use of information technology and computer application.
- Empower our young women to gain financial independence.
- Encourage the holistic development of students by following an eclectic approach

The leadership and governance of the college is well reflected in its vision and mission. The College has a defined organizational structure for effective decision making and execution of responsibilities.

**Governance:** The College comes under **the Commissionerate of College Education Rajasthan, Jaipur** headed by the Commissioner (Senior IAS). At the College level the **Principal** serves as the **Head of the Institution**. Three top senior faculty members are assigned duties of **Establishment section, Accounts section and Academic section** to shoulder various administrative responsibilities. **The Heads/ In-charges of the Departments** act so by virtue of their seniority and are responsible for the functioning of the respective Departments. The performance of every employee, teaching or non-teaching, is **appraised** by the **Principal** and reviewed by the higher authorities. Regular meetings of the college Committees and stakeholders play a significant role in overall governance viz. **planning, deployment, monitoring and execution** of agendas pertaining to development, academics, research, innovative practices, and social responsibilities.

**Perspective plans:** The administrative strategies are planned and executed both at the **Commissionerate and at the Institutional level**. The members of **BOS** receive feedback from students, teachers, IQAC, and **College Development Committee (CDC)** and initiate modifications in the curriculum. Action is taken accordingly on the basis of feedback regarding teaching, institutional social responsibilities,

augmentation of facilities and other areas.

**Participation of the teachers in the decision making bodies of the institution:** Constitution of committees for specific purposes clearly reflect effective governance. More than 80 committees are framed at the beginning of every academic session. The **Staff Council Meetings** and respective committee meetings are called upon periodically for efficient implementation of agendas related to teaching, curriculum, admission, examinations, students' union elections, co-curricular and extracurricular activities and any other significant matter related to the development of the institution. The committees are well supported by non-teaching staff.

**College Development Committee (Mahavidlaya Vikas Samiti):** It works as the liaison between the society and the College. It also steers and helps in the effective implementation of strategic planning by giving feedback and generating finance.

## 6.2 Strategy Development and Deployment

### 6.2.1

*The institutional perspective plan is effectively deployed and functioning of the institutional bodies is effective and efficient as visible from policies, administrative setup, appointment, service rules, and procedures, etc*

#### Response:

The college under the aegis of Government of Rajasthan is managed by the **Commissioner, College Education, Rajasthan, Jaipur. Principal** is the **Academic and Administrative Head of the Institute** and works as a link between the state head-quarter and the faculty members for information transfer and proper implementation of quality enrichment measures and decisions. **Principal** formulates strategies for assurance and implementation of quality education as per the norms of **Government of Rajasthan** in adherence of circulars and notifications issued by CCE, Rajasthan, Jaipur.

**IQAC Cell** has been set up in accordance with NAAC guidelines, and the centralized unit that adopts quality enhancement measures for its development.

Three top senior faculty members are assigned duties of the **Establishment section, Accounts section, and Academic section**. Teaching staff comprises of Associate Professors, Assistant Professors, and Contract Faculty. For the last two years in the subjects where faculty members are below 50%, temporary appointments are given under **Vidhya Sambal Scheme**. The non-teaching staff includes Accounts Officer, Administrative Officers, Assistant Administrative Officer, Senior and Junior Assistants, Librarian, Assistant Librarian, Sports Officer, Lab Assistants, Artist, Taxidermist, Assistant staff,



Gardner etc. The College appoints few staff (security guards, gardener, swachhatakarmi, computer operators, library assistant etc.) on daily wages basis under **CDC head**.

**Committees** are constituted (86 committees) for smooth running of all academic and administrative activities. The post of Sports Officer is presently lying vacant; therefore, a Committee looks after all the sports activities. The teaching staff is assigned various responsibilities either conveners or members of the committees.

The Administrative structure of **College Development Committee** (Mahavidhyalaya Vikas Samiti) comprises of Principal, District Collector, Government Representatives, Renowned Academicians, Social Workers, and Parents of Regular Students, IQAC Coordinator, Secretary (Senior most faculty member) and a Treasurer (a senior faculty member). The CDC act as a key body which approves proposals for infrastructure from its own funds as well as provides input and feedback for teaching-learning.

**Service rules:** The College is a Government institute and therefore it is mandatory to follow the rules, regulations, policies framed by the State Government (RSR). **Recruitment:** The staff is recruited by Rajasthan Public Service Commission/ Rajasthan Staff Selection Board. Daily wagers are appointed through a registered agency. Mercy appointments are given in accordance with government policies in place of the demise of a close relative who served in state government.

**Promotional policies (CAS):** The regular promotions are decided on the basis of recommendations made by the **Departmental Promotion Committee** based on **UGC 2018 guidelines and State Government Rules**.

**Grievance redressal:** Internal complaints committee, anti-ragging cell, grievances redressal cell, and anti-women harassment committees have been set up to look into complaints and solve issues. **Rajasthan Sampark Portal** is also serving as an online platform for grievance and complaint redressal. The SC/ST cell, minority cell have also been constituted. Besides, a committee called legal cell is also constituted to look into court cases. RTI and Human Rights Cells are also working in the College for dealing issues. The students can directly approach the principal for grievances redressal.

**Response:**

**Best Practice I**

**Title of the Practice: Develop Environmental Consciousness**

**Goal: To maintain a Green and Clean Campus**

**The Context:** Environmental education is the teaching of individuals, and communities, in transitioning to a society that is knowledgeable of the environment and its associated problems, aware of the solutions to these problems, and motivated to solve them. UNESCO states that Environmental education is vital in imparting an inherent respect for nature amongst society and in enhancing public environmental awareness. “Think globally and act locally” feeling can be boosted in students when they are provided with practical knowledge of environmental issues. To fulfill this campaign and drive for plantation is organized in the campus every year. Clean campus mission instill the values for dignity for labor and develops an aesthetic sense in our learners.

**The Practice:** The Clean Campus, Environmental Conservation and Campus Beautification Committee in coordination with the Eco Club, Department of Botany, NSS units, NCC cadets, staff of the college, NGOs and community personnel making efforts to keep the campus green and clean. During Vanmahotsav, Independence day, Ozone day and any other suitable occasion plantation programme is organized under aegis of any one of the above units. Department of forest and environment officers and other experts are also invited to guide these drives. For cleanliness separate pits are constructed to dump the biodegradable and non-biodegradable waste. Awareness campaigns are organized to make the campus eco-friendly, green and clean.

**Uniqueness:** Students are provided the saplings of the plants and asked to grow these saplings in college campus at space provided for it. They are asked to take care of these plants their own. A watchword of

this programme is each one-each tree for successful implementation of this scheme. Several NGOs such as Bharat Vikas Parishad, Prayavaran Samvardhan Sansthan are involved for better outputs. An area is developed as dense forest zone named Oxyzone under community funding and **MoU has been signed** for it.

**Constraints:** Safety of plants and water availability are the major problems and constraint. Tree guards are used to protect some of the trees and plant species which are drought tolerant are used for plantation. Rainwater harvesting structures are found useful for increasing water table.

Evidence of Success: This institution has more than epitome with 700 standing and a mature tree in 21.30 acres of Green Eco-friendly campus is one of the evidence of success. Dust and dirt free environment of the campus is another evidence of success. Class rooms and laboratories are neat and clean due to increasing awareness of green and clean campus movement. At a larger extent the environs of the campus becomes pleasant due to these efforts.

Problems Encountered and Resources Required: Although the success of this programme is highly satisfactory but from the month of February onwards to month of June care from students side becomes a major limitation and this trend results in mortality of few of the plants. Availability of tree guards from Urban Improvement Trust (UIT) and Municipal Corporation is another limitation this culminates in death of more plants due to cattle grazing. Occasionally Municipal Corporation services are provided to clean the campus through JCB machines and other resources but for regular cleaning of barren area is another challenge for us. *Parthenium hysterophorus* (Carrot weed) infestation during rainy season creates a nuisance in majority of the barren area of the campus and management of carrot weed invasion is quite difficult.

**Notes (optional):** The inception of the above scheme reflects the vision and sensitivity of the college towards the nature.

**Best Practice II****Title of the Practice: Creating Research Culture in the College*****Goal: To promote high quality environment of research***

M.L.V. Government College aims to encourage research and innovation in sciences, humanities and social sciences and commerce field and some allied areas. Towards this goal, the college has encouraged faculty members to participate in various aspects of research in their field of expertise.

The Context: The institution has a sufficient strength of research faculty to provide the necessary guidance which consciously promotes a research environment on campus. 42 permanent faculties at the institute possess a Ph.D. out of 64 faculty members. Thus, there is a strong impetus from the faculty to involve in research. Faculty members have received grants for Major Research Projects from Department of Atomic Energy (**PI-Dr. B.L. Jagetiya**) and UGC etc. This College has received DST-FIST grants for two terms.

The Practice: The College encourages, PG students to focus on research after completing PG degree. Faculty members are encouraged to under-take minor/major research projects from various funding agencies and guide Ph.D. students. Students can avail schemes of UGC, CSIR, DST, DBT etc.

Evidence of Success: The College has created an enthralling research atmosphere that motivates the PG students to engage in research for the Ph.D. degree. Many papers with student authors with their guide have appeared in national and international journals and conferences. Another sign of success is that right from the beginning 95 plus students are awarded Ph. D. and 145 awarded M.Phil. Degree. Around more than 600 research papers have been appeared in Journal of national and international institutes. **Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words**

**Response:**

Theatre has been associated with fine arts from the very beginning in human life. Dramas are not only prescribed in the syllabus of UG and PG courses of English literature but also they give an insight into human life with all weakness and strengths. Secondly such stage productions give an opportunity to students to learn many things like learning English language and its native pronunciations. Theatre is the metaphor of life and has been an integrated part of the curriculum of colleges and universities. Our College is pioneer in organizing many theaters, dramas and plays which is its one of the distinctive area to its priority and thrust. Few of such activities are that have been performed are followings:-

Enacting Shakespearean plays has not been a new thing or a matter of surprise in the campus. On this behalf in the campus of M.L.V. Government College, Bhilwara two of Shakespeare's plays '**Macbeth**' and '**The Merchant of Venice**' have been staged so far. The main objective behind these stage productions was to make students aware about the world of Shakespeare as a playwright who holds a significant name in literary arena. These practices make students learn about Shakespeare who are not from literary background or from humanities side.

The enactment of MACBETH and THE MERCHANT of VENICE went superb and wonderful. The hall of the college was full and hundreds of students waited outside the hall for the second show. All the students performed well and the plays made the renaissance atmosphere live as the students came on the stage in the costumes of the British society. The dialogues were aptly delivered and it was all highly appreciate.

Both Macbeth and The Merchant of Venice went for two shows on the same day. Both these two stage productions were well covered by media. On the enactment of Macbeth The district collector, Hon SP Jailor, Ex Vice Chancellor of CU Haryana with faculty members of the college were present. In the enactment of The Merchant of Venice ex VC of CU Haryana inaugurated the function. There occurred problems of light, sound, costumes .language, pronunciation etc. Moreover the big problem was to hold

the students for regular and rigorous rehearsals for more than six months. After all the major issue of satisfaction was that the department of English made Shakespeare enjoyable and knowable to those students who never knew him before. Both these two stage productions were directed by **Dr. Anant Dadhich, Department of English.**

A Good number of students from different disciplines and streams participated in a play 'Aawaaz-E-Haq'. The play was directed by **Dr. Devkanta Sharma**, Associate Professor from the Department of Public Administration. The show of this play was also presented in the town hall of the city. This show of 'Aawaaz-E-Haq' gave the message to the student fraternity that how does our constitution law and police system help such women fight against all such humiliation and ills of society and how do we get empowered by the network of law and order. To do theatre in the premises of Government Colleges particularly with the students of rural areas has been full of challenges.

Recently in the Bhilwara Science Fest held in the College Final Year students from the PG department of chemistry presented a dramatic show on science and superstition. In this play the clash between science and superstition was shown and this was also presented that how people are cheated in the name of age long traditions and customs prevailing in society. Mostly the victims are innocent people from rural area. The director of the play was able to show that the miracles and some of the supernatural events shown in the name of superstitions are merely the outcome of the formulas of science. This play was directed Dr. Saurabh Singh from the Department of Chemistry.

This institute has practicing play and theatre enacting as culture and tradition as part of regular activity to inculcate moral, character building and other human values among the students.
