## 1.1 INTRODUCTION

Government Girls College, Chittorgarh situated in urban area is one of the premier Girl's Colleges of the district Chittorgarh (Rajasthan) providing higher education to the girls/women. College was established by the Government of Rajasthan in the year 1995 with initial intake of 162 students in faculty of Arts and Commerce. Since there was no facility exclusively for girl students to study Science in the district, in the year 2010 Science Faculty was started in this college. The college was established with a clear vision and mission. The college has been accredited twice in 2005 and 2017 as C++ and B respectively and recognized by the state government as center for excellence. The institution volunteers for its third cycle of accreditation.

Presently 14 subjects are taught in the college at undergraduate level in B.A., B. Com, B.Sc. and two subjects at postgraduate level which are Hindi and History.

The principal is the head of institution and performs the duties related to overall administration, monitoring, planning and implementation with the dynamic leadership of the principal **Dr. Gotam Kumar Kukda** and a team of committed faculty members of the institution is progressing and reaching new heights of excellence.

The college has excellent infrastructure to run quality academic programs. It is connected with Wi-Fi, it has adapted ICT based methodologies in teaching learning and evolution. Variety of activities through clubs and committees has been organized for the holistic development of the students. The result of the college has always been excellent.

- Vacant permanent posts of faculties, librarian and physical instructor.
- Shortage of teaching and supportive staff.
- There is need of sports infrastructure and indoor stadium.
- There is limited number of consultancy & exchange programs.
- Weak communication skills of students.
- Absence of linkage and collaboration with industries.
- College runs primarily under-graduate courses with focus on teaching and learning rather than research.
- Only few faculty members are registered as Research Supervisors.
- Entrepreneurship development activities on campus are yet to be optimized.

- Short tenure and frequent change of the head of the institution.
- Frequent deputations and transfer of the faculties to the other institutions.

## **1.3 CRITERIA WISE SUMMARY**

## Curricular Aspects

**Curricular Aspects**-Government Girls College, Chittorgarh is affiliated to MohanLal Sukhadia University, Udaipur and follows the curriculum designed by the affiliating University. The college shows a lot of potential in introducing innovative thoughts within these predetermined academic frame work, committed to provide equal opportunity to all its students for holistic development. The current issues relevant to professional ethics, human values, gender sensitization, environment and sustainability are integrated in post-graduate and under-graduate curriculum. The curriculum includes some important compulsory courses to impart common basic knowledge to everyone and electives courses to pursue educational interests.

- For Arts, Science and Commerce stream, “Environmental Studies” is the compulsory paper in UG Part I level.
- One has to also opt either Hindi or English as in the first year of graduation.
- The students pursuing graduation choose their groups of interest from a plethora of 5+2+1 subject combinations in Arts, Science and Commerce.
- Presently the college offers under-graduation in 14 subjects and post-graduation in 02 and Ph.D. in 01 subject.

For conducting continuous Internal Evaluation, teachers conduct oral class test and board test in the class room and prepare their online lectures and upload them on College YouTube channel and link is shared in WhatsApp groups of different classes of the college.

Assignments are given either offline or online as Google forms.

## Teaching-learning and Evaluation

- Class 12th scores are taken as the initial indicator of students learning ability at the entry level in college. The enrollment percentage of students for the last five years is above 75%. Seats marked for reserved category are filled 96% with reserved category students.
- In addition to chalk and talk methods of teaching the faculty members are using IT enabled learning tools like PPT, screen recorder, Google classroom etc. The college has One Computer laboratory with 24 computers, one smart classroom with projector.
- Faculty regularly consults and shares reading materials in WhatsApp groups, lecture videos on YouTube. Search engines like Google search, Google scholar are used to encourage collaborative learning.
- Some faculty members have created online digital repositories for lecture on platforms like YouTube.
- The percentage of full time teachers against sanction posts during the last five years is 60%.
- The percentage of full time teachers with Ph.D./NET during the last five years is 70%.
- The college has 14 departments in all, 06 in Arts, 05 in science and 03 in commerce.
- The UG programs are B.A, B.Sc., and B.Com. And PG programs are M.A. in Hindi and History.
- The college is affiliated to MohanLal Sukhadia University, Udaipur and follows the curriculum prepared by it.
- The evaluation process involves the analysis of feedback on curriculum, teaching, and progression to higher education, skill development programs, and updated curriculum for competitive exams.
- The examination process is transparent and compliant with the MohanLal Sukhadia University, Udaipur guidelines and follows an Annual as well as Semester Examination scheme as per the University calendar.

- Most of the teachers are in the panel of examiners for paper setting and evaluation of answer books.
- Any Examination related grievances are forwarded to the University.
- Course Outcomes are measured on the basis of performances of the students both in curricular and co-curricular activities and also on the basis of the students' performance in the class activities, laboratory work, assignments and annual examinations.
- The pass percentage of students during last five years is 95%.

### **Research, Innovations and Extension**

- The main thrust of the college is on teaching still there is research ambience among faculty members.
- 14 research papers in Arts, Science and Commerce have been published by faculty members in journals notified in UGC Care list during last five years.
- The teaching faculty continuously participates in Conferences, Workshops, Seminars, Orientation /Refresher /Induction /Short Term Courses and Faculty Development Programs (FDP). They participate in the academic programs of other colleges as invited resource persons.
- They had 59 publications during last five years including books & chapters in edited books and proceedings of Conferences and Seminar.
- One faculty member is registered as supervisor by affiliating university.
- Several extension activities have been carried out for holistic development of the students.

One NSS units, one Ranger unit are also working in the college and serving the society. NSS unit is engaged in a large number of varied types of activities for over-all development of students and society.

Programs such as Swachhh Bharat, AIDS awareness, Covid-19 Awareness, Environmental Awareness and Gender issues related Programs have been conducted by these units in collaboration with industry, community and NGOs during last five years. The college also has an active Electoral Literacy Club and a Consumer Club. Online webinars have been conducted on Various Aspects-

- Gyan Sudha Program.

### **Infrastructure and Learning Resources**

- Government Girls College, Chittorgarh has a campus area of 30333 sq. mt. The building includes administrative block with Principal chamber, Establishment, Account, Examination sections, Store room, Staff room, Girls common room etc. For academic activities college has an adequate number of classroom and well-equipped laboratory facilities for the students.
- A smart classroom has also been established to record, edit and upload lectures and videos and also to deliver them directly to the students. Cultural activities and other activities are carried out in activity hall. A student union room, Botanical garden, NSS office are also available.
- Our College library has reading room and more than 12,214 books of different subjects. Each and every books of library have a fixed Accession Number.
- The Institute has rain-water harvesting tanks for water conservation purpose.
- The college receives funds from government grants and utilizes them as per the general finance and

account rules of the State.

- The College infrastructure is also used as an Examination center by MLSU, PTET, REET, Police constable and several other competitive Examinations.

### **Student Support and Progression**

- All the scholarships declared by the state government are provided to the eligible students in the Government Girls College, Chittorgarh.
- The scholarships of regular students are disbursed through Pay Manager in their relevant bank accounts in prescribed time.
- Several programs are organized under various committees for capacity building and communication of linguistic skills among the students.
- Yoga-Pranayama camps and medical counseling camps are organized for their health benefits on regular basis which has benefitted a lot of students as many of them have motivated to practice yoga & pranayama regularly at their homes.
- Keeping in mind of self-employment, data entry course training was also organized at the college level. Self-employment is necessity of recent time so such programs proved pivotal for many students. - The college has a transparent mechanism for grievance redressal including sexual harassment and ragging cases. Grievance redressal cell has been constituted at the college level. Complaints can be filed online on Sampark Portal. Complaints are disposed in time.
- Many students passed from the College get selected in Government and Private sectors. They provide their services in Administration, Education, Accounts and other departments and offices or they may continue their studies in higher education.

College is spread over 30,333 square yards and approximately constructed over its one third area. Institute comprises Academic and Administrative Block, Library, 1 Hostel, Sports Ground and a canteen. The college has 14 classrooms, including 01 smart classroom. A well-equipped seminar room and an activity hall. For clean and safe drinking water facility RO systems are installed. The college is having 05 laboratories for arts and science subjects. All the labs are equipped with sufficient instruments. One computer lab is also available. Faculty rooms/departments are available for Science and Home Science department. The college has a central library with 12214 books and departmental libraries are also maintained by departments. Environmental conscience is reflected by possessing green campus. CCTV cameras are installed in the college campus for 24X7 surveillance.

The sports infrastructure includes a lush green playground. Students are trained to participate in Collegiate; Inter-Collegiate, Inter-University, State level sports competitions. An open-air stage is also available on the campus The college regularly organizes various interclass/college and state-level cultural and literary competitions. An annual cultural event is also organized every year. The cultural committee headed by a senior faculty member manages the cultural events. According to government policy, weightage is given to students, in the admission, who have special achievements in sports, cultural and literary events. To motivate the students, the college provides incentives to the winners and participants of sports and cultural events.

7. The funds received are properly allocated and distributed for the meant purpose and utmost care is taken that they are properly utilized.

The Bill section and Accounts section of the college maintain the details with regards to accounts, audited by a Chartered Accountant hired for the purpose by the College. Audit from the Directorate/ State checks and verifies the accounts for irregularities if any. Any shortcomings/objections, raised by the Audit are settled up as per rules and policies. The External Audit is carried out by the auditors from the Office of Accountant General (AG) Rajasthan, Jaipur.

##### **1. The Context:**

Our college is committed to the cause of building environmental consciousness among students, staff and community members. Building a campus that has zero plastic use, produces minimal waste, disposes/converts of its solid, conserves energy, lowers consumption, protects biodiversity, and practices self-sustainability in areas of water and cleanliness is challenging due to environmental degradation.

##### **1. The Practice:**

- **Cleanliness campaign**

In the college and nearby campus cleanliness campaign is given special priority under various one-day and special camps by the unit of NSS.

- **Plantation:** Plantation program was organized every year. The Principal with all academic and office members, students, NSS volunteers actively participate in the program and many trees were planted at various places in campus.
- **Compost Pit for Waste Management-**

**College has taken initiative about composting for waste management by making compost pit in college campus. This Compost will be used as manure and fertilizer in our college garden and botanical garden, so composting is an important part of waste management in our college.**

- **Increase in green cover:** The College has greatly improved its green cover. In Our campus, there are over 75-100 plant species, including 15 types of medicinal herbs.
- **Botanical garden:** The College has a botanical garden and maintains medicinal trees.
- **Tobacco-free zone:** The College has guaranteed that its campus is tobacco-free zone. The college also organizes awareness campaigns towards this purpose to our faculty and students.
- **Rainwater harvesting:** The College is steadily working towards the creation of an infrastructure to facilitate rain water harvesting on a large scale.
- **Saving paper:** The College is consciously working towards reducing the use of paper by way of digitalization of documents. The Whatsapp group of all faculty members has also been made for dispersion of various documents in electronic form.

- The Green Campus initiative is a rather expensive practice. It needs expert advice and an investment of resources.

**3. The Context:** Gender equality and Women empowerment is all about giving women the power and control of their lives to become anything they want and to do what they want in situations. It refers to the creation of an environment for women where they can make decisions of their own for their personal benefits as well as for the society. Women empowerment is a term that is used to encourage, inspire and celebrate the strides that women and girls have taken in terms of gender equality, financial independence and self-confidence.

### 4. The Practice:

Many initiatives have been taken for gender equality and women empowerment as part of extracurricular activities in the Institution under.

- The college is conducting awareness sessions on gender-based discrimination, harassment, and violence.
- Providing counseling and support services to female students facing any form of discrimination or harassment.
- Organizing skill development and career-oriented workshops and seminars for female students.
- Creating a women-friendly environment in the campus, 24 hours CCTV Vigilance in college campus, parking spaces, and hostels for female students.

**5. Evidence of Success:** After a thorough discussion about the relevance and advantages of the programs related to health and hygiene, self-defence and legal rights of women, it was observed by the conveners of various cells like Women Cell, NSS/YDC/ RANGRING and Anti Sexual Harassment Cell that the execution of such awareness programs invested the girl students with a sense of self confidence and moral courage to face the challenges of life. It was also observed by the female staff members that a considerable number of girls felt inspired and benefitted by the information about health and hygiene which they received through these programs and enthusiastically adopted the requisite health measures suggested. The number of students has increased participating in decision-making processes and extracurricular activities within the institution.

### 6. Problems Encountered and Resources Required:

- One of the issues was to make the girl students believe in the successful execution of their rights, despite all their legal awareness, in a social setup still governed by the orthodox conventions of patriarchal psyche.
- Some of the girl students revealed that in their social setup women are still not granted the right of exercising their freedom of thought and action to take important decisions for themselves and their families.

- **Green Campus Initiatives-** Our institution adopts green campus initiatives as best practice so that we can protect flora biodiversity. it also helps to create healthy ecosystem So that many birds' species also flourished here. Many plantation activities, rallies and lectures were organized to protect and promote biodiversity.
- Institution is primarily eco-friendly and rich in biodiversity. Trees form huge canopy giving shelter to various birds especially the cuckoo, eagle, parrot, sparrow. Twig snake, egg eater snake, bush snake, brown snake and other species of snake are seen moving around sometimes among the bushes and shrubs. The brown has been spotted hunting squirrels. The Indian mongoose could also be seen on prowl for the brown.
- There are several trees in the campus which are rich source of fruits and berries.. These nutrient rich fruits are even relished by staff and students.
- The institution is located at the foothill of the Aravalli range. The fort is clearly visible from the institution giving the institution a picturesque view. Thus institute is preserving the bio-diversity.
