Sub: Monetary benefit of promotion under Career Advancement Scheme (CAS) for the Teachers including Librarians and PTIs in Universities, Government Colleges and Polytechnic Colleges.

It has been decided that teachers including librarians, PTIs/DPEs in Universities, Government Colleges and Polytechnic Colleges whose CAS was due on or after 01.01.2018 should be given cash benefit of CAS from the date of his/her eligibility as per respective CAS orders issued by the State Government under UGC/AICTE Regulations. Accordingly, Administrative Departments were required to amend or modify CAS orders and ensure compliance of announcement.

To ensure compliance of the said decision, the following is clarified and ordered:-

- 1. Incumbents whose CAS was due on or after 01.01.2018 shall be given cash benefit of CAS from the date of his/her eligibility. However, in the cases where incumbents had become eligible in all respect with reference to terms and conditions as laid down in UGC/AICTE Regulation for Career Advancement Scheme (CAS) prior to 01.01.2018 but screened on or after 01.01.2018, he/she shall be given cash benefit on promotion under CAS w.e.f. 01.01.2018 irrespective of Screening date.
- 2. The Internal Quality Assurance Cell (IQAC) shall be established in all Universities/Colleges as per the UGC/ National Assessment Accreditation Council (NAAC) guidelines with the Vice-Chancellor, as Chairperson (in the case of Universities), and Principal, as Chairperson (in case of Colleges). The IQAC shall act as the documentation and record-keeping Cell for the institution, including assistance in the development of Assessment Criteria and Methodology Proforma based on these Regulations.

These orders should supersede any others by Administrative Department or Universities.
