In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely:-


1. Short title and commencement.- (1) These rules may be called the Rajasthan Civil Services (Pension) (Amendment) Rules, 2022.

(2) They shall be deemed to have come into force with effect from 01-04-2022.

2. Amendment of rule 2.- In rule 2 of the Rajasthan Civil Services (Pension) Rules, 1996,-

- (i) for the existing expression "and posts in connection with the affairs of the Rajasthan State which are borne on pensionable establishments", the expression "and posts in connection with the affairs of the Rajasthan State including those Government servants who were appointed on or after 1st day of January, 2004 either they are in service or not on the date of commencement of the Rajasthan Civil Services (Pension) (Amendment) Rules, 2022 on fulfillment of conditions laid down by the State Government, which are borne on pensionable establishments" shall be substituted;
- (ii) in clause (e), for the existing punctuation mark ":", appearing at the end, the expression "; and" shall be substituted;
- (iii) in clause (f), for the existing expression "; and", the punctuation mark "." shall be substituted; and
- (iv) the existing clause (g) shall be deleted.

NOTIFICATION

In exercise of the powers conferred by proviso to Article 309 of the Constitution, the Governor of Rajasthan hereby makes the following rules to repeal the Rajasthan Civil Services (Contributory Pension) Rules, 2005, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Civil Services (Contributory Pension) (Repeal) Rules, 2022.

(2) They shall be deemed to have come into force with effect from 01-04-2022.

2. Repeal.- (1) The Rajasthan Civil Services (Contributory Pension) Rules, 2005 are hereby repealed:

Provided that the following Authorities or Agencies functioning for implementation of rules so repealed shall continue to function till the final settlement of claims under the rules so repealed, namely:-

- (i) Central Record Keeping Agency (CRA);
- (ii) Intermediary;
- (iii) Pension Fund Regulatory and Development Authority;
- (iv) Director, State Insurance and Provident Fund Department as Nodal Officer;
- (v) Point of Presence; and
- (vi) Various other agencies of the State Government.

Provided further that such repeal shall not affect the,-

- (i) Particulars of employees and nomination in State Insurance and Provident Fund database etc., for the purpose to make payment of New Pension Scheme, hereinafter referred to as the NPS, self subscription at the time of retirement / death;

- (ii) Maintenance of NPS account and database only for the purpose of settlement of NPS claims;
- (iii) Operation of the Finance Department notification number. F.12(8)FD/Rules/2008 Pt.III dated 12-10-2021 till settlement of all the issues pertaining to clause (i) and (ii) above,
- (iv) Orders / Memorandums / Circulars issued by the Finance Department, from time to time, in respect of the officers of All India Service and Officers on deputation from Central Government / Central Government autonomous bodies, other State Governments, autonomous bodies of other State for implementation of NPS, and

Provided also that,-


- (i) all the amount shall be deposited in the general revenue head of the State and the amount related to the individual NPS subscriber shall be returned in lump sum at the time of retirement to the NPS subscriber or to the nominee on the death of NPS subscriber, as per prevailing rate of General Provident Fund interest subject to the adjustment of amount of Rajasthan Pensioners Medical Fund / Rajasthan Government Health Scheme subscription of his / her service period. Any amount withdrawn from PRAN as NPS subscriber shall also be adjusted from his/her NPS self subscription amount. The contribution which has been deposited in PD account / bank account / budget head 8011 and unsettled shall be deposited in the general revenue head of the State. The State Insurance and Provident Fund Department will be the nodal department for maintaining individual account of every NPS subscriber and settlement of NPS self subscription amount at the time of retirement / death.
- (ii) the Government servants who were appointed on or after 01-01-2004 and they were not in service on 01-04-2022, they shall be eligible for pension as per provisions of the Rajasthan Civil Services (Pension) Rules, 1996 from the month of April 2022 subject to deposition of amount already received by them with prevailing General Provident Fund interest rate. No pension liability under old pension scheme shall be borne by the State Government upto 31-3-2022. The pensioner / family pensioner who are already getting pension under the Rajasthan Civil Services (Pension) Rules, 1996 being NPS subscriber shall continue to draw pension / family pension and for these pensioners, the Director, Pension and Pensioners' Welfare Department, Rajasthan shall issue new PPO / FPPO/ GPO / CPO after making revision and by adjusting amount already paid to them.

(2) The mention of the particular matters referred to in proviso to sub-rule (1) above shall not be held to prejudice or affect the general application of provisions of the Rajasthan General Clauses Act, 1955 (Act No. 8 of 1955) with regard to effect of repeal.

उक्त नियमों में किये गये संशोधनों के परिप्रेक्ष्य में समय समय पर जारी विभिन्न आदेशों / परिपत्रों / मेमोरण्डमों के प्रभावी / निरसित किये जाने के क्रम में राज्यपाल महोदय की अनुमति से निम्नानुसार आदेश जारी किये जाते हैं :

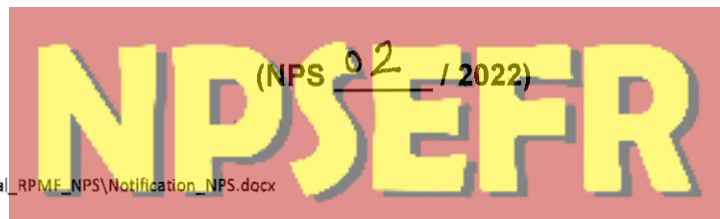

1. Short title and commencement.- (1) These Rules may be called the Rajasthan Civil Services (Medical Attendance) (Amendment) Rules, 2022.

(2) They shall come into force with immediate effect.

2. Amendment of rule 2.- In rule 2 of the Rajasthan Civil Services (Medical Attendance) Rules, 2013, hereinafter referred to as the said rules,-

(b) the existing sub-rule (3) shall be deleted.

"16. Supply of medicines through Pharma Stores.- Medicines prescribed by the authorized medical attendant shall be supplied by Pharma Stores as per the procedure laid down under the Rajasthan Government Health Scheme."

MEMORANDUM

Sub: Amendment in the Rajasthan Pensioners' Medical Concession Scheme, 2021

The Governor has been pleased to make the following amendments in the Rajasthan Pensioners' Medical Concession Scheme, 2021 to substitute the following existing Paras, namely:-

1. Amendment in para 3.- In para 3 of the said Scheme, following definitions shall be substituted / deleted, namely:-

- (i) In para 3 of the said Scheme, under the sub para (2) existing expression "and also includes retired judicial services officers governed under Rajasthan Judicial Officers (Medical Facility) Rules, 2008" shall be deleted and at the end of this sub para (2) the expression "The medical facilities to the retired judicial service officers shall be governed under Rajasthan Judicial officers (Medical Facility) Rules, 2008 till further order " shall be inserted.
- (ii) In para 3 of the said Scheme, under the sub para (3) the existing para shall be substituted by the following, namely :-
 - (3) "Family" shall be as defined under rules 3(9) of Rajasthan Civil Services (Medical Attendance) Rules, 2013.
- (iii) In para 3 of the said Scheme, under the sub para (4) the existing para shall be substituted by the following, namely :-
 - (4) "Pharma stores" means the medicine shops run by the CONFED/ Rajasthan Sahkari Upbhokta Sangh, Upbhokta wholesale Bhandar, Kraya Vikraya Sahkari Samiti, Jan Aushadhi Kendra or empanelled private medical stores under RGHS."
- (iv) In para 3 of the said Scheme, under the sub para (5) the existing para shall be deleted.

2. **Substitution of para 5.-** The existing para 5 of the said scheme shall be substituted by the following, namely:-

5. **Relaxation in Cost Ceiling :** For the extension of cost ceiling of drugs and medicines in case of out-door treatment above Rs 20,000/- per annum and tests charges above Rs 5,000/, the RGHS Card Holder pensioner shall apply online through RGHS portal. The relaxation in cost ceiling shall be decided by the following competent level :

S.No.	Competent Level	Extension limit of cost ceiling
1.	Director, State Insurance and Provident Fund	Upto Rs 2.00 lacs
2.	Administrative Department - Finance (Insurance) Department	Above Rs 2.00 lacs and upto Rs 5.00 lacs.
3.	Finance (Budget) Department	Above Rs 5.00 lacs and upto Rs 10.00 lacs.

3. **Amendment in para 6.-** In para 6 of the said Scheme, the existing expression "www.rghs.gov.in" shall be substituted by the expression "www.rghs.rajasthan.gov.in".

4. **Amendment in para 7.-** In the para 7 of the said scheme sub-para (2) shall be substituted by the following, namely:-

"(2) Claim of retired Judicial Officers shall be submitted as per their entitlement under Rajasthan Judicial Officers (Medical Facilities) Rules, 2008 till further order."

5. **Substitution of para 8.-** The existing para 8 of the said scheme shall be substituted by the following, namely:-

"8. **Reimbursement of medical claims in case of death of a pensioner :** The arrears of Medical Claim of a deceased pensioner may be paid to the heirs of the deceased without the production of the usual legal authority as per the relevant provisions of Rajasthan Civil Services (Pension) Rules, 1996 by submitting medical claims online on RGHS portal."

6. **Amendment in para 9.-** In para 9 of the said Scheme under, the existing expression under sub-para (2) "before 30-11-2021." shall be deleted.

7. **Amendment in para 10.-** In the existing para 10 of the said scheme, the expression under sub-para (1) "before 01-01-2004" shall be deleted.




The Governor has been pleased to make the following amendments in the Rajasthan Government Health Scheme to substitute the following existing paras, namely:-

1. Substitution of para 1.- The existing para 1 of the said scheme shall be substituted by the following, namely:-

"The Governor is pleased to introduce a Cashless Health Benefit Scheme hereinafter referred as Rajasthan Government Health Scheme (**RGHS**) to cover indoor medical treatment expenses, specified daycare procedures, outdoor treatment, investigations and medical attendance and treatment under Ayurveda, Homeopathy, Unani Chikitsa Paddhati and other treatment as specified or to be specified by State Government. The scheme will cover compulsorily the Ministers, All India Service Officers, MLAs & Ex-MLAs, Serving Government employees. The medical facilities to the retired judicial service officers shall be governed under Rajasthan Judicial officers (Medical Facility) Rules, 2008 till further order. This scheme will be applicable for the employees and pensioners of Autonomous Bodies, Boards, Corporations etc."

2. Substitution of para 2.- The existing para 2 of the said scheme shall be substituted by the following, namely:-

"2. The RGHS will cover all the medical facilities as per conditions and procedures laid down under the respective rules / schemes of different categories viz. (i) The Rajasthan Ministers (Medical Attendance) Rules, 1961 (ii) All India Services (Medical Attendance) Rules, 1954 (iii) The Rajasthan Legislative Assembly Members (Medical Facilities) Rules, 1964 (iv) Rajasthan Legislative Assembly Ex-Members and Family Pensioners (Medical Facilities) Rules, 2010 (v) Rajasthan Civil Services (Medical Attendance) Rules, 2013 (vi) Rajasthan State Pensioners' Medical Concession Scheme, 2021. The medical facilities to the retired judicial service officers shall be governed under Rajasthan Judicial officers (Medical Facility) Rules, 2008 till further order."

3. Substitution of para 3.- The existing para 3 of the said scheme shall be substituted by the following, namely:-

"3. For the employees and pensioners of Autonomous Bodies, Boards, Corporations etc. who have opted for RGHS will be allowed for treatment as per their option given under RGHS."

4. Amendment in para 4.- In para 4 of the said Scheme, the existing expression "rghs.gov.in" shall be substituted by the expression "www.rghs.rajasthan.gov.in".

5. Substitution of para 7.- The existing para 7 of the said scheme shall be substituted by the following, namely:-

"7. Enrollment of beneficiaries under this scheme will start from 10-4-2021 and will be on going process"

6. Substitution of para 8.- The existing para 8 of the said scheme shall be substituted by the following, namely:-

"The online registration facility for all the categories will be available on RGHS website www.rghs.rajasthan.gov.in along with the procedure to fill such forms. Every persons of above mentioned category will be notified regarding enrollment with Unique RGHS Card Numbers."

7. Amendment in para 9.- In para 9 of the said Scheme, the existing expression "www.rghs.gov.in" shall be substituted by the expression "www.rghs.rajasthan.gov.in" and the existing expression "The procedure and terms and conditions for e-pharma stores will be decided in due course" shall be deleted.


