# **1. EXECUTIVE SUMMARY**

## **1.1 INTRODUCTION**

Established in 1964 and affiliated to Raj Rishi Bhartrihari Matsya University, Alwar, G.D. Government College for Women, Alwar is one of the best women's colleges of Mewat region of Rajasthan. The college was started by the government of Rajasthan with a vision to provide access to quality education to young women at affordable cost. The institution has been striving incessantly for the qualitative enhancement of the women of the region and to make them globally competent.

The college is recognized under 2(f) and 12(B) of the UGC Act, 1956. It has undergone two cycles of accreditation, and was accredited with B Grade in the last cycle.

In its journey of 59 years, the college has made tremendous progress on all fronts of academics, sports and cocurriculars. This institution began with 135 students and there were 5083 students enrolled in 2021-22. The college is running UG, PG, Honours, and diploma courses.

The college has excellent infrastructure to run quality academic programmes. It has 42 spacious classrooms, 17 laboratories, one seminar hall, a girls' common room and a dedicated room for the Students' Union among other facilities. The institution also has a Gandhi Studies Centre established in 2021.

It is connected with WI-FI with 100mbps speed. ICT based methodologies have been adapted for teaching and learning. A Variety of activities through NSS, NCC, Placement Cell, Women's Cell, Entrepreneurship Cell and various committees are organized for the development of students. The college remains always ahead in participating in sports and cultural events at university, state, national and international level.

The additions in physical infrastructure, the fine tuning of teaching-learning activities with new learning paradigm, addition of innovative online learning modules, increased range of co-curricular/extra–curricular and extension activities, active students' participation, harmonized inclusive growth oriented environment and online registration of Alumni Association are among the key features of college functioning during last five years.

The College IQAC has been functioning as a catalyst for quality sustenance and enhancement. The campus is environmentally conscious and undertakes the green practices and conservation of the natural resources as its priority.

#### Vision

The college is committed to impart quality education to our students and to prepare them comprehensively for their career and future life. The vision of college is to develop core competence among women, especially from rural background and prepare them for various career options as well as to empower and sensitize them about gender issues. The vision of G.D Government College for Women, Alwar is to develop visionary, innovative and socially conscious human resource for India.

- To empower weaker sections of society through education and to make them understand the value of education not only for its informative and knowledge-rendering role but as something that will assist them in realizing their dreams.

- To inculcate discipline, importance of brotherhood and sense of responsibility towards nation building.

## **1.2 Strength, Weakness, Opportunity and Challenges(SWOC)**

#### **Institutional Strength**

- Institute's rich legacy in the field of women education. Being a 58-year-old institution dedicated to girls' education, the college enjoys a reputation of esteem and prestige in the district. As against 2000 seats in the first year we receive as many as 5000 applications from students aspiring for admission in this college.
- Centrally located and well connected to different parts of the city. Good connectivity to rural areas around Alwar.
- Good infrastructural facilities with large number of class rooms and laboratories. The college is located in a sprawling area of 7.49 acres at the heart of Alwar city.
- Fee concessions to students and financial aid to socially and economically weaker section students as per government norms.
- Powerbackupsupport with two ....... generators, UPS with aggregated capacity of ...... for different laboratories, administrative block and library.
- The college has already gone through two cycles of NAAC inspections.
- It is a RUSA beneficiary and has received grant of Rs. 2 crores initially.
- The academic environment in the college is entirely student centric.
- Highly qualified, experienced, and dedicated faculty ensures that students get benefitted from their academic resources and knowledge.
- Research and activity based pedagogical techniques are at the centre of the teaching- learning process.
- The infrastructure in the college supports the requirements of different departments and is regularly replenished with changing demands.
- The college draws a huge number of students from nearby rural areas that require safe and economical accommodation in the city. The hostel facility on the college campus caters to this need of the students. Admission to the hostel is done strictly on a merit basis in accordance with the rules and policies of the state government. The hostel has a capacity to cater to 186 girls.

#### **Institutional Weakness**

- The policies are determined by the state government and implemented through Commissionerate College Education which hardly leaves any space for autonomy to the institution.
- Limited collaboration with industry.
- The college understands its limitation in its care for the differently-abled via structured programmes.
- The college acknowledges that having a well-organized research cell is in its nascent stage; securing of research patents is yet to happen. Faculty members who have been publishing in self-acclaimed journals are now turning over a new leaf and are now in the process of publishing their work in journals having PubMed, Web of Science, Scopus and ICI.
- Paucity of consultancy and faculty and the student exchange programs between other institutions.
- Limited provisions and platforms for corporate training in Alwar because the industrial areas are located very far away. Limited provisions for corporate etiquette, soft skills, and communication skills training.
- Insufficient incubation and start-ups because there are very few institutions offering vocational courses.
- Lack of structured entrepreneurship promotional activities
- Facility of Incubation Centre is not available.
- Limited placement services.
- Participation of alumnae in the overall development of the college is less.
- Limited number of National and International Conferences, Workshops, etc. being conducted in the institution.

#### **Institutional Opportunity**

- The college has sufficient infrastructure, human resources (teaching and non-teaching) and sufficient academic programmes to claim for 'College with Potential for Excellence' status by UGC. There are also myriad opportunities to introduce new specialized courses along with already existing programs.
- Skill development activities can be given an impetus by introducing them in the syllabus.
- Use of knowledge and resources for development of e-content and e-resources. The college recognizes the need for the establishment of online courses, video/web-conferencing, to bridge the cultural and geographical gap of rural students and avail the best brains available in every field.
- Incubations and start-ups can be approached.
- Professional development programs and trainings for teaching and non-teaching staff need to be introduced with the latest changes in the administration.
- Enhancing employability opportunities.
- Encouraging industry collaboration and consultancy through Placement Cell.
- Providing special facilities, guidance, and counselling to slow-learners hailing from remote rural areas of the district.
- Exploring possibilities in MSME sector.
- Organizing placement drives to fulfil the gap between available workforce and employers.

#### **Institutional Challenge**

- Being an all women college inviting participation of alumnae towards overall development of the college
- The delay in the approval of research supervisors, and processing of research-related activities by the

affiliating University has been a cause of serious concern as it has discouraged and brought down Ph.D. enrolments.

- Teaching and Non-teaching ratio falls short in proportion to workload and student strength. The process of recruitment by the government is very lengthy and takes months, even years before new faculty is recruited.
- Financial constraints because the institution is totally dependent on government grants.
- Creating sufficient job opportunities for students.
- Availability of water for multipurpose usage has emerged as a challenge during past few years.

## **1.3 CRITERIA WISE SUMMARY**

#### **Curricular Aspects**

The college is affiliated to Raj Rishi Bhartrihari Matsya University, Alwar and the curricular aspects are aligned in accordance with the guidelines and framework of the university. The academic system is designed & developed to encourage participative, collaborative & experiential learning.

The programme and course outcome, displayed on the institutional website, define the learning level of the students in terms of knowledge, skills, values and capabilities. The college seeks to enhance students' behavioural, leadership and teamwork skills and also wants to sensitize them towards gender and environmental issues through various activities. The course content has been divided into units to structure and streamline the process of learning. The pedagogy includes use of ICT tools, intra-class seminars, assignments, projects, presentations, tests and group discussions. To make the learning more productive and socially sensitive, opportunities are provided to the students to establish partnership with communities through NSS, NCC, Ranger and Rovers, and various committees where students learn life skills, employability skills, develop competency and socially responsible behaviour. The curriculum offers space for integrating cross-cutting issues relevant to gender, environment and sustainability, human values and professional ethics.

The syllabi of these courses are designed by the university with a view to add skills and enhance employability of the students. The college encourages field trips to give the students a taste of real work environment. The presence of faculty members in committees of syllabi-designing, Board of Studies, and Academic Council benefits the college by providing us with an opportunity to have a role in the process of revision of syllabi and other academic decisions.

The college follows affiliating university syllabi; hence the programmes follow the elective pattern for all the courses. The core courses are intended to impart basic language and computer skills to the students. An enviable range of subjects are offered in all the three streams of arts, commerce, and science at UG level and 4 subjects at PG level. Around 23 different kinds of elective combinations are offered to the students of humanities. Ph.D. supervisors in different subjects in humanities and science streams are available to facilitate doctoral degree.

#### **Teaching-learning and Evaluation**

The process of admission and promotion to the next class is online in accordance with the policies of Government of Rajasthan. There is special provision for admission of students who are especially-abled, belong to deprived sections or with noteworthy achievements. Since this is an all-women college, students are

exempted from the tuition fee to promote gender equity by providing better opportunities for girl students. To make teaching, learning and evaluation effective and efficient, various processes have been developed which give freedom and flexibility to the faculty and the students to achieve their full potential. Study tours and project works play significant role in enriching the learning experience of the students. The college has a Mentor-Mentee System where each faculty member acts as a Mentor for a group of Mentees to address academic and various issues.

The faculty is devoted and rich in experience. Though the method of teaching is largely conventional, the process of participative learning and problem-solving approach is still duly adopted. The medium of instruction is bi-lingual as per the local needs. Many faculty members use ICT tools and every effort is made to develop the interest of the students in the subject. Since its inception, the college has remained committed to dissemination of knowledge and empower women to contribute to the development of society. The quality of education is constantly monitored and the standards of teaching-learning are reviewed and maintained thereby, enriching teaching-learning processes and developing skills in tune with the globalized world.

The college conducts orientation programme for new students. Time table and annual academic calendar is are made available through college website. To make the ICT enabled classroom sessions interesting and productive, the faculty adapts techniques of deliberations, discussions, use of LCD, and Power Point Presentations. Internal Assessment is made on the basis of the performance in home assignments, unit tests, attendance, and participation in GD and co-curricular activities. Follow up sessions for students and Parent-Teacher Meetings are also platforms available to the college to address students' problem. The Academic Section of the college maintains the record of every student and examination results are published online.

#### **Research, Innovations and Extension**

A proper culture of research and academic enhancement is imperative for any institution of higher education. Nurturing the ambience of research proves the worth of an institution of higher education as it paves the way of producing future scholars and scientists of the nation. Hence, the college aims to inculcate a flair for innovation and research among our students. 20 faculty members are approved as research supervisors of RRBMU and other universities in Rajasthan. The research efforts of the faculty members are evident from the publications, number of research students/scholars enrolled under them, and academic achievements like authoring books, chapters in book, accomplishment of research projects and participation in international and national conferences.

The Institute organized workshops/seminars on Research Methodology, Intellectual Property Rights and entrepreneurship to develop aptitude of entrepreneurship among the students. The required research facilities are available in the science labs, and it is periodically augmented with, whatever little financial resources made available to the college by the State Government, by adding newer gadgets and apparatuses. Workshops and webinars are organized to create a research environment for innovative ideas.

To meet the emerging academic and research needs, faculty enrichment programmes, seminars, symposiums, guest lectures and workshops are regularly organized. Field tours, visits of industrial units and research laboratories, excursions are also organized for students to imbibe the aptitude for research.

The Institute has received grants for minor research projects funded by UGC, and for post-doctoral fellowship from UGC and Indian Council of Social Science Research. The library provides a host of books, journals,

magazines and other publications. The e-resources comprise of N-List, NPTEL, and Research database

The Institute believes in sensitizing its students towards social and environmental issues. Every year the college organizes numerous extension and outreach programmes under the aegis of NSS, NCC, and Scouts. On many occasions, celebrations of days and events are carried out, in tandem with district administration, health department, ICDS, Nehru Yuva Kendra, Judiciary and RTO like agencies/ departments.

#### Infrastructure and Learning Resources

The college has its own land holding of 30350 sq. meters out of which approximately 23646 sq. meters is constructed area. The campus is situated at the heart of the city making it convenient for students to commute on a daily basis.

There are 43 classrooms out of which ..... are ICT enabled, 7 Smart class rooms and one ICT based seminar hall. There are 17 laboratories. All laboratories are equipped with ICT facilities. There are ..... computers out of which ...... are used for academic purpose. The Institute is self-reliant in its use of power through solar panels. The campus is equipped with WI-FI facility having 34 MBPS internet connectivity via lease line. The college also has a video conferencing room used for virtual meetings with other institutions. There are 20 CCTV cameras installed in the campus for students' safety.

There is one central library on the campus and four departmental libraries of the PG departments. There are 54828 books, Journals, Periodicals and Magazines, and 5 Newspapers in the library. It has rich collection of e-books and e-Journals through N-List programme of INFLIBNET, collection of rare books, on-line Newspapers, Periodicals, Encyclopaedia, NPTEL, and National Library of India etc. links created on college OPAC. The library is fully automated with Alice Software with latest versions. It has a rich book bank and also a community book bank maintained by faculty members.

The college has rich facilities for indoor and outdoor games. The Sports Complex is having gymnasium with sophisticated equipments, Table-Tennis and Badminton courts. The games available are: Volley Ball, Kho-Kho, Badminton, Hand Ball, Boxing, Hockey, Kabaddi, Judo, Wushu, Wrestling, Shooting, Taekwondo, Basketball, Table-Tennis, Athletics, Chess, Yoga and Meditation. The college collaborates with other institutes to provide training and coaching in sports for which it lacks infrastructural support. Hostel facility for women with a capacity for 186 students, canteen, girls' common room, botanical garden are on campus. One electronic kiosk has been installed in the college by e-Mitra Society of Rajasthan Government for providing various student-centric facilities.

#### **Student Support and Progression**

The college facilitates the scholarships provided by the Government of Rajasthan, Central Government and other agencies. The students belonging to reserve categories receive scholarships under various schemes. Tuition fee is exempted for girl students and students belonging to scheduled/reserved categories.

The Competitive Examination Coaching Cell, Placement Cell, Entrepreneurship Cell, Mentor-Mentee System, Environment Committee, and the Subject Associations are functional in the college to enhance the latent potential of the students.

At the time of admission a help-desk is created to provide all kinds of support and information related to the admission process. In addition, other committees like Student Grievance Redressal Committee, Anti-ragging Committee and Women's Cell are also at work to address any kind of issues or other problems.

To provide exposure for career choices and personality development various lectures by eminent resource persons, workshops on socially relevant topics, field trips, educational and industrial tours are organized. Camps organized by NCC, NSS, Scouts are also intended for personality development and sensitization. Literary and cultural activities organized by respective committees provide platform for pursuing and polishing creative skills and talents of students.

Besides, Gymnasium, Yoga and Meditation Centre, Library with online resources and other infrastructure requirement are provided for the smooth conduct of the curricular and co-curricular activities. The Language Lab equipped with Sanako software, allows students to practice language exercises for enhancing their communication skills with a variety of activities.

For active involvement of students and for their regular participation in governance, student representatives are elected through Students' Union Election organized as per government norms.

The college annually organizes Nupur: Annual Cultural Meet and Sports tournaments. For differently abled students scribes and other necessary amenities have been provided.

The Alumni Association of the college has been formed so that it can contribute for students' welfare.

#### Governance, Leadership and Management

The Vision, Mission, and Objectives of the institution reflect the nature of governance and decision-making bodies of the institution.

The major policy decisions of the college are taken at the level of the Department of College Education, Government of Rajasthan. The Principal is the head of the institution and is responsible for the activities of college. Still, as far as decentralization of responsibilities and participation of management is concerned, there are multiple need-based committees at college level to accomplish the routine work, institutional quality assurance and vision-based goals of college. All committees take their decisions through participation of all members which are further executed with the approval of the principal.

It is also worth mentioning that the module of e-governance has been implemented effectively in all areas like administration, accounts, finance, student support, planning and execution. All notifications from Directorate of Collegiate Education, Jaipur, and RRBM University are in e-mode.

Many of the decisions of infrastructural development and novel practices are also taken by College Development Committee. The College Development Committee (that also works as planning board of college) is registered under Rajasthan Society Act, and is comprised of senior faculty members, representatives of District Administration and Commissionerate, College Education Jaipur, elected public representatives like MLA, MP and members from alumni association or persons of social prestige.

Feedback of all the stakeholders like members of College Development Committee, Student Council, parents, or alumni that is received in the form of memorandums, meetings, interactions etc. are periodically taken into

consideration and the strategic plan of action for development of college is formed and executed accordingly.

The college ensures the following:

- Management of finance as per rules and regulations set by the Directorate of Collegiate Education.
- Internal and external auditing of accounts
- Frequent meetings of HODs and the Staff Council to generate short term and long term plans

The College provides welfare measures for the faculty and the supporting staff. The college IQAC has been ensuring the internalisation of quality culture in all the system processes.

#### **Institutional Values and Best Practices**

Institutional values and best practices have been adopted keeping in view the vision and mission of the college.

A few practices are listed as following:

- Admission process is online, transparent and student friendly.
- Solar panel, waste management and water harvesting system are maintained for keeping the campus environment-friendly.
- The entire campus is dotted with greenery and the plants / trees have been labelled with botanical names. The college staff plants trees in the campus at their own expense.
- Establishment of smart classes, Wi-Fi campus, CCTV cameras for safety of students is worthmentioning.
- The digitized library process and facility of e-library is operational.
- Extensive cultural and co-curricular activities to nurture creative talent are made available.
- Community Book Bank, with the help of "Donate a Book" scheme, is created.
- Skill development workshops are organized during summer break.
- Faculty Development Programs organized by Department of College Education have been attended by the teaching staff in their respective subject through a scheme, called 'Gyanganga'.
- Transparent, student-friendly and ragging-free, harmonious, academic and administrative atmosphere enable better learning prospects.
- Community reach-out through various activities of NSS, NCC, Rover & Ranger is done in every academic year.
- Tobacco-free campus and no-smoking in the campus is emphasized.
- Sensitization programs related to social issues, community, and humanitarian work is taken up regularly.
- Rain water harvesting units are there in the college. Students are provided awareness about water conservation techniques and ground water recharge.
- Gradually the electrical appliances are being replaced with energy efficient equipment and LED tube lights.

College regularly conducts social awareness activities like organizing programs on Voter Awareness Campaign, Swachh Bharat Abhiyan, Health and Hygiene, Blood Donation Camps, Tree Plantation, etc. Various commemorative days are celebrated in the college.

The college adopts two best practices: Unnayan – a skill development initiative, and Environmental Awareness.

The main thrust of the college is on providing excellent education which is demonstrated through the results, and to instil in our students a strong sense of social responsibility and sensitize them towards various social issues.

#### Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:	The institution is a hub of multidisciplinarity having 21 departments in all. The faculties of Humanities, Science and Commerce have subjects that are interdisciplinary having significant inputs from other disciplines. Subjects in Humanities like Sociology, Geography borrow important techniques from Statistics. GPEM not just includes types of fabrics, garments, weaves and dyes but also process of production and export management. It has inputs from the disciplines of commerce and management. Cell biology, genetics, ecology, polymers, biochemistry are topics that cut across disciplines like Botany, Zoology and Chemistry. Input on animal behaviour combines disciplines of Zoology and Psychology whereas Law, Economics and engineering form an integral part of the syllabus of Psychology. Environmental education forms a part of the curriculum of graduate programs in subjects like Sociology, Botany, Zoology, Geography. Students pursuing graduation are supposed to qualify 'Environmental Science' along with language papers. This assists in providing a holistic multidisciplinary education to the students. Learners from any stream may pursue Postgraduate course in Humanities. English literature combines Oriya, Hindi, Tamil, Sanskrit writers in translation whereas Sanskrit literature has Aristotle, Plato and Socrates as part of syllabus.
2. Academic bank of credits (ABC):	The college is affiliated to Raj Rishi Bhartrihari Matsya University, Alwar. The Matsya University Act, 2012 No. 29, vests the power to hold examinations and confer degrees for various programs, in the affiliated colleges, to the University itself. The university has not yet implemented the ABC system. the Academic Bank of Credits as proposed in NEP 2020, is presently being worked upon by our University and will be implemented there-on in all affiliated Colleges, including ours.
3. Skill development:	The institute has an active ' Placement and Entrepreneurship Cell' which organises camps and lectures enabling the students to develop skills that will help them in securing livelihood in their field of interest. It organises various vocational and soft-skill training camps and summer camps under the aegis of

	CCE, Rajasthan. Services of experts in various fields are solicited on blended platforms and hand-on training is provided by means of field-trips. Besides, various departments work towards enhancement of skills related to their subjects that might prepare learners to become constructive citizens. Annual workshop on fashion designing, and syllabi input on food preservation, home management, English language skills, horticulture, apiculture, sericulture, lac culture, poultry farming, pearl culture provide ample exposure to students for related skills.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	The college follows the syllabus prescribed by the affiliating university. Teaching is done mostly through Hindi medium except in subjects like English literature. But even there are Indian writers in English and Indian regional writers translated into English are taught to incorporate Indian ethos. Indian economic thinkers, indian political thinkers, sociologists are taught as an integral part of the syllabi. Indian weaves, textiles, patterns and designs are taught as part of GPEM syllabus and Indian foods and customs are there in the syllabus of Home Science department. Ayurvedic medicinal value of plants and their use in day-to-day well being is taught as a separate paper of Botany. Ancient Indian philosophical thought is taught as part of the syllabus of Philosophy. We have graduate, post graduate courses as well as doctoral supervision in Sanskrit. Ancient Sanskrit literature, Vaidik literature is an integral part of the UG and PG courses offered in Sanskrit.
5. Focus on Outcome based education (OBE):	Objectives of every course are well defined by the university, and college follows the same. Summative assessment is conducted by the university to assess the achievement of stated objectives. However, formative assessment is taken care of by teachers of the college, and is focused on assessing students' progress with the objectives. Interactive activities, games, puzzles, practical work, field trips and small projects are part of formative assessment.
6. Distance education/online education:	Keeping in mind the changing dynamics of teaching and learning in the post-pandemic world, the college has tried to keep pace with the same. The teachers have been involved in hybrid (online-offline) mode of teaching, disseminating knowledge and curriculum through YouTube videos, PDF notes, e-books, and

	other social media resources. All the teachers have their YouTube channels that help them to be connected with their students even when being at distant locations. Besides some teachers also maintain their educational blogs to provide notes and discussion prompts to students. These have been preserved in a repository named Rajiv Gandhi E- content bank and are available on the institutional website. Teachers have contributed videos for Gyandoot channels being facilitated by the Commissionerate for the benefit of students.

#### **1.1 Curricular Planning and Implementation**

#### 1.1.1

The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

#### **Response:**

The Institution has an effective mechanism for well-planned curriculum and documentation. It implements the process of completion of curriculum within the stipulated time to attain the programme outcomes effectively. To complete the curriculum completion in time, the college follows an academic calendar very meticulously uploaded on the website of DCE before the academic year commences. Accordingly, the college prepares a unified timetable for PG (Hindi, Political Science, Psychology, Sanskrit) and UG in every section of all the classes separately for each faculty that is, Arts, Commerce and Science. The teaching plan is prepared in each department by every faculty member under the supervision of the concerned Head & In-charge of the department. The Institution has a 56 years old heritage of dedicated teaching and 58 highly qualified teachers. All the teachers are advised to follow a well-structured teaching strategy to achieve optimum learning outcomes which is measured through the assessment process. Some measures that are adopted to ensure the effective delivery of the curriculum are as follows:

Lectures: The conventional method of teaching is complemented with the latest technology like smart boards and e-learning, power point presentations, animations, show of documentary movies using LCD Projectors which enhances the students' interest towards studies and guided for references to additional eresources like NPTEL-Swayam, e-PG Pathshala, etc.

Practical sessions and lab activities: Practical classes are conducted as per the syllabi of the university. Lab experiments go on to become core papers in the subject.

Learner-centric Teaching Methodology: Apart from conventional lecture method in classes, certain other styles are also employed to impart knowledge. In subjects like Economics, English, Hindi, History, Political Science, Sanskrit, Sociology, A.B.S.T., E.A.F.M. and Business Administration and Mathematics, other style of teaching such as group discussions, educational games, role play, online quizzes, blogs are also used by concerned faculty members for their classes.

Extension Lectures: Guests lectures are organized by the departments to broaden the concept of the subject among the students.

Exposure to the research avenues: Students who are in PG classes are taken to visit research institutions to encourage them for research. Whenever eminent scholars of specific subjects are invited by the department the students get a chance to interact with them.

E-contents like lecture-videos, blogs, are prepared by faculty members. Lecture videos are uploaded on

their respective YouTube channels. Similarly, the faculty members prepare power point presentations and scan their written notes and the links of the same are shared on the virtual groups of class students along with other study material and notes. Students in subjects like Botany also learn from virtual Biotechnology laboratory visits.

Contemporary Pedagogical tools and techniques like the use of ICT gadgets as smart boards, OHP, transparency and classroom quiz, interactive sessions are made by teachers to teach the topics with its prospective scope and application.

#### **1.3 Curriculum Enrichment**

#### 1.3.1

Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability in transacting the Curriculum

#### **Response:**

**Professional Ethics** - The courses offered in the humanities relate to imbibing the concepts of transparency, honesty, accountability, respect, hard work, confidentiality, constitutional values and professional ethics. Subjects like Business Administration, Economics, English/Hindi/Sanskrit Literature, Geography, History, Political Science, Home-Science and Sociology go on to cover the elements of professional ethics. The students in the faculties of Commerce, Science, and Humanities are exposed to learning the latest research findings. Besides, the activities of NSS, NCC, and Women's cell endeavor to take care to inculcate the idea of gender equity, equality and social responsibility among students. In addition, Entrepreneurship Cell and Placement Cell organize programs that provide exposure to students about professional ethics among other things.

**Gender-** Sensitization towards gender issues is one of the thrust areas of the working of Women's Cell. Women rights and women's contribution to society are part of the curriculum in subjects like History, Political Science, Literature, and Sociology. Women scientists' contribution in the field of scientific research is included in the curriculum of science subjects. Writings of women authors are included in the courses of English, Hindi, and Sanskrit literature.

**Human Values-** Basic human values like truth, love, loyalty, honesty, peace, compassion, empathy are considered necessary qualities of good human beings. All the courses on literature and languages include human values. Even courses in Commerce and Science faculty take care to develop a sense of responsibility that should be there in every citizen of the nation. Similarly, in Humanities, the papers of Economics, Political Science and Sociology, History touch upon fundamental rights and basic human values.

**Environment and Sustainability-** Environmental studies are an integral part of natural science like Botany, Zoology. At least one paper is based on ecology and environment. Geography and other subjects of Humanities also incorporate chapters on environment. There is a compulsory paper for all students in the first year of undergraduate classes. The paper is specially designed to impart awareness towards environment and sustainability.

Aanandam:- The Pandemic was not producing happy youths. According to this comprehensive

education is required. Therefore, 'Anandam' subject was introduced as a compulsory subject in higher and technical education curriculum. Anandam incentivizes college students to contribute to society and earn academic credits in return. In Rajasthan community service for students in higher education institutions attribute to the inculcation of values such as "Joy of Giving". This program was also associated with an increase in the Happiness index of students. Anandam nurtured leadership qualities in our youth by connecting them with society and its problems. It also made young people more compassionate and empowering, and reintroduced the purpose of education in the long run towards true enjoyment.

#### **Response:**

ICT is an integral part of teaching-learning activities in the college and the tech-friendly teachers make optimum use of ICT infrastructure for making their teaching effective, interesting, and resourceful. The

teachers teach students through informative PPTs and other audio-visual material. Not only this, but they also encourage students to present their assignments and seminars through PPTs. The movies and documentaries related to syllabi are shown to students of English literature followed by incisively involved discussions about different aspects of the text. There are smart classrooms with interactive boards, a seminar hall with a good sound system in the college. Besides this, for the ready availability of ICT tools, there is enough number of projectors which makes it handy for the teachers to teach classes though PPTs. Basic computer education is compulsory for all students. A well- equipped computer lab is maintained for this purpose. The English Language Lab becomes handy in teaching students basics of language skills, pronunciation, and other linguistic aspects. There is a well - equipped E-Resource Centre attached to the college library having the support of leased line connection for good internet speed, and ready access of internet facilities. The teachers and students have easy access to ICT facilities, and they can use them for academic and research purposes. Not only this, almost all the departments are equipped with computers and printers for preparing for teaching and other duties. The teachers are making good use of college website to inform students about studies, learning outcomes and others relevant information. During recent COVID-19 lockdown period, the teachers were well connected with their students through different digital mediums - You-Tube channels and Whatsapp groups. There is constant updating of the ICT facility and new evolving initiatives are also added over a period. The learning platforms such as Shodh-Ganga, Gyan-Sudha and Gyan Doot are made available under progressive guidance and necessary support of the Commissionerate of College Education, Rajasthan.

#### **2.5 Evaluation Process and Reforms**

#### 2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

#### **Response:**

The institution is affiliated to the RRBM University, Alwar and follows the summative assessment pattern suggested by the university. It has designed it's assessment through year-end examination system. Courses of the university are defined highlighting their objectives and significance which enables the students to understand and plan their methods of learning. Those subjects which have practical assignments as part of their curriculum have both internal and external systems of assessment. For practical subjects students are required to submit a record of the practical assignments completed by them throughout the year.

Though the institution does not have any formal or robust internal assessment system yet the faculty members do plan the internal/formative assessment in a way so as to encourage students to work independently and individually, by researching on the given topics. Evaluation and marking are done by the respective class teachers who communicate about the same to the students.

The dates of practical assessments are displayed on the College Notice Board, at least 15 days prior to the actual date of final examination. The students are, also, informed through news items in the local Hindi newspaper. External/ University Examination, All the examination related news and circulars are posted on University Website. In fact, under the Students' Corner tab on the University Website there is a separate link for examinations.

Examination forms and admit-cards of Term End Examinations are submitted and generated online. As soon as the University Examination timetable is announced online, the same is displayed on Students' Notice Board for ready reference. Moreover, the same information is also sent for publication as news items in local Hindi Newspapers. Soon after the college receives the mark-sheets from the University, it immediately arranges a proper system for its distribution to the students. Any discrepancy in the mark sheet, like spelling mistake, absent/present in the paper, RL case etc. are, in no time, forwarded to the University for its rectification. Unfair Means (UM) cases in exams are forwarded by the College to the University where final decision about the case is taken by concerned committee. Student Helpline numbers are provided for any kind of examination related issues or any other query.

Students have an option of re-evaluation if they are not satisfied with the marks awarded in university examination. Unsuccessful students in the final year of UG/PG degree courses are given a chance to appear in Supplementary Examinations which are generally held in September-October in the same year. In addition, Students are, also, given a chance to improve their marks in 50% papers of previous year examination if they want to. ### **Response:**

Being a fifty-eight-year-old institution, the college has adequate infrastructure to facilitate teaching and learning. The campus is sprawled across 7.5 acres with approximately 23646 square meters of construction in all.

The campus comprises the main building, the library, principal's residence, hostel, gymnasium, games and sports field and a well-spaced cafeteria, girls' common room, and one common staffroom for the staff. The college has a girls' hostel also which can accommodate 186 girls.

The institution makes optimal use of buildings and ensures sufficient space for all departments and common facilities. Solar Plant of 50 kw provides the college with ample electricity. The college has its own bore well, a underground water tank with a capacity of five lakhs liters, 13 overhead water tanks and dedicated pipelines of fresh water supply from PHED. Most of the students use a bicycle as a mode of transport to the college. Campus has a two-wheeler parking stand as well as independent car parking for faculty members. To combat power cut situations, the institute possesses 03 generators each of 15 KW capacity lodged in the main building. Two biometric machines are placed for regular attendance of faculty and office staff members.

- The institution has 43 well- ventilated spacious classrooms with podiums and seating capacity for more than 80 students each with a total capacity to accommodate 3000 students at a time and 14 laboratories of various subjects including English language lab, Botany, Zoology, Physics, Chemistry, Geography, Home Science, GPEM, and Psychology labs. It has one seminar hall, 07 smart Labs as classrooms, one computer lab with 25 networked computers with internet/wi-fi and UPS backup facilities. All the departments are provided with computers and internet /wi-fi facility. The college maintains LCD projectors for special lectures.
- The College has adequate facilities for indoor games and outdoor games. The indoor games include chess, carrom, and table tennis while the outdoor games played are cricket, football, hockey, lawn tennis, basketball, volleyball, and kabaddi. There are four sports courts and a ground viz., Tennis court, Basketball court, Handball court and Badminton court. A separate Multipurpose Indoor Hall of size 60X40m approximately is used as a Gymnasium which is fully equipped, which is used as Yoga center also. There is a sports room housing the sports officer's office where sports articles and records pertaining to them are also kept.
- The Co-curricular activities like Debate, Elocution, Essay, Poster and Slogan, Painting

Competitions, Poetry recitations etc., take place in seminar /multipurpose hall (Room no.125). G. D college for women has its own heritage of the most popular "Nupur" cultural week in which more than 1000 students participate directly and indirectly. The college has one open-air stage for cultural activities like Classical (Solo & Group) songs, (Solo, Duet & Group) dances, Plays, Skits, Fancy Dress show, Mono acting shows etc.

### **Response:**

The college has one Central Library and all PG departments and few UG departments have small departmental Libraries. The College Library has a total seating capacity of 100 students. The library has 01 reading room, 01 reference room, 01 big hall for book stacks, 01 room for old books and book bank, 01 Inflibnet room, 01 classroom for library science students. Ours is the only government college in Rajasthan which is running a diploma in Library Science. 40 students are enrolled in this course every year. The college Library has about 54828 classified and indexed books. The whole Library is facilitated with wi-fi network and is partially automated. A separate fiber optical connection for the Internet is provided for the Inflibnet room with the bandwidth of 10 mpbs.

The library caters to the needs of the students, teachers, researchers, interested readers and others. The college offers good reading materials in the form of reference books and periodicals, encyclopedias, journals, magazines, newspapers etc. The library has been prepared with modern technological facilities. Library staff is available for the transaction of books and other reading material.

A 'Library Committee' comprising of college teachers is put in place to supervise the smooth functioning of the college library. To measure the usefulness of the library a Visitors' Register is maintained in the library. The committee advises the library staff regarding the improvements and updating process of library facilities. The procurement of textbooks and subscription of journals is done based on the advice given by the committee and the heads of departments.

? There are seven labs/ rooms with a smart board facility. These classrooms are used by UG departments for teaching, practical work displays and small workshops.

? The video conferencing room in the college is used for virtual meetings with the Commissionerate College Education and District Administration.

### LMS:

? Audio-Video tools, LCD projector in various departments. Smartboards in different departments. Computers with LAN connections in every department, E-Mitra plus machine. Personal laptops, Wi-Fi, (bandwidth with more than 34 MBPS/ GBPS), Digital visualizer etc. are some of the learning management systems used by the college.

### 6.1 Institutional Vision and Leadership

### 6.1.1

### **Response:**

The leadership and governance of the college is well reflected in its vision and mission. The vision, mission and objective of the institution is to nurture the educational endeavors of the state by imparting quality education effectively with an ethical impetus. Criteria of ideal citizenship, upliftment of the poor and the downtrodden by spreading the ideals of education, patriotism, civic sense, democratic values, social equality, humanitarianism are the prime objectives of the institution. Enlightenment, enrichment and the enhancement of the student as a human being is the mission of our college.

The institution strives to share the responsibility in nation building. An important component of college administration is Mentor – Mentee system, in which every faculty

member is to act as mentor to a particular section of class of students.

Strategy and planning for development –Mahavidyalaya Vikas Samiti is our planning board in action and the staff council is executive committee. College Development Committee is a big support and it helps in overall development it also steers and helps in the effective implementation of strategic planning by giving feedback and managing finance.

**Interaction with Stakeholders** – the principal ensure that all the stakeholders are involved in college activities. As students are the main stakeholders so they are treated as the pivotal centre of all the activities.

The college interacts with ex-students through Alumni Association. The college administration maintains a cordial relationship with the district administration and local police so that safety of the campus could be ensured.

### **Response:**

The college has an arrangement of bodies like IQAC, Mahavidyalaya Vikas Samiti, and Staff Council. For devising the need or vision based plan with financial, technical and manpower requisites, execution module and time-frame the draft proposal is discussed. Once the draft proposal is passed as a resolution, the next step is to realize the proposal on ground. To make it a reality, an implementation and monitoring committee is formed .

The progress of the Project is periodically inspected by RUSA nodal officers and Accounts officers from other Government colleges in the district also.

Entire grant was successfully utilized under different heads. The allocated budget under renovation & construction was used as planned under constant supervision of PMU member.

It is an apt case of successful deployment and execution of the Strategy to complete a renovation and

construction job in the college .The project succeeded in getting some urgently needed renovation work done and also achieved an addition of some more infrastructural facilities at the college.

Administrative setup at the college level: The College comes under the Commissionerate of college Education, Rajasthan headed by the commissioner, Higher Education. The college is headed by principal and the post of principal is filled on departmental promotion/ transfer basis by the Government of Rajasthan. Under the leadership of principal different committees are formed officially to deal with and carry out various responsibilities in the college.

- The senior-most faculty member of the college works in many capacities such as DDO, secretary of staff council, & Mahavidyalaya Vikas Samiti, IQAC, Legal cell etc. to deal with responsibility.
- Similarly, the other senior faculty members of college are entrusted with the responsibility for efficient functioning of institution.
- To provide administrative assistance to various In-charges and HOD, Administrative officer, Accounts officer, Assistants, Lab staff and peons etc. work under administrative control of the principal.
- AAO and accountant and cashier deal with the financial matters. Besides, some office staff is recruited on contractual basis via college Development Committee like the security guards, Gardeners, cleaners and sweepers, computer operator and PTI etc.
- The Administrative structure of CDC Comprises of principal, MP, M.L.A., Zila Pramukh, representative of the district collector, representative of Commissionerate College Education, two educationists and two learned citizens.
- IQAC was constituted in 2015 and it works for quality monitoring and enhancement through concerted efforts of its members and the management. The IQAC consists of principal, faculty members, two external members and AAO.

### Policies regarding appointment, service rules etc. :-

• The college is a Government institute and therefore it is mandatory to follow the rules, regulations, policies framed by the state government (RSR).

Appointment on Gazetted positions is done through selection process of RPSC. Major policy decisions like organizational set up, admission policy, budget for salaries, promotional avenues, financial regulations etc. **Grievance Redressal:** - The College has formed Internal Complaints Committee, Anti-ragging Cell, Grievances Redressal Cell and Anti Women- Harassment Committee & Rajasthan Sampark Portal to look into complaints and solve such issues. ### 6.3 Faculty Empowerment Strategies

### 6.3.1

The institution has performance appraisal system, effective welfare measures for teaching and non-teaching staff and avenues for career development/progression

### **Response:**

The employees at G.D. Government College for Women, Alwar are covered under all the benefits provided to government servants by the government of Rajasthan. Various welfare measures like provident fund contribution, insurance coverage, pension benefits, gratuity benefits, medical facilities to employees and their family members, provision of compassionate appointment to dependent family member of deceased government employee are extended to all the employees at the college. The college implements all the welfare schemes of the state government and also tries to facilitate the same through various effective welfare measures. The compulsory deductions for future security are GPF/NPS and SI. In addition, annual group insurance is also deducted. Medical claims are reimbursed by the state government as part of the health expenses incurred by the employee. The government of Rajasthan has recently launched the Rajasthan Government Health Scheme in order to provide medical facilities to the state government employees and pensioners.

### Types of Leave for Teaching Staff -

PL - 15 Privilege Leave earned after completion of every calendar year.

HPL - 20 Half-pay leaves after completion of the year can be commuted on medical grounds.

CL - 15 Casual Leaves in one academic session.

AL – 15 Academic Leave in a session for seminars, conferences and academic purposes.

#### Leave for non-teaching staff -

PL - 15 credited in advance two times in a year.

HPL – Same as teaching staff.

CL – 15 in a calendar year.

The schemes of TRF and PDF are also available for the purposes of Ph. D. and Post-Doctoral Research respectively.

Female employees are provided with the benefit of Maternity leave twice in service period for 180 days and CCL as per the state Government rules. Male employees are provided with Paternity leave as per the state Government rules. Every year all the teaching and non-teaching staff members submit Self-Appraisal reports in which they describe their targets and their performance in the curricular and extracurricular activities during the year.

There is a prescribed ACR and PARs proforma filled by all the employees and submitted officially to their reporting officer as per the norm of government of Rajasthan.

- For Teaching and Non- Teaching staff the PAR is assessed by the Principal and then reviewed by the CCE on annual basis, it covers various aspects of working, behavior result area", "Targets and" Actual achievements" Any special work accomploshede by the staff must be mentioned in PAR.
- The Reporting Officer assesses and grades the work.
- The Commissioner of College Education is the "Reviewing Authority" and he finally gives the overall grading.
- The Principal Secretary, Higher Education to Government of Rajasthan is the Accepting Authority with reference to PARs of teaching employees.

Finally, The ACRs of teaching employees are sent to the Accepting Authority. These records are reviewed by the Departmental Promotion Committee for promotions. The PARs of non-teaching employees are kept in the record of Commissioner of College Education, Rajasthan, Jaipur as the Commissioner is their Accepting Authority. The teaching staff have to fill one self-appraisal proforma.

### 6.4 Financial Management and Resource Mobilization

6.4.1

## Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

### **Response:**

The college is a government establishment and works strictly in accordance with the financial rules and regulations formed by the Finance Department of Government of Rajasthan. The policy orders are issued by the Department of Higher Education, Rajasthan. All the financial support for the college is provided by the government and external audit is conducted annually for all the financial approvals. The college is a government establishment and in financial matters it is governed by the general rules and regulations formed by the Finance Department of Government of Rajasthan and the policy guidelines issued by its parent Department of Higher Education, Rajasthan. There are different sources of fund mobilization and the college strictly follows government norms in resource mobilization. Government financial grants are the major source of financial resources. These are sanctioned for different purposes by the Department of Higher Education, Rajasthan such as the salary of the staff, the conduct of various co-curricular/extracurricular activities, the up-gradation of infrastructural and laboratory facilities, the purchase of library books, the maintenance and enhancement of ICT facilities, the addition of new infrastructure and other related activities. The budget is allocated in accordance with the requirements of the college and broader policy parameters of Government of Rajasthan. In addition to this, the college receives fees and funds from students and these funds are used for earmarked activities related to students' teaching-learning, cocurricular/ extra-curricular and other activities. Different works for students' welfare and improvement of college facilities are accomplished through the amount received in this manner. The college also gets financial grant from UGC for certain required activities and infrastructural up- gradation. In addition to the above mentioned regular resources, the college got financial assistance from the development funds of the local M.P. and M.L.A. for better infrastructural facilities. The institution also got financial assistance from the local Municipal Corporation for better connectivity with tiled all-weather road. Not only this, the active co-operation of various government departments was ensured to keep college facilities in right stead. The college administration ensures that the mobilized financial resources should be optimally used for the desired purpose in a transparent manner. A regular assessment of college facilities has been made to find out the areas which need fund mobilization and then a decision has been taken about from where the financial help can be managed. The work is done economically in the lowest rates without compromising the quality of work. Thus, the college administration is actively involved not only in mobilizing resources other than government grants but also its proper utilization for providing better facilities to students and staff.

Our college promotes women's education to inculcate values in them, strengthen them to stand independent and strong in society. The institute strives towards maintaining an inclusive environment for all students.

We ensure that the events college conducts inculcate the value of tolerance and harmony towards cultural, regional, linguistic, communal, socio-economic, and other diversities among students. Important days & festivals such as Basant Panchami, Holi, Teej, Guru Purnima Gandhi Jayanti, Yoga Day, Youth Day, and Science Day are celebrated. 1. 'Unnayan' - A Skill Development Initiative

### **Objectives of the Practice:**

- Embracing the rapid technological advances and using them for educational purposes.
- Providing exposure to our students for non-conventional, entrepreneurial career paths.
- To learn the basic English skills of listening, speaking, reading, writing, grammar and vocabulary.

- To introduce the students to the know-how of the fashion industry and also motivate them to pursue it as a career.
- To improve skills of various techniques of food preservation and marketing.
- To expose students to myriad government schemes and portals for employability and skill enhancement.
- To organize presentations and interviews with successful start-up owners and entrepreneurs.
- To provide leadership in making non-academic contributions to community.

### Context-

The present century has posed a plethora of new challenges for the present generation of students. A completely new skill set is the demand of the day. Computer efficiency, digital literacy, critical thinking, entrepreneurial skills, leadership quality are just the tip of the iceberg. Being an all women college, the institution feels even more responsible for promoting gender equity. Catering to the mostly rural and semi-urban population of girls, the focus is always on providing maximum exposure to the students to market practices.

### The Practice -

Programs organized by Dept of English, GPEM, Home Science and Placement and Entrepreneurship Cell.

The focus of the college is always on providing maximum exposure to the students to global practices. To this end, the Department of English organizes English play every year that provides an opportunity to the learners to get more engaged with the nuances of the language and culture. The Department of GPEM organizes a fashion workshop and exhibition every year that showcases all the garments prepared by students. This practice introduces the learners to the know-how of the fashion industry and motivates them to pursue it as a career. Department of Home Science organizes Food Preservation Workshop where students learn various techniques of preservation. Placement Cell ensures arrangement of talks and lectures by District Employment Officer, local industrialists, and entrepreneurs to widen the horizon of students.

The establishment of an Entrepreneurship Cell in the college has been an important step towards widening the horizon for our students.

### **Evidence of Success-**

- Students' employability skills are enhanced as they learn food preservation by experts in the field.
- The annual 'Vastram' exhibition where students not only display dresses and other textile products designed and created by them, but also sell them for a profit has enabled them to better understand the working of this industry.
- Annual English plays have boosted the confidence of our rural students who now feel more comfortable using the language.
- Informative talks by government officials and entrepreneurs have kept our students updated

about government schemes for skills enhancement and employment opportunities.

• Entrepreneurship Cell enabled students to interact with entrepreneurs from different fields, who enlightened them about the challenges and opportunities of the same.

### **Problems encountered-**

Students coming from rural backgrounds often find it difficult to actively engage themselves in activities that require them to bring raw material on their own. Highly beneficial as they are, the workshops organized by GPEM, and the Home Science department become financially challenging for students to attend as a very meager sum is allotted for the same.

Since this is a government college, industrial visits by various departments suffer a setback owing to non-availability of conveyance allowance to students.

The onslaught of COVID-19 made it extremely challenging to provide physical, offline exposure to entrepreneurial and employability initiatives.

### 2. Environmental Awareness

### **Objectives of the practice**

To sensitize the students and staff towards environmental consciousness, the Environment committee, with NSS and NCC, work with the motto "Save nature to save the future, make safer environment for better tomorrow".

The main objectives of Environmental Awareness

- To develop a green, clean, and beautiful campus that is situated in the urban central place.
- To identify the various environmental issues and need to address them.
- To make greening an integral part of institutional development agenda.

• To adopt measures for waste management and recycling.

### Context

All of us have a moral obligation to protect the environment and elevate the sustainable development of our planet for future generations. The degradation of the environment is deteriorating the health and security of almost all the species on the earth. Thus, it becomes necessary that we take notice of the impact of our actions on the environment.

### **The Practice-**

As part of our environmental awareness program the institution has conducted various activities such as

- Solar lights are installed in the college. The college is proud of its energy-saving practices. College saved 6679.68 units of electricity in total during the session.
- Rainwater harvesting system installed in the main building.
- Recycling wastewater from RO is used for watering plants.
- Compost pits and Vermicomposting units are functional in the college.
- There are four gardens on the college campus, one Botanical Garden, and Herbal Garden.
- Campus trees have been labeled with botanical details.
- Bird houses have been put up on some trees.
- Extension lectures related to environmental pollution, awareness, quiz competitions have been organized for awareness.
- As a conventional practice, guests, resource persons and other visitors are presented plants with planters as souvenirs.
- Conventional bulbs and tube lights have been replaced by LED lamps.
- In the college campus there is a complete ban on single use plastic in classrooms, labs, canteen, and hostel.
- Smoking and chewing of tobacco is strictly prohibited on the campus.

### **Evidence of Success**

The college has ensured the active participation of the maximum number of students, staff and other social groups in the initiatives undertaken to protect the environment.

### **Problems Encountered**

Although the green initiative activities were conducted with great success, the major challenge was posed by the pandemic of COVID-19 in 2020 and 2021 which had adversely impacted on the execution of important activities. Disposal of E-waste has been difficult since the institution has to follow State Government rules.

# Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

### **Response:**

Since the time of its establishment in the year 1964, the vision of Gauri Devi government College for women, Alwar has been the empowerment of women through academic excellence. This goal is being realized in a consistent and phased manner to ensure for its primary stakeholders, the students, a future that assures them justice and equality in society. Interestingly there has been an obvious shift in the profile of the students. Initially it was mainly urban in nature because of the scarcity and non-availability of the means of transport and communication to girls residing in far flung areas. But with rapid progress in means of transport and growing awareness among people towards the importance of higher education for girls, the profile has taken a new look. As a result, the college is proud of the fact that along with students from urban areas a good number hail from rural areas too.

The college derives its distinctiveness from being the only government College in the district for girls that offers UG courses in all the three streams of learning – humanities, science and commerce—thus giving it a multidisciplinary distinction. Students can opt for Honours in Political Science and can go for Masters in the same subject after graduation. Post-graduation courses are available in Political Science, Psychology, Sanskrit and Hindi. From session 2022-23, Post-Graduation course is available in English literature also, through self-finance scheme (SFS) mode. The college distinguishes itself by offering optional in subjects like Music, Home, Science, GPEM, Psychology and Diploma in Liberty Science —though not vocational in nature, yet offering the students a chance to opt for careers as artistes, dieticians, entrepreneurs, counselors, and Librarian.

Apart from providing a suitable ambience for academic excellence the college strives to achieve its objective of holistic development of the students coming mostly from the marginalized and weaker sections of society and enabling them into the mainstream by executing some of the ambitious flagship schemes introduced by the government. With its commitment toward empowerment and upliftment of women, consistent, concerted efforts are aimed towards achieving those milestones – be it academic, co-curricular, games and sports, NCC and others. Students, who hail primarily from nearby rural areas are encouraged to participate in community services, development of ICT skills as well as soft skills, proficiency in language and communication skills along with inculcating in them a sense of moral and social responsibility.

The purpose of these schemes is to empower students and equip them with a sense of importance and confidence. The college enjoys the distinction of being the nodal center of the district for carrying out the distribution of Scooties to the meritorious students under the Kalibai Bhil Medhavi Chhatra Scooty Yojana, and Dev Narayan Scooty Evam Protsahan Rashi Yojana since last decade and half. Out of the total number of beneficiaries, the students of this college have always been bagging the maximum number due to higher ranks in merits list.

Similarly, at least a dozen other scholarships are also disbursed through college and other government agencies. They include:

- One special type of scholarship, namely Palanhar Yojana for orphaned children who want to pursue higher studies.

To provide monetary aid, the government is providing stipends to students pursuing research work.

Another distinction that has, of late, pervaded both the students as well as the faculty is the receptivity and embracing technology in teaching- learning programs. This perceptible, positive change in the attitude of students with regards adaptability for the new technologies being introduced is very encouraging for the faculty who are including e- learning format vigorously in teaching process. All the teachers have their individual YouTube channels on which videos related to their respective subjects are shared regularly. The college is proud of Dr. Vinita Goyal, Associate Professor (English) who was given a Commendation Letter by the Commissioner, College Education for her contribution to developing econtent for the students during the COVID-19 year.

By complementing the traditional and conventional classrooms with smart classrooms, availability of an un-interrupted internet and vigorous use of e-learning, the college has succeeded in bringing about a positive change in the academic atmosphere.

With the span of time along with other required facilities the basic infrastructure and facilities of ICT, library, teaching-learning tools here got enhanced to a level of best efforts. The college development and maintenance is done mainly by RUSA, CDC and with efforts of CSR. The campus atmosphere is gender friendly and free from any kinds of ragging. The college constantly endeavors to upgrade the student support and guidance initiatives. The progress and results of the students are very much encouraging. Student orientation is organized for freshers to make them aware about the facilities as well as the Campus Code of Conduct. Students are benefitted with all outdoor and indoor sports with gym and yoga centre. "Nupur" a cultural week is organised for students which is USP of the college. Students Union elections prepare the students to become responsible citizens of the country. Celebration of Voters' day sensitizes the learners and the staff members about the importance of their role as voters. Activities of Human Rights Club and Voters Club include taking oaths on becoming responsible citizens and awareness lectures and campaigns towards understanding the rights and duties of citizens. The college instills the values of patriotism by celebrating the significant days and festivals in the college.
