This educational institution was established as **Maharaja High School, Brijnagar** in pre-independent era as a foundation stone of education development in this region. In 1946 this institution was upgraded to inter college level and renamed as **Rajendra Inter College, Jhalawar.** This institution was again promoted up to graduate level in faculty of Arts and finally named as **Govt. Degree College, Jhalawar** in 1958. The Science and Commerce faculties were started here in 1963 and 1970 respectively.

In 1977, this college was further upgraded up to **post graduate level.** Presently in PG level 14 subjects are running. Since 2003, it is affiliated to **University of Kota**, Rajasthan. The college is enlisted by the **UGC under sections 2 (f) and 12 (B) of its Act (1956)** projects,

This college is a centre for **IGNOU**, and **VMOU**, **Kota** and helping in imparting higher education to the masses through correspondence also.

The college has regular student strength of **about 4703 students** in the academic session 2021-22. 70%, are from rural areas. About 80% of total enrolled students are from SC, ST, OBC and SBC categories.

It has 32 class rooms, 09 laboratories, central library, computer laboratory, playgrounds, Four NSS units, one NCC unit and two Rover and Ranger wings. Rover Ravindra Modi & Ravi Modi got President Award recently.

Women Cell of this college celebrates Women Week every year. Anti- Ragging, Women Harassment and Human Right Cells are making the campus safe and secure.

All P.G. Departments have **Subject Associations** and conduct seminars and other academic programmes grooming their personality and developing competence among the student.

The playground for out-door games of this college is very well managed and has a well-equipped gymnasium.

The **Counseling Cell** of this college in interacting with the student on regular basis in group of students and individual as well. A **Placement Cell** is actively working for developing linkages with existing industries in the vicinity area.

Curricular Aspects

The college being an affiliated college does not enjoy full autonomy regarding the curriculum; however, faculty members of the college acting as conveners/members in BOS/COC and Academic Council contribute in curriculum enrichment. The suggestions for the enrichment of the curriculum are offered by the stakeholders, the faculty members, students and subject experts from other universities. The modifications are done keeping in mind the local/regional needs, the latest trends and developments. The relevant issues of utmost concern like human values, gender sensitization, environment and sustainability, culture and language are integrated in postgraduate and undergraduate curriculum. The curriculum comprises of Core subjects to impart common knowledge foundation and electives to pursue educational interests. The core subjects offered during the first

year of graduation are General Hindi, General English, Elementary Computer Application and Environmental Studies. The students pursuing graduation by choosing subjects combination from the list in Arts, Science and Commerce respectively. The master's programs also offer elective courses of contemporary significance. Presently the college offers UG in 17 subjects, Post Graduation in 14, and Ph.D in 8 subjects such as Chemistry, Zoology, Botany, Geography, Hindi, Pol. Science, History, Sanskrit. The College showing concern towards the ever-increasing demand of the region for mainstream regular courses that otherwise are not available has come forth by putting up regional study centers of Vardhman Mahaveer Open University (VMOU) Kota and IGNOU. More than 30 value-added programs across the major faculties are offered to impart life and employability skills.

Teaching-learning and Evaluation

Teaching-learning and Evaluation

The College follows a transparent online admission process as per government rules and policies of commissionerate College Education of the State. As an initiative step to promote higher education among girls, the government has made a provision to exempt them from paying tuition fees. Each and every student is important for the Institution and it tries to cater to each one's diverse needs. For students who fail to meet the objectives of the prescribed curriculum; the teachers extend support by modifying their teaching strategies. The college also promotes women-centered activities under the aegis of Women Cell to provide an extra edge to female students. The Students Advisory Bureau of the College provides academic, personal, psycho- social guidance and counseling related to the election of subjects and their prospects, availability of subject-related material and books and financial assistance to the students. Since most of the students come from rural backgrounds, the faculty tries to facilitate learning at the level of content and comprehension, the most important being the use of bilingual mode in classroom teaching. The conventional method of teaching includes lectures, interactive sessions, group discussions and classroom activities. Student-centric methods such as experiential learning, participative learning and problem-solving methodologies are implemented inside and outside the classrooms to enhance the learning experience. The college displays learning outcomes for all courses and programs on its website which are specifications of what a student should be capable of doing on successful completion of a course and/or a program. During Covid period i.e. in session 2019-20, 2020-21 online classes were conducted using audio visual technique and through e-content various lectures were uploaded on college youtube channel.

Research, Innovations and Extension

Research, Innovations and Extension

Imbibing an aptitude and fostering a culture for research is very essential and the college aims to do the same through its teaching-learning process and various research-oriented activities. Research in Humanities and Social Sciences emphasizes contexts and primarily focuses on community and societal needs; whereas in Science it links knowledge, experience and evidences. The college enjoys the privilege of having one of the maximum numbers of research supervisors as well as research scholars among the affiliated colleges of the university. The faculty has been recognized at National/International level for the research work which has added new dimensions to the reputation of the college. The college is a Government organization has to depend on various external funding agencies that provide financial support to pursue research activities. Different such agencies that have been providing funds to the institute during the recent past are UGC, ICHR,

ICSSR Rajasthan State Biodiversity Board Jaipur etc. Research interest of the faculty is reflected in the form of Major and Minor Research Projects, the participation of scholars and faculty members in National and International Conferences and research publications. The research laboratories of the science faculty are well equipped and harbor some of the latest instruments. Computer Lab, Smart Class Room and E Class Room are available in the college. Seminars, Conferences of National and International level and Workshops are organized independently and in collaboration. Other activities that add on to the research environment and inculcate research aptitude among students include field projects, surveys, excursions, visit research laboratories and institutes. A regular quarterly presentation is mandatory for all the research scholars registered under college supervisors. Pre submission viva-voce is compulsory to all the research scholars.

Infrastructure and Learning Resources

Infrastructure and Learning Resources

The College is constantly extending and expanding its resources in terms of construction, IT infrastructure, equipment, classroom furniture, Library, and other campus facilities. The college has a landholding of 7.62 acres where different building blocks are constructed. Besides the main building which harbors the Administrative, Academic and Establishment Sections, Chamber of the Principal, Department of Physics, Departments of Zoology and Department of Chemistry. Department of Botany and other departments of Social Sciences and Humanities and Commerce have separate blocks. The basic facilities in the college comprise of 4 water coolers for drinking water facilities 40 boy's toilets, 25 girl's toilets and 5 ramps for persons with different abilities. The college library is fully automated and has about 75082 text books and 14025 historical books. The library of this college is of national repute and monumental heritage. According to the Wikimapia Website (www.wikimapia.org) the central library of this College is one of the best library among all govt. college libraries in the state of Rajasthan. Departmental libraries have also a good collection of books which are of great help to aspiring students. The college has separate playground with will equipd gymnasium. Now the college has an auditorium of 650 sitting capacity. Solar panels were installed on the roof top of the building and producing 10 kw electricity. Computer and internet facilities are available in the respective departments which are accessible to students and teachers. Th college has three well equipped smart class rooms. The college has Vivekanand Hostel of 32 student capacity. The college has a generator of 30 kw capacity. The Alumni also supports and contributes in its own way by extending support as per their position and capabilities in respective posts.

Student support is extended through mentoring, personal counseling and learning resources. The Institute is committed to the cause of first-generation learners and weaker sections of the society. Most of the students are from rural background and the college aims to maximize the learning experience of students with the available resources with utmost concern, support and participation. The support is furnished at various levels viz. information, infrastructure, finance, counseling and exposure:

• **Informational support** – College prospectus, updated college website, classroom teaching, field trips, educational tours, mentoring and problem-solving sessions regarding curriculum and subject

knowledge.

- **Finance** Liberal fee structure, waving off fee for girls, persons with different abilities and scholarships from central, state government and social welfare department.
- **Counseling** Career counseling cell, NCC, NSS, YDC, Women Cell, skill development cell, Placement Cell, Anti Ragging Cell, Internal Complaints Committee, extension activities and lectures on personality development and communication skills, special classes for slow learners.

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:	The college is affiliated to University of Kota, Kota and the college is having interdisciplinary
	and the college is having interdisciplinary /multidisciplinary approach in the core subjects as per the curriculum provided by the University of Kota. The main aim of the institution is to promote each student's holistic development in academic as well as non academic fields. Add on certificate courses are also offered by the college that can be studied by the students without any subject bar. To interchange the ideas among the students and faculties an Interdisciplinary programmes are organized in research, cultural and literary fields in the college. The skill development courses/training programmes provided by the college to the students, in addition to the core subjects, are helpful to measure one's potential and implement plans. Faculty members offer full freedom to have interdisciplinary discussions with students of all streams. Courses such as Environmental Studies, Elementary Computer Education and Anandam have been made mandatory for all undergraduate students and Aanandam programme is mandatory for PG students. To impart and promote multidisciplinary/interdisciplinary culture in the college extension lectures in various subjects/topics are also organized. The research cell established in the college encourages innovative research and linkage between different departments. Some research scholar working in the college are choosen interdisciplinary topics for pursuing Ph.D. Taking into consideration of the envisaged changes in the NEP, the college will adopt it in due course of time.
2. Academic bank of credits (ABC):	Being an affiliated college, the college follows the university curriculum and examination pattern of university of Kota, Kota. Faculty members are involved in paper setting, invigilation duties and assessment work. In the existing Academic Bank of Credit (ABC) a student can move from one college to another that have affiliation with University of Kota and the transfer of credits to other university is strictly within the purview of the university rules and regulations. There is possibility of credit transfer between the universities located in the state only in some special circumstances, as described in the admission policy of the state Government. The faculty members of institute are engaged in publication of books in specific areas. Some of the

	faculty members are appointed by university for curriculum design as BOS/COC members. A six day FDP programme was conducted by Geography department under Gyan Ganga scheme. A five day national workshop on operation and maintenance of laboratory equipment was conducted by college in collaboration with WRIC Mumbai. The NEP related policies adopted by the affiliating University and the same are implemented by the College as per the directions of the University. The use of SWAYAM portal and its credit transfer scheme are also briefed to students.
3. Skill development:	For all the programmes that are in consistency with the objectives of NEP, the college is eager to initiate the implementation of Learning Outcomes-based Curriculum Framework (LOCF) as suggested by UGC. Keeping in view the present scenario of the society the program tends to promulgate the necessity of providing opportunities as well as platforms for the girl students. Besides this, measures are adopted to enhance the bench skills of the students such as the introduction of the Project work, summer training programmes, skill development programmes, Communication and IT skills, etc. The organization of these courses hones the skills of students. College is also offering "Mukhyamantri Yuva Kaushal Vikas Yojana" where students are provided opportunity to opt for skill development course out of 16 listed courses. MMYKY 2.0 is a joint venture of Commissionerate College Education and Rajasthan Skills and Livelihood Development Corporation. The institute is also registered for Spoken tutorial, an online initiative by IITs, here students can learn various free and Open-Source Software all by themselves. Incubation cell has been established in the college which is specially focusing on skill development in entrepreneurship under the banner of i-Startup.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	For easy communication of subject course the medium of instruction is bilingual that is Hindi and English. Hindi, Sanskrit, English, Urdu languages are taught in UG and PG programmes. The faculty of college is capable to teach students in bilingual mode as they are all updated. PG association of Sanskrit department conducted a seven day Sanskrit communication programme for the students to promote the Sanskrit language. Hindi association

	conducted programme on literary activities like essay, quiz, debate, extempore, kavya path etc. Hindi is included as a compulsory course in 1st year in all under graduate programmes. Cultural activities are focused on Indian culture as some of the competition are based on Indian culture themes like Mandana Competition, Saafa Competition, Mehandi Competition, Rangoli Competition, Bindori Competition, Folk Song Competition etc. To promote Indian heritage and culture the PG association in history organizes trip to heritage sites. In UG classes local tour are arranged to aware students towards the culture of local region. During Covid-19 period the college started its youtube channel where online content for student were uploaded by all faculty members. Under "Ek Bharat Shreshtha Bharat" scheme, students are made aware of Indian culture, art and languages.
5. Focus on Outcome based education (OBE):	The college is affiliated with University of Kota, Kota. The programmes offered by the college are outcome based. Currently we have 224 courses which have specific topics related to value based education, environmental awareness, gender equity, etc. which are achieved by specific lesson plans prepared by the faculty members. Evaluation system include internal/term/ monthly tests. POs and COs are discussed with the students in introductory classes to enable them to understand the effectiveness and practicality of the opted programs and courses. The outcome is measured through the performance of the students in university exams and their progression to higher studies. The tabulation registers of results are created by the college. Feedback collected from stakeholders also indicates the success of OBE.

2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

As the college is affiliated to university of Kota, Kota so that the students are assessed through the annual and semester examination conducted by the university. The institution thus does not have any direct process of continuous internal evaluation but it has its own modus operandi for the same in the form of periodic test and sessionals during the course of the academic session.

- As per the curriculum, it is mandatory for all PG students of science faculty to participate in the departmental seminars and periodical tests. Evaluation is being made on the basis of their performance. The head of respective departments call a meeting at the beginning of the academic session and discuss among faculty members how to improve the performance and skills of students.
- In the subjects where practical exams are part of the curriculum, it is mandatory to submit a practical record which is evaluated and marks are included in the final consolidation of results. The

project report is also compulsory in some of the subjects and is considered for assessment.

- Periodical class tests are also conducted on a regular basis which are helpful to the students in their preparation for the final exam.
- In Post Graduation program, there is an option of writing a dissertation on the topic chosen by the student under the supervision of the faculty member. All such endeavors contribute indirectly to the evaluation process because they are like formative exercises for the students.
- As per the University norms for P.G. Programmes in science subjects there is a system of internal assessment. The faculty members of the college of the respective department conduct tests for evaluation of internal assessment and the marks will be sent to the UOK, and which are added in the final result of the university exam.
- The practical's examination of UG and PG for conducted in the presence of University appointed external examiner and the marks will be sent to the University through online on the same day.
- The college conducts the University examination in the college as per the time table given by the University and the answer books were sent to the University for evaluation. After the evaluation of the answer books the University declares the final results.

The curriculum design and delivery aims at employability skills and competence. The graduate and postgraduate programmes equip the learners for job opportunities in different service sectors. Though the college is not offering any technical courses but all the running programmes and curriculum are designed to deliver the best. The programme outcomes and course outcomes primarily aim at imparting knowledge and skills which is important for personality development and to develop competence among students. 3.4 Extension Activities

3.4.1 Outcomes of Extension activities in the neighborhood community in terms of impact and sensitizing the students to social issues for their holistic development during the last five years.

Response:

This institute of higher learning plays very important role in nurturing its students as well as society. - Cleanliness drives: Following the essence of "Swachh Bharat Mission" college administration has allotted separate blocks to different departments and assigned responsibilities to keep them clean. In the mean time special drives are being initiated to make the campus clean. Special camps are organized by the NSS units in the college to make it neat and clean regularly. The students not only clean the campus but also went to the neighboring villages for the same motives. They worked with great dedication and wholehearted support was extended by the society too. For the collection of waste materials dust bins are placed at different locations in the college. College has well defined dumping area for solid waste management. Further health and hygiene go together and it is very important to prevent diseases to maintain good health and for this heath and vaccination camps are organized in the campus during covid-19.
- **Blood donation camps**: Blood donation is a life-saving endeavour and is a sign of humanity that unites people irrespective of caste, creed and religion. The college organizes blood donation camp at least once in a year. Faculty members and students donate blood with full enthusiasm. District govt. hospital has appreciated the college many times for this kind act.
- Social Issues of concern: The college organizes camps from time to time on different social issues like save the girl child, female feticide, 'AIDS Awareness' etc. Various competitions viz. Rangoli, slogans, posters, essay writing, short skits etc. are also held to pass the message to the society.
- Voter awareness: For the awareness of 'Right to Vote' college organizes awareness camp in collaboration of district administration through NSS and SCOUTS units. Every year on 25 january, the college celebrates National Voter's Day and takes oath for free and fare voting. Further campus

ambassador is also appointed to create voter awareness among students.

Response:

The college has adequate facilities for teaching and learning. The institution has sufficient space for all departments and common facilities. There are well equipped state-of-art laboratories and departments. The college has its own well and 2 bore wells, an overhead water tank with a capacity of 10 thousand litres, and a dedicated pipeline of fresh water supply from PHED. The college campus has a provision of two-wheeler and four-wheeler parking stands. The institute possesses a 30 KW generator installed in the main building and two additional generators in science block of 2.3 KV and 0.75 KV respectively. Most of the departments are equipped with computer and WiFi internet facility. The details are below:

- The main building which harbors the Administrative, Academic and Establishment Sections, Chamber of the Principal, Department of Physics, Departments of Zoology and Department of Chemistry. Department of Botany and other departments of Social Sciences and Humanities and Commerce have separate blocks. The college has 4 water coolers for drinking water facilities, 40 boy's and 25 girl's toilets. 5 ramps for persons with different abilities.
- **Classrooms**: There are 32 traditional classrooms, 02 lecture theatres, 09 practical laboratories, 02 smart classrooms and 01 e-classrooms with interactive boards and internet connectivity.
- Facilities for Research: Research facilities are available in science and arts. Presently more than 15 faculty members are recognized as research guide and more than 60 research scholars are pursuing their Ph.D. under their supervision.
- ICT Lab: ICT laboratory is equipped with twenty computers and internet facility.
- The college central library has about 75082 classified and indexed books along with 14025 rare books. The whole library is facilitated with Wi-Fi network and is fully automated.
- The college auditorium of 650 sitting capacity is under construction with rupees 4 crores.
- The college has separate boys hostels of 36 students capacity.
- The college has solar power panels of 10 KW capacity in its premises.

Facilities for sports:

- The College has adequate sports facilities for indoor and outdoor games. Various sports played by the students of the college include Football, Cricket, Table Tennis, Volleyball, Basketball, Kho-Kho, Kabbadi, Chess, Carom, Badminton and Softball. The college is regularly organize university inter collegiate tournament as per university calendar. The College sports committee takes care of various team selections, holding competitions, taking teams to different places during tournaments.
- Most of the students of this college are from the rural background with their academic excellence, they perform well in sports too.

- All the players are provided sport kits and t-shirts for practice and track suits for tournaments.
- The college provides TA/DA to the players for participation in the state and National level tournaments.

Facilities for cultural activities:

- Presently the cultural activities like Solo & Group songs, Solo & Group dance, Plays, Skits, Fancy Dress, Mono acting, Debate, Rangoli Making, Mehandi etc. are organized at open stage of science block.
- The college has different subjects associations are also organize different academic and cultural activities.

- There are 16 CCTV cameras which have been installed in the administrative building, science block, arts, commerce and library. The main TV screen is placed in the Principal's office for

constant monitoring.

- The number of Computers in the College is 41. There are in all 5 Browsing Centres.
- Four biometric machines have been installed for monitoring attendance of teaching and non-teaching .

Criterion 6 - Governance, Leadership and Management

6.1 Institutional Vision and Leadership

6.1.1 The institutional governance and leadership are in accordance with the vision and mission of the Institution and it is visible in various institutional practices such as NEP implementation, sustained institutional growth, decentralization, participation in the institutional governance and in their short term and long term Institutional Perspective Plan.

Response:

The leadership and governance of the college is well reflected in its vision and mission. The vision of the college has been to impart student-centric quality education and inculcate moral values in its stakeholders. Being accredited by NAAC with B and B+ grade twice consecutively bears testimony to its illustrious and glorified history, growth, development, achievements, leadership, and governance over the years. The college has a good organizational structure for effective decision making and execution of responsibilities.

- Nature of governance: Commissioner of college education, Rajasthan Jaipur manages and administers all the government colleges of the state, but at the college level the Principal is the head of the institution. He decentralizes duties and the senior faculty members are given charges of Establishment section, accounts section and academic section to shoulder various administrative responsibilities. The heads/ incharges of various departments act so by virtue of their seniority and are responsible for the functional activities of the departments. The performance of every employee, teaching or non-teaching, is appraised by the Principal and reviewed by the competent authority on annual basis covering various aspects of working/ behavior and overall performance. Regular meetings of the college development committee and stakeholders play a significant role in overall governance viz. planning, deployment, monitoring and execution of agendas pertaining to development, teaching, social responsibilities, and innovative practices.
- **Perspective plans**: The administrative strategies are planned and executed both at the commissionerate and at the institutional level. The members of BOS receive feedback from students and teachers, initiate modifications in the curriculum in the University BOS meeting. Action is taken on the feedback regarding teaching, institutional social responsibilities, augmentation of facilities and other areas within the purview of the principal. Matters and requirements related to finance are forwarded to the commissionerate for further action.
- **Participation of the teachers in the decision making bodies of the institution:** The constitution of committees for specific purposes clearly reflect effective governance. More than 50 committees are framed at the beginning of every academic session. The staff council meeting and respective committee meetings are called periodically for effective implementation of agendas related to teaching, curriculum, admission, examinations, students' union elections, co-curricular and extracurricular activities and any other significant matter related to the development of the institution. The committees are well supported by non-teaching staff.
- Mahavidyalaya Vikas Samiti (College Development Committee): It works as the liaisoning platform between the society and the college. This committee plays a big role in the development of the college. It helps in the effective implementation of strategic planning and generating finance.

6.2 Strategy Development and Deployment

6.2.1 The institutional perspective plan is effectively deployed and functioning of the institutional bodies is effective and efficient as visible from policies, administrative setup, appointment, service rules, and procedures, etc

Response:

The key aspects of the organizational structure of the college are as follows:

- Administrative set up and function of various bodies: The college governed by the commissionerate of college education, Rajasthan headed by the commissioner. The senior members of the faculty are given charges of the establishment section, Accounts section, and Academic section. The staff members include teaching staff, office support staff, Librarian, Laboratory Assistants, Electrician etc. Various Committees are constituted for different assignments. As the post of PTI is presently lying vacant, a Committee looks after all the sports activities. AAO and accountant deal with the financial matters. Many employees like the Security guards, Gardeners, Safai Karamcharis, Computer Operators etc. are recruited on contractual basis through placement agency. The teaching staff is assigned various responsibilities such as conveners and members of different committees. The Administrative structure of *Vikas Samiti* (College Development Committee) comprises of principal, representative of the district collector, local MP and MLA or their representative, commissionerate college education representative, two educationists and two learned citizens. The function of the committee is to provide and maintain basic infrastructure and generating funds deliver teaching-learning and developmental activities.
- Service rules: The college is a government institute and therefore it is mandatory to follow the Rajasthan state service rules, regulations, policies framed by the state government (RSR). (link RSR)
- **Recruitment:** The staff is recruited by Rajasthan Public Service Commission/ Rajasthan Staff Selection Board. The class iv employees are recruited through employment exchange. In addition, there is a provision of compensatory appointment in place of the demise of a working person, based on the mercy of the govt.
- **Promotional policies:** The promotions are decided on the basis of recommendations made by the Departmental Promotion Committee as per the specific guidelines framed by the government.
- **Grievance Redressal:** The college has formed the committees like, anti-ragging cell, grievances redressal cell, and anti-women harassment committee etc. To look into complaints received and solve them judiciously. Besides, for grievance redressal related to Govt. P.G. College, Jhalawar the Employee ID of the Principal of the college is mapped by the Rajasthan Sampark Portal. Anyone having grievance can file a complaint through online process on the Sampark Portal. The complaint is forwarded to the college through the central office and college has to solve the issue at earliest. The SC/ST cell and minority cell have also been constituted for the same. Besides, a committee called legal cell is also constituted to look into court **cases**. The students can directly approach the principal for grievances and redressal. The matter is discussed with the related committee and action is taken accordingly.

6.3 Faculty Empowerment Strategies

6.3.1 The institution has performance appraisal system, effective welfare measures for teaching and non-teaching staff and avenues for career development/progression

Response:

The college implements all the welfare schemes of the state government and also tries to facilitate the same through various effective welfare measures. GPF/NPS and SI are compulsory deductions for future security. In addition, annual 'Group Insurance' is also deducted. Medical claims are reimbursed by the State government through RGHS (Rajasthan Govt. Health Scheme) as part of the health expense incurred by the employee. Besides being given gratuity and pension the superannuated employees of the college are benefitted from the Rajasthan Pensioner's Medical Fund. The university deducts 6% of the amount for 'Teacher's Welfare Fund' from the remuneration of the teachers which they receive for the evaluation of answer books, which is provided to the family of the needy faculty member, based on the policy of the fund. Provident fund is also deducted from the salary with long term future benefits of the employee. Some of the other benefits include:

Leave for teaching staff:

- P.L : 15 privilege leave earned after completion of calendar year
- HPL 20 half pay leave after completion of the year can be commuted on medical grounds.
- CL 15 in one academic session
- Special CL 15 in a session for seminars, conferences and academic purpose

• Study leave for maximum two years for higher studies.

Leave for non-teaching staff:

- PL 15 advance credited two times in a year
- HPL same as teaching staff
- CL 15 in a calendar year

Leave for female staff:

- Maternity leave, two times in service period for 180 days

6.4 Financial Management and Resource Mobilization

6.4.1 Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

Response:

The funds are utilized as per GF & AR of the State. Either the principal is the DDO or one of the senior members is given the charge of DDO who looks after the financial matters including the salary of the college employees. There is an office of AAO supported by accounts staff who maintain proper ledger with details of the financial support received and utilized under different heads from various agencies. The funds are received under the following schemes/heads:

• State Government: allocates a specific amount to Govt. Colleges for overall development and maintenance. The committee constituted for college developmental purpose puts forth the demand and requirements before the principal. The state budget and grants are released for salary, TA, medical, office work, construction and maintenance, lab grant, books and journals, etc. This is disbursed as per allocated heads. The proposals for requirements related to maintenance are also

submitted to CCE, College Development Committee, and RUSA for their engagement and contribution.

- State Government Scholarships: Payment of fellowships and scholarships of UGC, ICSSR, and CSIR etc. is through PFMS. The payment of various Scholarships is online and executed through the SSO module.
- UGC and RUSA: UGC has been providing assistance till 2017 under the XII Plan Period. These funds were disbursed by the planning board of the college for various purposes viz instrument procurement and maintenance, building construction in college, etc. The UC was submitted timely to the office of the UGC (CRO). After 2017 RUSA comes into the existence and funds amounting to Rs 2 crore were allocated to the college under three major heads construction, renovation and equipment. The fund was utilized as per rules and UC has been submitted. Governing and Monitoring bodies Board of Governors (BOG) and Project Monitoring Unit (PMU) monitor the progress of projects initiated by RUSA.
- Vikas Samiti: Requirements and emergency needs other than these are fulfilled by funds generated through *Vikas Samiti (College Development Committee)*.
- **Research:** The College being a Government organization has to depend on various funding agencies like UGC, CSIR, ICHR, ICSSR etc. for financial support to pursue research activities.
- **MP lad scheme:** The funds Rs. 3.22 cores received through MP lad schemes were utilized for the construction of auditorium and renovation of hostel.
- Alumni: The alumni also contribute for the development of college through donations.

Maintenance of Laboratory Equipment.

- IQAC has conducted IPR Awareness programme in college on 23 Jan. 2022 and Second IPR awareness workshop on 1st March 2023.
- Introducing post graduation in Sociology, EAFM and BADM.

Out of so many initiatives the two best practices of IQAC in institutionalizing quality assurance are

Best Practice 1 : Organization of 5 days Instrumentation Workshop in Collaboration with WRIC Mumbai :-

The context :- To improve the quality of operation of instruments and non working are to be repaired.

The Practice :- IQAC has taken initiative to organize this workshop to enhance the knowledge of the students, lab staffs as well as faculty members of science faculty. In this workshop total number of participants are 145 including teaching staff.

Uniqueness :- The WRIC team repaired many instruments, which were in non-working condition. The college benefited too much by organization of such a workshop.

Constraints :- After getting dates from the WRIC Mumbai, financial constraint was major issue and it was crossed through registration fees.

Evidence of Success :- Non working instruments were repaired and now they are working properly.

Problems Encountered and Resources Required :- No problem was faced exept 5 days scheduled management and session wise planning.

Best Practice 2 : Initiative taken to improve the qualitiy of research :-

The context :- The college is the active research centre of University of Kota, Kota and keenly envolve in research in development.

The Practice :- Presently eleven college faculty members are registered has research guide and fifty research scholar are pursuing their Ph.D. under the guidance of their supervisors in different faculties. Twenty five Ph.D. have been awarded during assessment period.

Uniqueness:- It is mandatory for all the research scholar to present their progress report quarterly before the faculty members.

Constraints :- In the subjects of humanities research scholars have faced some problems during the field work. Some time they do note get proper response of their questions from the respondents.

Evidance of Success :- All the research scholars quarterly present their progress report in the college. Ph.D. thesis are being submitted to the university and awarded as per schedule.

Problems Encountered and Resources Required :- Some times research materials are not available timely and easily but still the research scholar are making efforts to come out of these problems. How ever research scholars are visiting other University libraries, research centres and archives.

Response:

Response: 1. Green and Eco Friendly Campus 2. Alternate Energy Resources

Best Practice - I, Title : Towards a green and eco friendly campus

Goal:- To keep the campus green and Clean

The Context:- A number of trees to be planted towards fulfilling the goal and to provide grass cover patches over areas lying barren. The Eco Club and campus beautification committee are planning to plant more number of trees in the campus. The challenging issue is maintaining the planted trees because water is the main problem during summer months so we have a water harvesting system as well as additional one well and three bore wells.

The Practice:- The Eco Club and campus beautification committee are working towards this issue in the campus. The members of the club involve NSS student volunteers, NCC Cadets and Scout Rovers for tree plantation. Grass patches have been put in various places across the college campus under the supervision of the club.

Uniqueness:- In collaboration with forest department, planted trees which requires less water to grow. We have created plantation blocks (like Neem block, Sheesham Block, Botanical garden block etc.) and given responsibility to student groups and their mentors to maintain them. The college administration also helps the team to buy plants and grow them.

Constraints:- It is difficult to maintain plants green in summer due to water scarcity. This can be overcomes by using the water obtained from water harvesting techniques and also by planting drought resistant plant species.

Evidence of Success: The fencing of the lawns has been completed. Under Harit Rajasthan Programme 120 plants of different species were planted. A well maintained lush green lawn has been developed by the department of geography. The overall environment of the college have become more pleasant due to the aforesaid efforts.

Problems Encountered and Resources Required:- Due to more students enrollment, there can be seen some unclean areas in some places at times but they are duly monitored and rectified at the club and the administrative levels. Similarly the survival rate of the planted trees also depend on the water availability for which water harvesting technique is being assiduously pursued in the college.

Best Practice II

Title : Alternate Energy Resources

Goal : Installation of Solar Power panels on the college building roof top to save the electricity

Context : RUSA fund was utilized for installation of solar power panels and connect it to power grid so that the electricity bill of the college become reduced.

Objective : The college has power consumption 20 KW per month as per JVVNL record. To minimize the power consumption the college has taken initiative to install solar power panels of 10 KW.

Practice : In the Rajasthan state there is no scarecity of solar energy. So we decided to use solar energy for reducing the electricity expenditure. For which solar power panels were installed on the roof top of the building by spending RS 6 lacs from the RUSA grant in 2018 and producing 10 KW electricity.

Obstacle : Spending a grant of RS 6 lacs is a big problem but due to the RUSA grant the college crossed this obstacle.

Impact of the Practice : By producing 10 KW power the college minimize the electricity bill expenditure.
