

A memorandum of Understanding
for Mental Health Wellness
Between
Heartfulness Education Trust
And
Janki Devi Bajaj Government Girls College, Kota

Whereas Heartfulness Education Trust, a not-for-profit organization, registered trust having its Registered Office at No. 40-15-9/12, Nandamuri Road, Venkateswarapuram Post Office, Vijayawada - 520010, Andhra Pradesh (hereinafter referred to as "HET") and Janki Devi Bajaj Government Girls College, Kota (hereinafter referred to as "JDB, Kota") seeking to develop positive thinking, increased concentration, removal of mental stress and feeling of happiness in mind of students and faculty, have agreed to sign this Memorandum of Understanding (hereinafter referred to as "MoU") as a first step towards achieving this goal.

NOW THERE FOR EPURSUANT THERETO, the parties hereby agrees as follows:

1. SCOPE OF COLLABORATION

- (i) Parties hereby agree to implement within the framework of rules and regulations applicable in each of the institutions and subject to availability of funds and resources, the following programmes and activities, which may include but not limited to:
 - (ii) Heartfulness meditation sessions and sharing of literature
 - (iii) Offer various tools of wellness including awareness sessions
 - (iv) Training programme to faculty member and staff

(2) It is agreed that the terms and conditions of any programme and activity contemplated in this MOU shall be subject matter of separate written agreements to be negotiated and agreed upon by both Parties and/ or any third parties, wherever applicable. PROVIDED ALWAYS the decision whether to initiate and/ or implement any programme or activity shall be at the sole discretion of each Party

(3).The parties agree to designate, on behalf of each institution, a coordinator whose responsibility will be to supervise the execution of this MOU and to draw up programmes or activities to be implemented under this MOU, setting out specific provisions concerning the programmes. For this purpose, the coordinator for HET is the Director and for JDB, Kota is the Principal.

2. CONFIDENTIALITY

The Parties agree and undertake to keep confidential at all times any information or data that may be changed, acquired or shared in connection with any programme or activity conducted pursuant to this MoU save where the same is already in public domain.

3. DURATION AND TERMINATION


- (1) This MoU shall take effect on and from the date of execution of this MoU and shall continue to be effective for a period of **Three** years therefrom. This MoU may be extended for such further period as may be agreed by the Parties in writing.
- (2) Notwithstanding clause 3 (1) above, this MoU may be terminated by either Party given written notice to the other at least six (6) months prior to the proposed date of termination.
- (3) Notwithstanding clause 3 (1) above, the provision of this MoU or any other written agreement in respect of any on-going exchange programme or any other form of cooperative activity under this MoU shall continue to apply until their completion unless both parties mutually agree in writing to the earlier termination of the programme or cooperative activity.

4. MISCELLANEOUS


- (1) This MoU may be modified, varied or amended at any time after due consultation and with the written agreement of both parties.
- (2) This MoU is not intended to be legally binding. It merely express the intentions and understanding of the parties which form the basis of any legally binding agreement to be drafted and executed in the future.
- (3) The Parties hereby agree that they are not bound exclusively by this MoU and shall be at liberty to enter into any separate agreements or arrangements with any third party without reference to the other party.






