

MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

Memorandum of Understanding (MoU)
Between
Janki Devi Bajaj Government Girls College Kota
And
Agriculture University, Kota

This Memorandum of Understanding (MoU) is entered into by and between the Janki Devi Bajaj Government Girls College Kota hereafter "J.D.B. Govt. Girls College", with a registered address at Antaghar chuoraha, Nayapura, Kota- 324001 India and the Agriculture University, Kota "AUK", with a registered address at Borkhera, Baran Road, Kota-324001. J.D.B. Govt. Girls College and AUK are referred to collectively, as "Partners" or individually as "Partner."

1. Purpose

The purpose of this MoU is to bring Academic Excellence, Research and Extension Activities and to define the areas for fundamental, academic and research in which the Partners desire to work together in the future for their mutual benefit to foster Joint Research Activities, Exchange of Academic Materials, Laboratory/Infrastructure Sharing, Training/Project/Dissertation Programs, Virtual centre for interdisciplinary research between J. D. B .Govt. Girls College and AUK. Both of them find precious synergy in such initiatives and plan to work together for mutual development, promoting research, study and extension activities.

2. Scope

This MOU sets forth the intentions of the Partners for increased collaboration, cooperation and interaction and does not create any legally binding commitments. If the Partners later agree to undertake specific joint projects with legally binding obligations, they will develop separate written agreements for such projects, setting out each Partner's contributions, deliverables, and budgets.

The Partners intend to:

2.1 Pursue collaboration on fundamental academics, research and extension for the mutual benefit either or.

2.2 The partners agree to share their respective networks with one another. Both partners have access to data collected within collaborative projects to use within jointly written scientific articles. The partners take responsibility for exchanging information for one another, for example on research calls for funding.

2.3 Provide mutual access to facilities for the purposes of fundamental academics, research and Extension related to scientific applications. Any such activities, including any academic exchanges outlined in 2.4 below, must comply with the access requirements of the respective Partner.

2.4 Offer an academic exchange opportunity with the aim of sharing and furthering the scientific and technical know-how of both Partners.

2.5 Both the parties agree to organize jointly seminars, conferences, or workshops, lead lectures on topics of mutual interest and to invite and allow each other's faculty, students etc. to participate therein.



3. General Provisions

3.1 As stated above, any specific joint projects with legally binding obligations will be set forth in separate written agreements.

3.2 Treatment of intellectual property rights developed through collaborations under this MOU will be determined between the Partners through mutual consultation and separate written agreements on a case-by-case basis and will be of joint ownership.

4. Duration

4.1 This MOU shall be effective from the date of final signature and initially will be for five years and may be extended or resigned on mutual understanding. This MOU may be terminated by either Partner upon three (3) months advance written notice.

5. Fees

5.1 Fees will be charged from the students to conduct research. Training, dissertation, as decided by the respective institution. Other charges should also be applied as per institutional norms or decided by the competent authority and will be accepted & paid to the concern.


6. Liability


6.1 However any damage to the equipment, implement, items or facilities of one party brought about by negligence or intentional misuse by the personnel of other party will be chargeable. The decision of head of the respective institution shall be final.


7. Jurisdiction

7.1 If any dispute, will be settled in the court of Kota only.
