पंचम भाग

प्रवेश के सामान्य नियम

5.1 प्रवेश अस्वीकार/निरस्त करने का अधिकार :

प्राचार्य निम्नांकित कारणों से अभ्यर्थी का प्रवेश अस्वीकार/निरस्त कर सकता है -

- 5.1.1 जिसने अपूर्ण आवेदन पत्र प्रस्तुत किया हो।
- 5.1.2 जिसने प्रवेश हेतु प्रस्तुत आवेदन पत्र में कोई तथ्य जान बूझकर छिपाया हो अथवा मिथ्या प्रस्तुत किया हो।
- 5.1.3 जिसने शुल्क जमा कराने की घोषित तिथि तक महाविद्यालय शुल्क जमा नहीं कराया हो।
- 5.1.4 जिसका प्रवेश सम्बद्धक विश्वविद्यालयों के नियमों के अन्तर्गत स्वीकार्य न हो।
- 5.1.5 जो पूर्व वर्षों में किसी दुराचार / दुर्व्यवहार का अपराधी रहा हो।
- 5.1.6 परीक्षा में अनुचित साधनों के प्रयोग के लिए बोर्ड अथवा विश्वविद्यालय द्वारा दण्डित किया गया हो।
- 5.1.7 जिसके विरुद्ध किसी शैक्षणिक अथवा अशैक्षणिक कर्मचारी के साथ परिसर में या परिसर के बाहर हिंसात्मक व्यवहार करने का आपराधिक मामला न्यायालय में विचाराधीन हो।
- 5.1.8 जो न्यायालय के द्वारा नैतिक कदाचार अथवा किसी प्रकार के अन्य अपराध के कारण दोषी ठहराया गया हो।
- 5.1.9 जो वर्तमान सत्र में प्रवेश के समय अथवा उसके बाद किसी शैक्षणिक / अशैक्षणिक कर्मचारी के साथ दुराचार / दुर्व्यवहार अथवा गाली-गलौच करने का दोषी पाया गया हो।
- ह.1.10 जो विद्यार्थी रैगिंग गतिविधि में लिप्त पाया गया हो।
- नोट :- अभ्यर्थी के दस्तावेजों में शंका होने पर प्राचार्य विधि-सम्मत कार्यवाही करने को स्वतंत्र होंगे।

5.2 राजस्थान का निवासी वह है :--

- 5.2.1 जो राजस्थान में जन्मा हो (जन्म प्रमाण पत्र के आधार पर)।
- 5.2.2 जिसके माता / पिता पिछले पांच वर्ष से राजस्थान में निरन्तर निवास कर रहे हों। (इस कोटि के आवेदक को इस हेतु संबंधित जिले के कलेक्टर / एस.डी.ओ. / सहायक कलेक्टर अथवा तहसीलदार का प्रमाण पत्र प्रस्तुत करना होगा।)
- 5.2.3 जो राजस्थान सरकार अथवा राजस्थान सरकार के किसी उपक्रम अथवा राजस्थान सरकार के किसी अर्द्ध सरकारी संगठन के कर्मचारी का पुत्र/पुत्री हो।

ANTI- RAGGING POLICY

Ragging is a criminal offence and is governed by the Anti-Ragging Code of the UGC. The Institute is firm on ensuring that the UGC framed regulations on prohibition, prevention, and elimination of ragging are strictly followed on campus. The college has taken strict of the UGC cognizance notification - "Regulations on Curbing the Menace of Ragging Educational in Higher Institutions, 2009". The Institute shall ensure that its campus and accommodations facilities are free of the menace of ragging.

OBJECTIVES:

- ➤ To prohibit any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- ➤ To comply with the directives of UGC issued from time to time.
- > To ensure completely ragging free environment.
- > To create awareness among seniors that ragging of any kind is prohibited by law.
- > To deal with the incidents of ragging promptly and stringently.
- To ensure discipline in the class rooms and within the college campus.
- > To promote responsible behavior amongst students.

MEASURES FOR PREVENTION OF RAGGING:

- * Ragging within and outside the campus is totally banned and anyone found guilty of ragging and or abetting ragging is liable to be punished.
- Every candidate has to fill and sign an affidavit to the effect that he/she is aware of the law regarding prohibition of ragging as well as the punishments, and that he/she, if found guilty of the offence of ragging and/or abetting ragging, is liable to be punished appropriately.
- ❖ Anti-ragging Committee is constituted Committee which is headed by the head of the Institution, and consisting of Institute has constituted an Anti-ragging representatives of various stakeholders as per the norms.
- ❖ The Anti-Ragging Committee ensures compliance with regulations provisions as well as the provisions of any law for the time being in force concerning ragging.
- ❖ The names of all the committee members along with their mobile numbers and emails are displayed at noticeable places in the College and on the College website. Complaints should be in written form or online.
- ❖ The complaint boxes are placed in the College at visible and can drop a written strategic places. Student's complaint in complaint box of College or to Convener of the Anti- Ragging Committee.

❖ CCTV cameras installed in the College at various points, the constant vigil of security guards and members of teaching/non-teaching staff, with due instructions from the Principal, taking rounds in the various locations of the College.

ACTIONS TO BE TAKEN AGAINST STUDENTS FOR INDULGING AND ABETTING RAGGING IN THE INSTITUTE:

In pursuance to the Judgement of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, Students who violate this rule will be instantly suspended from the Institute and accommodations for a period of one week. The mater will be placed before the Anti-Ragging Committee, which will review the incident of ragging and take action according to the due process of law.

- ✓ A strong, exemplary and justifiably harsh punishment would be meted out to the persons indulged in ragging to act as a deterrent against recurrence of such incidents.
- ✓ The Anti-Ragging Committee of the institution shall take an appropriate decision, with regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging.
- ✓ Punishment of ragging is suspension or expulsion or cancellation of Degree or Penal Action.
