







ANTI-RAGGING-CODE OF CONDUCT

1. Maintenance of discipline and code of conduct

The Institution committee members is responsible for the maintenance of discipline throughout the college. A clearly defined and elaborate Code of Conduct has been developed and the observance of the same is mandatory for all students. Any breach of the Code of conduct shall be deemed to be a breach of discipline and would render the defaulter punishable under the rules of the college. Students are, therefore advised to read carefully and abide by the Code of Conduct set out in brochure and help to ensure the maintenance of a congenial environment of knowledge and harmonious relationship among all stakeholders. They are also advised to ensure that they file with the college an affidavit duly signed by them and their parents/guardian in the prescribed form set out in prospectus regarding restraining from acts amounting to any indiscipline.

The Code of Conduct

The code of conduct to be observed by all students is as under

Clause - 1

Curbing indiscipline and misconduct by students

The following acts on the part of students, individually or collectively or in the group of two or more students or persons shall amount to indiscipline and misconduct.

- Physical assault, threat to use physical force, or any other intimidating behavior, within
 the premises of the college against any teacher, office, functionary, member of any
 authority, member of non-teaching staff or student of any such institution or unit or a
 visitor present on official invitation or for administrative or academic work in such
 premises.
- Causing disruption or disturbance in any manner in the teaching or any other work, the
 working of libraries, laboratories, facilities and amenities, admission and examination
 processes, administrative working, and in the college.
- 3. The use of loudspeakers or any other sound amplification devices in the premises of

- the college, except where the college has permitted such use of any educational, academic, co curricular, literacy, cultural or other extra curricular event.
- 4. Unruly and disorderly behavior during the course of any educational or academic excursion or tour or at any event or competition relating to curricular, co-curricular or literacy, culture, sports or other extra-curricular activities or other social educational or career related programme organised by the college.
- 5. Any disobedience of, or dissent against, the awards or decisions of Referees, Umpires, Judges, officiating at any event or competition related activities.
- 6. Any act or statement, or distribution or display of any document or literature, including the circulars, pamphlets, poster, press releases, etc., which adversely affects the public image of the college, or of any individual belonging to, or associated with, such institution.
- 7. The possession and distribution of objectionable goods or materials
- 8. Any act that creates, or tend to create, it will between groups of persons or promotes intolerance on religious, social, regional or linguistic grounds.
- 9. The possession, display, use or threat of any weapon.
- 10. Any act that interferes with the personal liberty of another person, or subjects other persons to indignity, or involves physical violence or use of abusive language.
- 11. Any violation on the dignity of female students.
- 12. Any violation of the status, dignity and honor of students belonging to the Scheduled Caste and the Schedule Tribes.
- 13. Any act or practice, whether verbal or otherwise, that is derogatory of women or amounts of sexual harassment.
- 14. The making of false statements or the submission of false documents

- 15. Any act amounting to unauthorised presence in, in or entry or trespass into specified premises and areas and any unauthorised retention or premises of college.
- 16. Any act that causes, encourages or implies the interference of outside persons, organisation or authorities in the functioning of college.
- 17. Unauthorised collection of funds.
- 18. Possession, distribution or consumption of alcoholic drinks, intoxicants, narcotic drugs, and other psychotropic substances and presence in the premises of college.
- 19. Any act involving moral turpitude.
- 20. Any act of resorting to or abetting ragging, as defined in clause -2.
- 21. Students shall avoid using cell phones in the campus, while listening to music and sharing visuals on cell phones or other electronic devices in the Campus is strictly prohibited.

Clause – 2

UGC regulation curbing the menace of Ragging in the College

In view of the UGC draft Regulation 2019 and Supreme Court of India's Letter No 370/04/XIA dated 26 February 2019 and 17 March 2019,

following provisions have been made by the College to curb ragging effectively in its campus,

Ragging" means the following:

Any conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise rear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

Punishable ingredients or Ragging: -

Abetment to ragging; Criminal conspiracy to ragging; Unlawful assembly and rioting while ragging; Public nuisance created during ragging; Public nuisance created during ragging; Violation of decency and morals through ragging; Injury to body, causing hurt or grievous hurt; Wrongful restraint; Wrongful confinement; Use of criminal force; Assaults as well as sexual offences or unnatural offences; Extortion; Criminal trespass; Offences against property; Criminal intimidation attempts to commit any all of the above mentioned offences against the victim (s); All other offences following from the definition of "Ragging"

Punishments:

- At the institution level- department upon the nature and gravity of the offence as
 established by the Anti-ragging committee of the college, the possible punishment for
 those found guilty of ragging at the suspension from attending classes and academic
 privileges.
- Withholding /Withdrawing Scholarship/fellowship and other benefits.
- Debarring from appearing in any test/examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, National or International meet, tournament, youth festival, etc.
- Rustication from the institution for period ranging from 1 to 4 semesters or one year.
- Expulsion from the Institution and consequent debarring from admission to any other institution fine of rupees 25,000/-.
- Collective punishment: when the person committing or abetting the crime of ragging are not identified of the college shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
