# **1. EXECUTIVE SUMMARY**

# **1.1 INTRODUCTION**

**Swargiya Rajesh Pilot Government College, Bandikui** is a pioneer co-educational institution in eastern Rajasthan that provides opportunities of education to the students coming from rural and economically weaker sections of the society in and around Bandikui. **Swargiya Rajesh Pilot Government College, Bandikui** was established in 1977, as a Commerce College with only 40 students, it is affiliated to the University of Rajasthan Jaipur. Since then, it has established many milestones in its journey towards excellence in higher education. In 1983 Arts stream was included in regular government scheme by the order of Rajasthan government. Science stream was started in 2003-04 under Self-financing scheme. Post graduate programmes in Hindi and Political Science were also inducted in the Self-financing scheme, whereas M.A. Political science and Science Stream was included in regular government scheme by the order of Rajasthan government in 2013-14 and Political Science in 2016. The name of the college was changed from Government College, Bandikui to Swargia Rajesh Pilot Government College, Bandikui in 2005 by the orders of State Government. The College was initially affiliated to University of Rajasthan Jaipur and still it is.

Swargiya Rajesh Pilot Government College Bandikui is located on Baswa Road Bandikui. Bandikui town is a sub-division of Dausa district. It is situated approx 90 km away from the Jaipur, capital of Rajasthan. It was the first Railway Junction of Rajasthan under British reign. Swargiya Rajesh Pilot Government College, Bandikui, has had a meteoric rise since its inception and has developed into a premier institution of education in eastern Rajasthan. It is spread over an area of Approx 10.1 hectare (28 Bigha and 9 Biswa) with a built-up area of 2 hectare. The college outreaches to the widest range of rural as well as urban youth.

Our motto is "Mein Man Shiv Sankalpam Astu" (from Yajurveda) which means "May My Heart Be Good".

#### Vision

'Sa Vidya Ya Vimuktaye' i.e. education is that which liberates. According to Gandhi, "Knowledge includes all training that is useful for the service of mankind, and liberation means freedom from all manner of servitude even in the present life." In the present scenario of globalization and a competitive market, our students have to undergo strenuous ordeals to reach out to their dreams. We strive to prepare them for the competitive world ahead, with their cultural and social values preserved within them.

#### Mission

#### Youth education and empowerment

The institution looks upon its students as living souls rather than as materials for manipulative fabrication. A

substantive part of the enrolment comes from semi-urban and rural locales of the area. They undergo dynamic and humanizing process of education before stepping into the competitive world. The aim is to help students rise above their localized milieu and possess a universal approach to become a part of mainstream education. We intend to prepare our youth not just as ICT ready, innovative, competitive and employable, but also as custodians of Indian values, culture and heritage.

The institution is driven by a vision and a mission for the realization of its objectives, socially uplifting, academically enriching through research orientation and empowering through value based holistic, learner-centered education. It enjoys wide popular acceptance, permanent University affiliation and a positive government support. It is well known as one of the most peaceful and academically oriented campuses in the State.

- The strength of the institution is its qualified and committed faculty, administrative staff, infrastructure, interactive smart classes, high speed internet access, and availability computing facility, facilities for scanning, printing and copying, academic ambience and the enthusiastic students.
- The faculty of this college is as writers, poets and speakers have been a constant source of motivation for the students to achieve higher goals in life.
- The institution is a nodal institution for Inspection of private/ B. Ed. colleges of the tehsil, Scholarships, AISHE, RACE, Grievances on CM Portal and many other government schemes.
- Long standing commitment to learner centric teaching and regular classes.
- A wide range of extracurricular activities aimed at the all-round personality development of students. Our students represent the district in activities on the state as well as national level.
- It encourages community service and social bonding.
- There is a high demand for admission in Undergraduate as well as Postgraduate courses. There is a constant demand in the area for raising the sanctioned seats showing the demand of the college.
- Availability of infrastructure for outdoor sports makes it convenient for the students to achieve their goals.
- Complete transparency in admissions, examinations, student union election and the organizational set up.
- Constant merit position in examination results in University of Rajasthan, Jaipur.
- A peaceful ambience despite a co-educational institution makes it a reputed place for students.

- Well established PG departments in Arts, and UG in Commerce and Science.

#### **Institutional Weakness**

- Exam-centric curriculum and inability to rise to the global standards.
- Annual examination system with substantial reliance on the University allotted marks and degree.
- Few multi-disciplinary research projects with national knowledge network.
- Funding for research is not being readily provided by UGC.
- Lack of adequate freedom to move out of state for participation in research activities
- Transfers by the State Government, leading to instability in academic environment.
- Posts of non-teaching staff (librarian, DPE and others) lying vacant for a long time.
- Vacant posts of ministerial staff and supporting staff.
- Low employability due to non-availability of Professional programs.
- Low computer: student ratio.
- Limited industry participation through consultancy and projects in college.
- Inadequate documentation of post qualification employment status of students and insufficient student tracking system.

#### **Institutional Opportunity**

- Most of the students are from a rural background for which higher education is essential for a secure future and social mobility. The college is the oldest and biggest institution of the area repute, and attracts large number of students from surrounding towns and villages.
- Subsidized fee and availability of various scholarships draws students for admissions.
- To start number of skill-development and vocational courses.
- Professional development programmes and trainings for teaching staff.
- Enhancing employability opportunities.
- Organization of National seminar and conferences.
- The college has opportunities to undertake location specific research work relevant to rural agrarian needs.
- Scope of further updation of ICT and other infrastructure.
- Scope of enhancing research facilities and providing ample freedom to teachers for collaborations with institutions across India and abroad.

- To establish Security training Agency, MOU and collaborations with external agencies. Reliance on Commissionerate, Jaipur for approval and execution of MOU. Placement of students is a challenge due to non-availability of professional courses.

# **1.3 CRITERIA WISE SUMMARY**

#### **Curricular Aspects**

- Swargia Rajesh Pilot Government College offers a wide range of Under Graduate and Post Graduate Programmes. The College is affiliated to University of Rajasthan, Jaipur and implements the curriculum prepared by the University.
- The College has developed a structured and documented process to ensure effective curriculum through a well-planned documentation process.
- At the beginning of the academic session, a class-wise and teacher-wise time table is prepared. The timetable is displayed on general notice board and departmental notice boards and is circulated in students' groups, college website and social media platforms.
- The college adopts Elective Course System and displays its subject combinations on the website. The four core subjects offered during the first year of graduation are Hindi, English, Elementary Computer Application and Anandam. The students pursuing graduation choose from a wide range of subject combinations in Arts(12), Science(2) and Commerce(1). The Master's programs also offer elective courses of contemporary significance. Presently, the college offers Under Graduation in 16 subjects, Post-Graduation in 02 and Ph. D guidance 04 subjects.
- The curriculum is updated periodically by the respective Board of Studies of the University of Rajasthan, Jaipur. Dr. Munna Lal Gurjar, Dr. Banshihar Dhar Rawat and Dr. Vinod Kumar Bairwa are the members of Board of Studies.
- Postgraduate and Undergraduate programmes are offered under the Annual Examination System.However, since 2023-24 semester system has been introduced in UG programs.

Feedback is regularly collected from the stakeholders and action is taken accordingly by the respective committees.

### **Teaching-learning and Evaluation**

- The institution has an online transparent procedure for admissions into different programmes. A duly constituted Admission Committee ensures the admission process strictly adheres to the statutory reservation provisions, with 21% O.B.C., 16% S.C., 12% S.T., 10% EWS and 5% M.B.C. Women candidates are given 3% bonus marks in admissions in graduate courses which are not offered by the local Government Girls' College.
- The college is affiliated to University of Rajasthan, Jaipur, and the students are assessed during the annual examination conducted by the affiliating university. The results are displayed on the university website.
- The institution has 29 qualified and committed teaching faculty members.
- It is equipped with the necessary and updated infrastructure in E-resources and ICT like Audio-Video tools, LCD projectors, Computers with LAN connections in every department, E-mitra Plus machine, Video conferencing room with E-podium including camera, screen and LED TV, open access e-resources.
- Students can approach the teachers for teaching-learning and counseling through mobile calling, whatsapp, face-book, you-tube and text messaging by various counseling cells and mentors.
- Our teacher established themselves as renowned creative writers and speakers in their respective fields and made the institution proud. This has set an example for students to be more creative and confident.

#### **Research, Innovations and Extension**

- The college has a Research Committee that, in collaboration with the IQAC promotes the research activities in the college.
- Innovation and Skill Development Committee plans and conducts the activities in alliance with the IQAC, distributing the student-centered activities to several committees specialized in their respective tasks.
- Study material in the form of PDF notes, links, books, graphs and other material was shared with students through social media platforms like whatsapp, face-book, You tube channels etc. as a medium of teaching during Covid-19 pandemic times.
- 6 teachers are registered as Ph. D supervisors in 4 different subjects & in different universities.
- Around 120 books and chapters in edited books were published by the faculty.
- Over 165 articles were published in refereed, peer reviewed and UGC listed journals.
- The faculty members attended workshops, trainings, induction programs and over 400 seminars and conferences and presented papers in the last five years.
- The institution has one NCC unit, Scout two units and three NSS units that conduct several extension activities and community services in and around the campus like plantation, cleanliness drives, blood donation camps etc.
- Diverse activities are organized in Women Cell, Planning Forum, YDC, Literary and Cultural and other cells.

#### **Infrastructure and Learning Resources**

- The institution has been keeping pace with the changing needs and the environment to meet the required infrastructural facilities. The total area of the campus is **Approx 71250** sq. m (**28 Bigha And 9 Biswa**) with a built-up area of **7300** sq.m. It has four buildings administrative block, science block, library block, arts block. There are 25 traditional classrooms, 1 lecture theatre, 7 Practical Laboratories, 1 Smart Classroom with Interactive Board. Each department individually is equipped with at least one computer and internet facility. It has 7 departmental staff rooms and one common staff room, one hall with smart classroom, one room each for NSS, NCC, Student Union, Sports, Girls Common room, YDC and Scouts (Rover and Ranger). The main building harbours the Administrative, Academic and Establishment Sections, Chambers of Principal and Vice-Principal and Accounts section. The college campus has two parking stands for two wheeler as well as four wheeler vehicles. To combat power cut situations, the college has one generator- 20 KWA, lodged in the campus. The College has adequate facilities for outdoor games. There are Volley Ball, Basket Ball, Kho-Kho, Kabaddi, Badminton courts and Cricket grounds. The main library has 21715 books, 10 magazines and newspapers and is semi automated with E-Library ILMS software and INFLIBNET.
- The college campus is pollution free, smoke free and environment friendly. It has a number of lush green lawns with benches and seats for students. Gandhi Stadium of Bandikui Railway is built in mid of the town that provides free access to our students for games. The campus is home to several varieties of trees, herbs and bushes, seasonal plants and birds.

#### **Student Support and Progression**

• The institution is linked up with the web portal of Commissionerate College Education, Rajasthan,

Jaipur, which provides on-line admission facilities with admission policy and prospectus including welfare schemes, reservation policy etc. Fee charged by the institution is less than that of other institutions. During the last 5 years from 2018 to 2023 approximately 6947 students that included SC, ST, OBC, and General and minority students were benefitted from scholarships that included CM scholarship, Social Welfare scholarship and NPS. Girls Mentoring Cell, Internal Complaints Committee and Grievance Redressal Cell, Sexual harassment Committee and Anti-Ragging Committees look after the grievances and resolve them in the minimum time.

- Student Progression- 8.62% UG students progressed for higher education and placement. .
- The Student Council plays an important role in contributing to the growth and progress of the institution. The office holders take an active part in all the main functions and activities of the college.
- The Alumni Association of the college is a registered body (S.NO. COOP/2022/DAUSA/203233, named Alumni Association Swargia Rajesh Pilot Government College Bandikui. The process for a separate SBI account of Alumni Association has been currently under process for the use of welfare activities.

#### **Governance, Leadership and Management**

- The leadership and governance of the college is well reflected in its vision and mission. The College works under the Commissionerate College Education Rajasthan, Jaipur headed by the Commissioner. More than 60 committees are framed at the beginning of every academic session. Mahavidlaya Vikas Samiti (College Development Committee) works as the liaison between society and this institution. Access, equity, inclusive education, regional development through better teaching learning and low fee structure are ensured at all times. The perspective plan is prepared by IQAC. One such strategic plan and its implementation well reflected in the repair and renovation of administration block, library, girl's toilet, and boy's urinals. Our college implements all the welfare schemes of the State Government and also tries to facilitate the same through various effective welfare measures to empower its faculty. The performance of every employee, teaching and non-teaching, is appraised by the Principal and reviewed by the competent authority on an annual basis. As sub district Nodal College our college provides teaching faculty to the government colleges of Dausa district, at Baswa, Girls Bandikui, Girls Sikandra, Mahuwa and Sikrai. The college is a sub district nodal college for CM Scholarships, NOC/ Inspections for private colleges, Sampark Portal, DRACE etc. With the widespread covid pandemic in 2019 and 2020, the teaching-learning process went on ceaseless and smooth. As many as 2100 video lectures and over 2600 PDF files were prepared by the faculty and shared among whats app groups of the students and other social network sites. ## 2.3 Teaching- Learning Process

2.3.1

Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

**Response:** 

For enhancing learning experiences the faculty members adopt many ways, for example, lecture method, interactive method, project and field work method, computer-assisted method, experiment method etc. Teaching and learning activities are made effective by these practices. Many teachers use the conventional black/white-board presentation methods, especially in mathematics, commerce and economics, where they teach mathematics and statistics as numerical solving. Also, some teachers use power point presentations and computer-based materials. For, they use the lectures of you-tube to make learning interesting besides the conventional oral presenting methods. Some Student centric methods are given below:

1 **Interactive methods:** The faculty members make learning interactive with students by motivating student participation in group discussion, debate, spot Speech, role- play, subject quiz, news analysis, educational games, discussion and questions and answers on current affairs, etc. These methods are used by various cells like NSS, Planning Forum, Scout Guide, Women Cell, NCC etc.

2 The Interactive method is the core of the traditional Class room discussions on various subject topics, widely used almost all departments. Further Especially, **ICT Enabled Teaching:** ICT enabled teaching includes Wi-Fi enabled campus, rooms, , Smart Class rooms, etc. The institution adopts modern pedagogy to enhance teaching-learning process. The institution has the essential equipments to support the faculty members and students.

**3 Experiential learning:** Experimental/Laboratory method is used in science subjects to acquaint the students with the facts through direct experience individually. Students verify the facts and laws of the subject with the help of experiments. Especially, the department of Chemistry, Physics, Botany, Zoology and Geography uses this method. Students take interest and learn things via experiential learning.

**4 Student Seminars:** The Student seminars are organized where in the papers is presented by students on contemporary topics to enrich their learning experience.

**5 Winter Camp Program:** The NSS organizes Four 1 day camps & One 7 day's special camp in December for NSS students, where they learn about the importance of cleanliness, participate in various learning activities and enhance their learning skill and capabilities.

**6** Group Learning Method: Group learning method is now being adopted through whatsapp group. Student share their notes and study material through this method. Whatsapp group are made by a student or by the teacher. They share the information to each other.

**7** Black-board presentation: In this method, each student is given a certain question. And student has to solve this problem in the black-board. The department of mathematics uses this method.

**8** Online Teaching: The College has a YouTube channel to provide online learning. Some faculty members also have their own individual You Tube channel on various subjects. Apart from this, the College has contributed to Rajiv Gandhi E-content, Gyan Sudha (Success Sathi) hosted by College Education Rajasthan on its website. Additionally, library provides Information and Library Network (INFLIBNET) access to journals and e books.

## **2.5 Evaluation Process and Reforms**

### 2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

**Response:** 

### **External Assessment**

College always follows the rules of the Internal/External Examination of University of Rajasthan. The evaluation is carried out as per guidelines of the University of Rajasthan at two levels:

### (1) Comprehensive External Examination (CEE) and

### (2) Internal Assessment (IA).

The CEE is controlled by the affiliated university. The institution is limited to adhere the directions and guidelines prescribed by the University. The role of the institution is to implement the directions from the University. The exam-related activities of CEE such as the preparation of question papers, exam supervision, answer-sheet evaluation, result declaration, etc. are carried out by the university. All information related to CEE is communicated in advance, and the same is communicated to the students accordingly. To implement examination rules and regulations as prescribed by the University, two types of committees are made, **Question paper committee** and **examination committee**.

#### **Internal Assessment**

Internal assessment comprises term end written practical examinations, practical assignments (records) and viva. Internal assessment is carried out in only in selective subjects, which includes all science subjects (UG) and Geography, Elementary Computer and Anandam. All Practical are conducted regularly and according to a well-planned and properly communicated schedule. All prescribed practical

are conducted and the students are given sufficient training in carrying them out. Thus, students are prepared to perform well in the practical examinations. All detail of internal assessment weightage is described in the additional file provided. To ensure free, fair and transparent internal assessment in final practical exams, external subject expert in each subject except the Anandam is appointed by the university. In Anadam internal assessment is carried out by the respective mentor and thus grading is accordingly forwarded to the university to be included in final result. The whole process is done in a transparent manner and to ensure transparency, supervisors are appointed to monitor and supervise the whole process.

### The Grievance Redressal System

The student can approach to concerned Professor/Exam Committee to clarify related grievances as per his/her requirement. After result declaration, students who are not satisfied with their marks can demand for photocopy of their related subject answer sheet through RTI. The student can apply for Rechecking/ Revaluation by filling up the Rechecking/ Revaluation forms by paying the university fees within given dates after declaration of result. The grievances regarding any misprinting in mark sheet, marked absent in mark sheet, enrollment issues etc. duly forwarded to the University for timely rectification.

#### **Response:**

OBE is an educational theory that bases each part of an educational system around goals (outcomes). By the end of the educational experience, each student should have achieved the goal. There is no single specified style of teaching or assessment in OBE; instead, classes, opportunities, and assessments should all help students achieve the specified outcomes. The role of the faculty adapts into instructor, trainer, facilitator, and/or mentor based on the outcomes targeted.

#### **Programme Outcomes (POs)**

Programme Outcomes are statements about the knowledge, skills and attitudes (attributes) the students should have at the end of a formal program (i.e., three-year Arts/Commerce/Science etc, Graduate program) in the college. POs are broader statements that describe what the students are expected to learn

and would be able to do after their Bachelor Degree. POs deal with the general aspect of graduation for a particular program, and the competencies and expertise a graduate will possess after completion of the programme.

#### **Programme Specific Outcomes (PSOs)**

Programme Specific Outcomes are statements that describe what the students should be able to do at the time of graduation. These are expected learning outcomes that will help the teacher to check for understanding and learning achieved by our students both in and outside the class. The PSOs are program specific.

#### **Course Outcomes (COs)**

POs and PSOs are attained through program specific Core Courses (Papers). These course-specific outcomes are called Course Outcomes. Course Outcomes (Cos) are narrower statements that describe what students are expected to know, and be able to do at the end of each course. The COs are statements that relate to the skills, knowledge, and behavior the students acquire as they go through a specific course within a program. The course outcomes are statements which are course-specific. They cover the core course related outcomes, and contribute to the overall attainment of the Program Outcomes. Each course is designed to meet (about 5–6) Course Outcomes.

#### How Course Outcomes achieved

The college has to adhere the programs and course schemes as prescribed by the affiliating university. As per scheme, **BA program** comprised of 3 subjects in choice based combination divided in 6 courses for each subject (a total 18 courses) excluding compulsory courses. B.Com program is comprised of 3 subjects divided in 6 courses for each subject (a total 18 courses) excluding compulsory courses. B.Sc program is comprised of 3 subjects divided in 9 courses for each subjects. There are 2 PG programs, political Science and Hindi Literature. Each PG program comprised of a total 9 courses. In previous year of PG, there are 4 compulsory courses while in final there are 5 courses. In MA(F) (Hindi Literature) 1 optional course to choose from 20 options and in MA (F) Political Science 2 optional courses to choose from a single group as prescribed by the university of Rajasthan.

#### **Response:**

The Institution follows a systematic procedure to evaluate the attainment of POs an Cos. The IQAC and the Result Analysis Team evaluate the program and course outcomes through different means. For this, we use both **Direct and Indirect methods** of evolution.

**Direct Method**, the weightage will be 100% end examinations carried out according to the university. In the direct method we assess the divisions of the passing students to quantify the CO & PO attainment. On the basis of this evaluation, suggestions have been discussed with the faculties.

**Indirect Method**, this method includes both qualitative and quantitative assessment through various activities by different forums. Further we collect the information through surveys/feed backs from students carried out by the IQAC. The college follow the guidelines of Affiliating University and the same is canvassed among the students by announcing in the class rooms, notices through WhatsApp groups, college website etc. Teachers regularly monitor the performance of individual student through various class room activities. Some of them are:

- Performance in terminal test is conducted once and each of them covers the evaluation of all the relevant COs attainment.
- Performance in annual Examination: It is descriptive metric for assessing whether all the COs are attained.

After every internal assessment evaluation, the teachers will get inputs for the attainment of COs of each subject. In case of poor performance an extra care will be taken such as giving extra assignments and tutorials. As soon as the results are announced, the results are analyzed and shared with all the teachers. With respect to Indirect Method, the following are the some of the initiatives

- Placement of Alumni: The records show the employment of the alumni in different Jobs like Administrative Officer, Bank POs, College Teachers, School Teacher, Advocates and corporate sector jobs.
- Feedback System: Systematic feedback on Course helped to assess the implementation of the Course Outcome.
- Annual meeting with Alumni and Parents also helped us to evaluate Cos.
- The college has utilized the system of Student Satisfaction Survey developed by NAAC. It helps the institute to have a clear evaluation of students' response on the Curriculum and Teaching Learning.

#### The evaluation process involved the following steps:

- 1. Formulation and publication of Program-Specific Outcomes (PSOs), Program Outcomes (POs) and Course Outcomes (COs): The syllabus of all the programs are designed by University of Rajasthan and College has no direct role on this. Our college is still working on the formulation of these outcomes in the revised syllabi.
- 2. Assessment Measures: Various assessment measures are employed to evaluate the attainment of outcomes. Two assessment methods are used by the college to assess the attainment of PO, PSOs and COs. These are Direct assessment methods & Indirect assessment
- 3. **Data Collection and Analysis:** Data on student performance and achievement were collected using both qualitative and quantitative methods. This included analyzing examination results, project reports, feedback surveys of alumni, employers, and industry placement records.
- 4. Evaluation Criteria: Benchmarks or criteria were established to determine the level of

attainment for each outcome.

- 1. The institution has adequate infrastructure for academics and activities. It makes optimal use of buildings and also ensures sufficient space for all departments and common facilities. It is spread over an area of 73096.481 sq metres with a built-up area of 7300 Sq metre. Modern laboratories and departments are available, and they are properly equipped.
- 2. The physical facilities in the college are as follows:
- 3. The College Building is classified in 5 blocks Administrative block, Science block, Library block, Commerce block & PG block(combined), Arts block and. There are 26 (including 5 rooms used for other purposes also as needed) traditional classrooms.
- 4. 05 Practical Laboratories, 1 Smart Classroom with LCD. Each department individually is equipped with an internet facility.
- 5. The chamber of the principal is situated in the main building with the administrative academic establishment and account sections.
- 6. It has six departmental staff rooms and one common staff room, as well as a seminar hall and rooms for NSS, NCC, Student Union, Sports, Rover, YDC, and IQAC & UGC, Store Room, Gandhi Study Centre & Yoga Centre.
- 7. The College has a computer Lab for student's usage.
- 8. The college has a smart class room equipped with fine quality cameras, computers with latest software for live streaming lectures facility.
- 9. There is a separate well-furnished Common Room for girls with attached facility.
- 10. There are adequate toilets for student. The college campus has two parking stands for two wheelers as well as four wheeler vehicles.
- 11. The college has one 20 KVA generator located on campus and inverters to handle power cuts.
- 12. The College has adequate game facilities. Table Tennis, Volleyball, Basket Ball, Kho-Kho, Kabaddi, Shuttle Badminton courts, as well as Cricket and Athletics grounds, are available.
- 1. A hall with an area of 1500 sq. ft. and a seating capacity of 150 and one open theatre are available for cultural activities. The college has its own sound system for the college functions.
- 2. The main library contains 21715 books, magazines, and newspapers, and it is fully automated using E-Library ILMS software. The library building includes a main hall, a staff room, and three student reading rooms.

- 3. The college has two bore wells, two overhead water tanks with a capacity of about 1500 litres, and three water coolers.
- 4. Two water huts with water filter amenities and water coolers are available for students.
- 5. The Department of Botany at the institution maintains a botanical garden with numerous types of herbal and medicinal plants.
- 6. The campus boasts a wide variety of trees and plants approx 2200, as well as lush green grass. According to the seasons, it is home to a wide diversity of birds and insects.

Library is automated with digital facilities using Integrated Library Management System (ILMS), adequate subscriptions to e-resources and journals are made. The library is optimally used by the faculty and students

#### **Response:**

The College is dedicated to provide excellence in Services and supporting academic inquiry, research and learning needs of the students and faculties. The library is located in the middle heart of the college campus, in a separate building which constitutes a well-furnished reading space, textbook section, reference section, issuing counter. The Library covers an area of 7720 square feet. A main hall, a stack room, and two reading rooms can accommodate 200 students. In the absence of a full -time Librarian, it is overseen by a committee of teachers.

The library has a large stock of 21715 books, journals and e-resources. There are also competition related books, magazines and news paper available for students. The library is well equipped with computer, printer, barcode reader and bar code printer. Internet facility is available in the Library. All members of the staff, students, research scholars and non-teaching staff of the College is members of the library works from 11:00 am to 4:00 pm on all working days of the week.

The budget for library is allotted by the government and accordingly new book purchase has been done in consultation and recommendation of the related faculty members.

There are four registers of the books: General, CDC, Book Bank and Remedial. Books under each register are 17713, 2647, 1123 and 232 respectively.

The college has a collection of e-content developed by faculty members available on college

YouTube channel, NPTEL video lecture series, Rajiv Gandhi E-content bank, Gyan Sudha and Gyan Doot. Further some faculty members also maintain their own you tube channel on various subjects and content. The college has adopted a community serving approach by establishing a book bank has been established for poor students, which is a collection of donated books. The college library is automated since 2019 for the convenience of students and faculty members. All the books are bar-coded, by using the software LibSoft.

The library has a membership of the N-List (National Library and Information Services- Infrastructure for Scholarly Content) INFLIBNET Centre, an IUC of UGC that provides students and teachers with easy access to a variety of reading resources.

E-journals from many reputed publishers such as Royal Society of Chemistry, McGraw Hill,

Springer eBook, JSTOR, Elsevier, Taylor and Francis, Oxford University Press, Sage Publication and Cambridge University Press, etc. and thousands of e-books) through the N-LIST program of INFLIBNET, the membership of which is renewed on annual basis by the college library.

The college's Information technology facilities are updated as needed. Traditional way of teaching has been gradually supplemented with multi-media teaching pedagogy. The college has consistently updated its Wi-Fi and IT infrastructure. Wi-Fi is available in the administrative block with 5 Wi-Fi routers. This Wi-Fi is used in Principal Room, Account Section, Faculty Section, IQAC and UGC Room. Wi-Fi access is available in the library, Staff Room, NCC, Computer Lab, Science Block room through Wi-Fi routers. These Wi-Fi routers are connected through LAN. The college has **6 optical fiber net connections** (BSNL) with bandwidth of 100 Mbps of each connection.

#### IT Infrastructure

**Smart classrooms:** There is one room equipped with modern IT facilities. Departments use these classrooms for teaching, holding seminars, and hosting workshops. The college's video conferencing room is used for virtual meetings with the Commissionerate of College Education. During the pandemic, a large number of state-level virtual seminars and extension-lectures were delivered via E-classroom.

- 1.Smart Class room is equipped with E-podium for recording e-lectures, LCD Screen, Projector(1), Audio System, PC(1), Camera(2), mic with internet facility.

#### **Response:**

Administrative Structure: Main components of the organizational structure of the college: The administrative system of the institute is managed under the leadership of Commissioner of College

Education, Rajasthan, Jaipur. The Commissioner is responsible for running the government/private colleges in Rajasthan. At the institute level the principal is its head. At the college level it has been decentralized into establishment, accounts and academic sections. As a part of decentralization the staff includes senior academic faculty members, subject faculty members, and clerks. Besides, various allotted tasks are also carried out effectively by the staff, librarian, laboratory assistant, laboratory boy etc. Different committees are formed for different tasks.

**Finance:** Every financial matter is managed strictly as per GFAR (General Financial) and accounting rules of the Government of Rajasthan) financial issues are handled in the institutions. By Assistant Account Officer (AAO) who follows GFAR guidelines.

**College Development Committee**: Principal, Local Member of Parliament, Local Member of Legislative Assembly, District Collector, Assistant Director College Education, Local Teacher Representative, Two Distinguished Citizens, Two Parents Students and a student union representative from the administrative structure of the college. The committee manages to provide and maintain the necessary material.

**Service Rules:** The College is a government institution, hence all the service rules framed by the State Government are ensured to be followed in letter and spirit.

Recruitment: The recruitment process of faculty members is done by Rajasthan Public Service Commission and the recruitment of non-teaching staff is done by Rajasthan Staff Selection Board. All personnel are recruited on the basis of government policy. Provision for compassionate appointment in case of death of an employee has also been made as per the rules of Rajasthan Government.

**Promotion Policies:** The Commissionerate conducts regular promotions through departmental channel. Promotion Committee (DPC) is constituted as per the rules of the Government of Rajasthan.

**Grievance Redressal:** The college has an Internal Grievance Redressal Committee, an Anti-Ragging Cell and a Anti-Harassment of Women Committee is concerned with the investigation of complaints, these committees take action on the complaints effectively.

#### Institutional strategies for the mobilization of funds and the optimal utilization of resources

The college is adhere to comply with General Finance & Account Rules i.e., GF & AR of the State of Rajasthan to use the available financial resources and mobilize the fund. The financial operations and processes done with the charge of Drawing &Disbursing Officer (DDO), assigned to the principal or senior faculty member. The Assistant Account officer (AAO) office keeps a record and monitor financial support received and used.

**State government: The state government** allocates a specific amount to Government College for various purposes mostly including development, maintenance and other expenses. The state budget and grants are released for salary, travel allowance (T.A.), medical, office expenses, construction and maintenance, lab grant, books, journals, etc.

**College Development Committee:** There is CDC fund receives fund from student fees @ of Rs. 200 to meet the various expenses of development, maintains and repair. There is a governing committee (registered) to take decisions pertaining to various development plans.

**Personal Deposit Account:** The College also maintains a PD account also known as Boys fund in treasury. This fund receives funding from the fees deposited by each student. According to fees structure, this fund is further maintained under different 20 subheads. This fund is primarily used to meet the expenses of student centric activities and related purchases.

Alumni Association Fund: As the Alumni Association is registered on 23.02.2023 its fund creation is currently in process.

The institution conducts internal and external financial audits as:

#### Internal Audit-

The AAO and DDO are primarily responsible for financial transactions, however to keep the checks & balances there are some committees monitor, check and audit internally all financial business. 1. Account Committee, 2. Purchase committee, 3. Store Committee, 4. Income Tax Committee, 5. GeM Portal Committee.

The accounts of the College Development Committee are also audited by a **Chartered Accountant** hired by the College.

The External audit process: The external Audit are done as by:

- The Auditor General (AG) office of the Government of Rajasthan. The AG office on a periodical basis (every 3years) audits accounts of the college in length and detail. The most recent audit was done in *November2018*. During the AG audit most of the objections are clarified by the account section, however substantial objection are communicated by the AG office in form of paras after completion of the audit process.
- **Directorate Internal Inspection, GoR** also undertakes periodic internal audits of accounts. The last audit was done in between 28.05.2018 to 30.06.2018.
- The Directorate Internal Inspection, GoR also carries a special audit and inspections of Store account statements, stock entries and also undertakes physical verification of all articles under store. Such last store audit was done in between 01.06.2022 to 18.06.2022
- The CDC account of college is audited by hired CA Mr. A.K. Thakuria & Co. at the end of every financial year.

#### Context

During The Paris Agreement on the Climate change 2015, the world agreed to limit the rise in global average temperature less than 20 or in best case scenario less than 1.50. India has also agreed with this great responsibility and set an ambitious target net zero emission by 2070. Therefore as a responsible institution of the society, we understand our responsibility towards the environment and adopted policies and traditions that promote environmental protection.

#### Practice

- 1. Creation of green area: About 2000 trees have been developed with the help of Forest Department in about 8 hectare areas in the college campus.
- 2. Creation of plastic free zone: Keeping in view the fact that plastic is extremely harmful and dangerous for health; slogans related to it have been written in the entire college campus keeping the entire college campus plastic free.
- 3. Awareness about Environment Conservation: Various participations and lectures were organized on environmental protection issues by developing Botanical Garden in the college.
- **Plantation Drive:** Sapling plantation campaign is conducted every year by the college NCC, NSS, Scouts and Eco Club.
- Water for birds' campaign- Every year forums like scout & Guides (Ranger and Rovers), NSS and NCC have been tied Parinda (water Bowls) at trees to provide water to birds in the season of summer.
- Plastic free and use low emission vehicle (Undertaking by staff): The staff of the college has given an undertaking by stating that they would not use plastic and minimize the use of fossil fuelled vehicles.
- **Development of Botanical Garden:** The College has taken imitative to develop a Botanical Garden to facilitate Botany student to learn with nature.
- Use of energy efficient Devices: The college is now more sensitive towards the power consumption of each electrical and electronic device to save the energy and the staff is directed to switch off all electric appliances when not in use.

- Green audit and Energy Audits are undertaken.

Lack of financial Resources and Procedural hurdle: Being a government college. The college has to abide by the financial rules of the Government. Therefore prompt and required actions and financial permissions are difficult to obtain.

Lack of public support: The neighbourhood community is not interested in the development and initiatives of the college.
