FAQs (Indemnity Bond)

1. Whether Property of Grand Parents/ Joint property of family members can be mentioned in the Indemnity bond?

Candidate can mention Property of Grand Parents/ Joint property of family members in the Indemnity bond

2. Which documents should be submitted for property proof? Should these be self-attested by the owner of the property?

Jamabandi / Registry/ Patta to be taken from the candidate for property proof. These documents should be self-attested by the owners of the property.

3. It is mentioned in the Indemnity bond that property value should be more than 1.5 times of total scholarship amount. What if the property value is less than this amount?

Candidate has to mention property details possessed by the candidate or his/her family irrespective of the value of the property.

4. If no property is possessed by the candidate and his/her family then which document is to be submitted in this regard? (an affidavit declaring that no property is owned by candidate or his/her parents)

If no property is possessed by the candidate or his/her family then he has to submit an affidavit on 100 Rs. Non judicial stamp declaring that no property is owned by candidate and his/her family

5. Whether sureties have to be Government officials or not?

Preferably sureties have to be Government officials (Gazetted or non Gazetted), in case candidate doesn't have government sureties then any other responsible persons can also be his/her sureties. In case of Government sureties, their Govt. Id proofs should also be submitted.

6. Can parent/sibling/spouse be a surety or a witness?

Yes, parent/sibling/spouse can be a surety or a witness

7. Can witness and surety be same?

Yes, witness and surety can be same.

8. Do we have to take ID proof of sureties and witnesses?

ID proof (Aadhar card) of sureties and witnesses is to be taken with Indemnity bond.

9. If parent is giving Indemnity bond then should language be changed accordingly for the parent as indemnifier or parent can sign it on behalf of the candidate (candidate is Indemnifier)?

Parent can give Indemnity bond for the candidate if candidate is a minor or is not in India. Language of the indemnity bond can be changed accordingly if the parent is giving the indemnity bond as an Indemnifier.

10. What is to be written in vide G.O. in the indemnity bond?
