RULES AND REGULATION (Revaluation)

FOR DIPLOMA COURSES IN ENGINEERING AND NON ENGINEERING SEMESTER SCHEME 2020-21

FOR THE SESSION 2023-2024 AND ONWARDS

- 1. A student who wishes to apply for revaluation of answer –book (s) must submit online application on the portal wide his/her SSOID before expiry of 07 days excluding the date of the declaration of his examination result. Application not submitted online by the due date shall be rejected. Incomplete application forms will be rejected.
- 2. The fee for revaluation will be Rs. 400/- per paper.
- 3. The revaluation fee will not be refunded in any case.
- 4. Revaluation of answer books shall not be permitted in more than 50% of the theory papers in which a student appeared for each semester/year in which he/she is appearing as regular and/or Ex student in an examination. Where the number of papers in a semester/year in which a student appeared at an examination happens to be an odd number, it will be increased by one.
- 5. Notwithstanding the aforesaid provisions, revaluation of answer-books shall not be permitted in respect of practical examination, Internal Assessment, class tests, Summer Internship, Anandam, Project and Viva-voce.
- 6. (i) If the award of the re-evaluator(R) is more or less than the main Examiner (M) subject to a limit of 10% of the main examiner award (M), the award of the main examiner (M) shall be considered as the final marks.
 - (ii) In case the award of the re-evaluator(R) is more or less than the award of main examiner (M) by above 10%, the average of (M) and (R) shall be considered as the final marks.
 - (iii) Those students who are in final semester of diploma and apply for revaluation, their final semester mark sheet will not be printed till the result of revaluation declares.
- 7. The answer-books(S) shall not be subject to any inspection or production before any external or internal authority except at the instance of Chairman.
- 8. A student who is declared eligible for taking examination of back paper(S) as a result of revaluation shall be permitted to appear at the next main examination related to his/her back papers or if the same is already over, at the time of next main examination related to his/her back papers. Such a student will also be eligible to appear at the next higher examination as an ex-student, if such facility exists for the examination concerned.
- 9. A student desirous to apply for re-evaluation may treat his result as "NO Change" for purposes of submission of application forms for appearing at the ensuing examination within due date.
- 10. Students should presume their result as unchanged for all purposed until declaration of the result of revaluation their scripts.
- 11. All court case shall be subject to the jurisdiction of the Board at Jodhpur not at any other place.
