ORDER

Sub:- Amendment in the Rajasthan Travelling Allowance Rules.

The Governor has been pleased to order that the following amendments shall be made in the Rajasthan Travelling Allowance Rules, 1971, as amended vide FD order of even number dated 13.03.2008, namely: -

- (1) At the end of Note 4 under "Explanation" appearing below sub-rule (4) of Rule 3, the existing word "to" shall be substituted by the word "two".
- (2) In existing Appendix "Travelling Allowance to Government servants on transfer", appended to Rule 17, in col. 2 - "Cost of carriage of conveyance", the existing word "are" appearing in third line of Note 2 under heading "by Rail" shall be deleted.
- (3) In appendix - II "Mileage Allowance for Travel by Road", in col-3 - "Ordinary Rates" against "Category of Government servants" "A & B", the existing item (b) shall be substituted by the following, namely:-
"(b) Mileage Allowance for journey to reach Airport/Railway Station/Bus Stand from duty point/residence and vice versa.

Place	Rate
(i) Jaipur	Rs. 60/-
(ii) Jodhpur, Udaipur, Kota, Bikaner and Ajmer	Rs. 45/-
(iii) All state Capitals in India (except Jaipur) including Delhi	Actual charges paid in payment of fare for Taxi, Auto Rickshaw, Tonga, Scooter, Bus, Rail, Metro Train etc.
(iv) Other places.	Rs. 25/-

- (4) In Appendix - II "Mileage Allowance for Travel by Road", in col. 3 - "Ordinary Rates" against "Category of Government servants" "C, D & E" the existing item (b) shall be substituted by the following, namely:-

"(b) Mileage Allowance for journey to reach Airport/Railway Station/Bus Stand from duty point/residence and vice versa.

Place	Rate
(i) Jaipur	Rs. 50/-
(ii) Jodhpur, Udaipur, Kota, Bikaner and Ajmer	Rs. 40/-
(iii) All state Capitals in India (except Jaipur) including Delhi	Actual charges paid in payment of fare for Taxi, Auto Rickshaw, Tonga, Scooter, Bus, Rail, Metro Train etc.
(iv) Other places.	Rs. 25/-

- (5) In Appendix - II "Mileage Allowance For Travel by Road", in Col. 3 - "Ordinary Rates" in "Exception" between the word "duty point" and "and vice versa", the word "/residence" shall be inserted.

- (6) In Schedule to Appendix IV (A) and (B) "Condition for admissibility of daily Allowance" to Rule 8 (2), the existing Para 3 shall be substituted by the following:-

"3. Daily Allowance shall be admissible upto a period of 30 days for continuous halt at a particular station. In case the halt is continued beyond a period of 30 days but upto 60 days the Administrative Department concerned will be competent to sanction the same. For a halt beyond a period of 60 days but upto 180 days, sanction of Government in the Finance Department will be necessary. For halt of more than 180 days no daily allowance will be admissible".

- (7) Existing column 3 "For family" of Appendix "Travelling Allowance to Government servants on transfer" to Rule 17 (1) shall be substituted by the following:-

"One extra fare for each member of the family. However, in respect of the children accompanying the employee, half fare or full fare actually paid as per the tariff Regulations of Railways, shall be admissible."

- (8) Existing column 5 "For family" of Appendix "Travelling Allowance to Government servants on transfer" to Rule 17 (1) shall be Substituted by the following:-

"One extra fare for each member of the family. However, in respect of the children accompanying the employee, half fare or full fare actually paid as per the tariff Regulations, shall be admissible."

- (9) Existing column 2 "Actual rail fare of class of accommodation" for Category "B" Government servants of Appendix- 1 "Rate of Admissibility of Mileage allowance for travel by Rail" to Rule 8 (1) shall be Substituted by the following:-

"Actual rail fare including reservation charges of A.C. Three Tier (May travel in Two Tier if the train does not have Three Tier A.C. coach) or A.C. Chair Car (excluding Executive Class)."

- (10) Existing item 2 of column 4 "Remarks" of Appendix - 1 "Rate of admissibility of mileage Allowance for travel by Rail" to Rule 8 (1) shall be Substituted by the following:-


"2. For this purpose (except travel by second class Non A/C) the Government servant concerned shall enclose ticket/cash receipt (in original or photocopy) issued by Railway authorities in the Travelling Allowance Bill."

- (11) Existing Note (iv) of column 3 of Appendix - II "Mileage Allowance for Travel By Road" to Rule 8 (1) shall be Substituted by the following:-

"3. Every Government servant who travels on duty in Air conditioned/deluxe (including Semi-Deluxe)/Volvo or any Upper Class Bus shall be required to attach the bus ticket or its photocopy in the Travelling Allowance Bill."

These orders shall come into force with immediate effect.
