State Government of Andhra Pradesh and others etc. and later judgements.

In the event of infringement/contravention or non-compliance of any of the conditions, guidelines, norms, and regulations prescribed by the AICTE from time to time the AICTE or a body or person(s) authorised by it shall be free to take measures for withdrawal of the approval or recognition without consideration of any related issues and that liabilities arising out of such withdrawal would be solely that of the Management/Trust/Society and/or Institutions. AICTE may inspect the institution at any time it may deem fit to verify the progress of said institute.

You are requested to kindly take appropriate action to implement the decision of the AICTE and communicate the progress made in regard to the North-West Regional Committee of the AICTE under intimation to this office.
