Introduction and Objective of the Scheme

Hon'ble Chief Minister of Rajasthan, Sh. Ashok Ghelot has announced this Scheme on 20.08.2021 (on the occasion of birth anniversary of late Shri Rajiv Gandhi, former Prime Minister of India)

The objective of the Scheme is to provide financial assistance to students of Rajasthan to study in top foreign universities in the world. The scheme was launched on 05.10.2021

Important Eligibility Criterions

Bonafide Resident of Rajasthan

Admitted / Obtained offer letter in top 150 Universities in the world as per latest QS world university ranking.

All disciplines are allowed for UG, PG, Ph.D. and Post Doc.

 Maximum 15 scholarship awards for Engineering, Medical and Dentistry for UG courses in Top 25 Universities – subject wise QS ranking

Number of Scholarships & Salient features

200 Scholarships awards in a year.

Highest priority in selection of students whose parents gross income is less than 8 Lacs / annum.

Higher income group candidates may also be considered, if scholarship awards are lying vacant.

Selection on the basis of QS World University ranking

Minimum 30 % seats are earmarked for girls candidates.

Financial benefits in the scheme

1. Category E1(Parents Gross Income Less than Rs 8 Lacs/annum)

→ Tuition Fees - 100 % + Other charges - 100 % (maximum 12 lacs/annum)

2. Category E2 (Parents Gross Income Rs 8 - 25 Lacs/annum)

 \rightarrow Tuition Fees - 100 % + Other charges - 50 %

3. Category E3 (Parents Gross Income higher than Rs 25 Lacs/annum)

→ Tuition Fees - 100 % + Other charges- Nil

4. Any other Scholarship/Sponsorship/Fellowship will be deducted from the tuition fees of the student.

* Any other expenses other than tuition fees will be considered as 'Other Charges'. Accommodation fee would be included in other charges.

State Government may revise guidelines from time to time and benefits will be given accordingly.



- Last Exam Passed Certificate
- Passport
- Indemnity Bond (Required at the time of selection)

Where/How to fill

- Click on "Online Scholarship" Tab
- Can be filled at nearest e-mitra centre or by Self, through Laptop, Desktop or Mobile.
- Online application can be filled through SSO_ID only and updating Janaadhar ID in it.
- Before filling, update domicile, bank details, caste, income etc. on Janaadhar.

FAQs

1. Are the student of other States domicile eligible for the Scholarship.

Ans. No, the scholarship is available only for the students of Rajasthan State domicile.

2. Is there any age criteria for availing scholarship?

Ans. Yes, the age of the student should not be more than 35 Years as on 1st July of the selection year.

3. Is Scholarship available for only those students whose family's gross income is less than 8 lacs/ annum ?

Ans. No, Students students whose family's gross income is 8 lacs/ annum or higher can also apply. Their applications may be considered provided scholarships awards are lying vacant.

4. Suppose 30 seats are lying vacant (after providing scholarship awards to those students whose family's gross income is less than 8 lacs/ annum) and there are 60 eligible candidates in higher income categories. How the selection will be made ?

Ans. Selection will be made among the students whose family's gross income is 8 lacs/ annum or higher, according to merit criterion i.e. firstly the QS world University ranking will be considered, secondly the subject ranking will be considered and thirdly the qualifying degree marks will be considered.

There will not be any differentiation for Selection/Merit among students whose family's gross income is 8 lacs/ annum or higher.

FAQs

- How many scholarship awards are earmarked for female candidates ?
 Ans. Minimum 30 % of the available scholarship awards.
- 6. In case female seats are not filled. Are earmarked female scholarship awards may be filled by the candidates whose family's gross income is 8 lacs/ annum or higher during the selection process ?

Ans. Earmarked female scholarship awards may be filled by students whose family's gross income is 8 lacs/ annum or higher
provided male candidates (whose family's gross income is less than 8 lacs/ annum) are also not available during the selection process.

7. Is Scholarship available in certain subjects/ discipline/field of the study.

Ans. No, Now it is made available in all subjects/ discipline/field of the study

8. Is Scholarship available in all subjects/ discipline/field of the study at undergraduate (UG) level ?

Ans. Yes, it is available in all subjects/ discipline/field of the study at UG level. However, there are only 15 scholarship awards for Engineering and Technology, Medicine and Dentistry (combined).

- Can I Edit the information already saved on the online portal and upto what time.
 Ans. You can edit information till you "submit" the application finally on the online portal.
- 10. If I avail this scholarship for UG degree , can I apply again for this scholarship for PG /Ph.D/Post Doc. Degrees.

Ans. No, this will be awarded once in lifetime.
