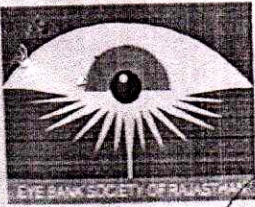

Dear Madam,

I am writing this letter with reference to telephonic conversation with you by Dr. Deepali Bhargava, Joint Director College Education (Retd.) about the possibility of organizing awareness programmes about Eye donation in Government and Private Colleges of Rajasthan under your Jurisdiction.

Here I would like to brief you about the Eye Bank Society of Rajasthan (EBSR). The EBSR, a non-profit organization, is a Registered Society dedicated to spreading awareness about Eye Donation. The Society is also retrieving corneas from persons who have died and thus providing corneas for transplantation on corneal blind persons for restoration of their vision, thereby contributing to National Programme of Eradication of Blindness. So far, we have harvested about 17353 corneas and have transplanted 11200 corneas facilitating restoration of eyesight of 11200 corneal blind people. To provide better coverage in Rajasthan, we have opened our Chapters/Eye Collection Centers in 10 cities of the State.

The cornea is the outer, transparent clear surface at the front of the eye that covers the Iris, pupil and interior chamber. When it is transparent, the light can enter through it and a person can see. However, if due to some injuries or infection, it is damaged and becomes opaque, then the person cannot see. Cornea cannot be manufactured in laboratory. For restoration of eyesight of corneal blind person, we are dependent upon cornea of a dead person, it is retrieved within 6 to 8 hours of the death.

Thus the cornea is retrieved after death of a person when it is not of any use for the dead person. It is ultimately destroyed during cremation or after burial. However if corneas of a healthy person are donated within 6 to 8 hours of his death, eyesight of two corneal blindness persons can be restored. Corneas can be collected whether death takes place in hospitals or at home. But very few family members of a deceased persons come forward for donation either due to lack of knowledge or awareness about

eye donation. Thus we annually collect only about 2000 corneas which can increase manifold if there is a widespread awareness about eye donation and its acceptance.

The EBSR regularly organizes awareness programmes for spreading message of eye donation to public at large. We also regularly organize awareness cum sensitization programmes in colleges where we have some contact. However if instructions are issued by your Commissionerate for organize awareness programmes and actively help in eye donation, then we can organize more awareness programmes in the colleges. I have been informed that NSS Camps are being organised in the month of December. In case, we are given just one hour, our team can come to your Colleges or NSS camps and explain them about necessity of eye donation. This will motivate faculty members and students to more pro-actively help in eye donation and thereby contributing to the noble cause of providing eyesight to the corneally blind persons. If you require any information or if there are any queries, then we will be very glad to respond and provide the necessary information.

We are very hopeful that our request of organizing awareness programmes in Government and Private colleges and also during NSS camps will get a positive response from you and you will necessary instructions to colleges.
