Dear Chief Secretary,

In recent times, there has been a noticeable rise in the frequency, duration, and intensity of heat waves throughout the nation. Even in states that were previously thought to be particularly unlikely, heat wave incidents have been reported. As per the India Meteorological Department (IMD) seasonal outlook for Temperature (April to June 2024) on 01 April 2024, in most parts of the country, maximum temperature, minimum temperature, as well as the number of Heatwave days are likely to be above normal. NDMA has already issued national guidelines for preparing Heat Wave Action Plans (HAP) in the City, District and State levels. We need further improvement in our Heat Wave preparedness towards achieving "zero mortality" in 2024.

In collaboration with MyGov, we are conducting an awareness campaign by actively engaging the public, including students in Poster-making and Essay writing contests on 'Heat Wave' from 08 May to 22nd May 2024. These contests, as per the details given under, will be open for 15 days:
