**Subject: Regarding Submission of SSR to SLQAC for NAAC Accreditation**

Dear Sir / Madam

For ensuring quality improvement, availing scholarships and financial support etc. in higher educational institutions (HEIs), NAAC accreditation is mandatory as per New Education Policy (NEP) 2020.

Also, as per University Grants Commission (Mandatory Assessment and Accreditation of higher Educational Institutions), Regulations, 2012 (clause 4.1 and 4.2) the following needs to be taken into account.

- 4.1 It shall be mandatory for each Higher Educational Institution to get accredited by the Accreditation Agency after passing out of two batches or six years, whichever is earlier, in accordance with the norms and methodology prescribed by such agency or the Commission, as the case may be.
- 4.2 Every Higher Educational Institution, which has completed six years of existence or two batches having passed out, whichever is earlier, shall apply within six months from the date of coming into force of these regulations, to the Accreditation Agency for accreditation.

In the light of these regulations, the colleges (applying for NNAAC cycle 1) which have completed six years of establishment or two batches of graduates having passed out, whichever is earlier were asked to submit their SSR to SLQAC. Despite holding trainings for them for preparing SSR, guiding them through the process of accreditation and assessment, repeated reminders on Mail and WhatsApp groups, SSR has not yet been received from these colleges by SLQAC.

The colleges which have been accredited at least once by NAAC and are due for the next cycle (2<sup>nd</sup>/3<sup>rd</sup>/4<sup>th</sup>) of accreditation are also required to submit their SSR to SLQAC, if not yet done so.

This matter is being taken up with utmost seriousness both by SLQAC and the Hon'ble Commissioner, College Education, Rajasthan as accreditation by NAAC is being monitored by state government at the highest level.

**Please note that colleges submitting IQA after 31<sup>st</sup> May 2024 will have to include the next academic session (2023-24) for accreditation.**

This bears approval of the competent authority.
