#### Dear Madam/Sir,

With reference to the above mentioned subject, it has been observed that government colleges in Rajasthan applying for NAAC accreditation are facing difficulties with the payment process on the portal, as NAAC currently only accepts online payments through net banking and credit/debit cards.

In this context, the State Level Quality Assurance Cell (SLQAC) addressed this matter with the highest priority and seriousness. Earnest efforts were made to inform NAAC about the concerns of these colleges, and a respectful request was submitted for the implementation of alternative payment methods for government colleges in Rajasthan

Hence, as special case, the Hon'ble Director, NAAC has agreed to permit Government Colleges in Rajasthan to pay fees directly from Government Treasury by NEFT/RTGS to NAAC with following two important conditions for smooth and efficient process:

- 1. Upon payment, colleges will inform NAAC Finance Department immediately with details of transaction by email to <u>finance@naac.org.in</u>
- 2. Institutions will update payment details on NAAC portal for verification and further processing within 2-3 days of payment."
