4. Science & Engineering (Includes Space Engineering, Nuclear Science, Informa Technology, Reserch & Development in Science & its allied subjects etc.)
5. Trade and Industry (Includes Banking, Economic Activities, Manager Promotion of Tourism Business etc.)
6. Medicine (Includes medical research, distinction/specialization in Ayur, Homeopathy, Sidhha, Allopathy, Naturopathy etc.)
7. Literature & Education (Includes Journalism, Teaching, Book compo Literature, Poetry, Promotion of education, promotion of literacy, Educ. Reforms etc.)

9. Sports (Including popular Sports, Athletics, Adventure, Mountaineering, promotion of sports, Yoga etc.)
10. Others (Fields not covered above and may include propagation of Indian Culture, Protection of Human Rights, Wild Life Protection/Conservation etc.)

It has now been decided with the approval of competent authority in the Government of India that the nominations/recommendations for the Padma Awards will be received online only, on an electronic management system designed by MHA (address of the website: <https://padmaawards.gov.in>).

You are, therefore, requested to kindly comply with the instructions given in the said letter and send the information online to the MHA within the given period i.e. **31st August, 2022 under intimation to this Secretariat with hard & soft copy (Proposals must be recommended by Concern District Collector)**, so that the recommendation of the State Government may be sent to GOI within the prescribed period.
