A bout GLC Sirohi:

The College, since 1984, running as Faculty/Department of Law at Government College, Sirohi later became independent college w.e.f. May, 2005. Initially, it was affiliated to University of Rajasthan which was later shifted to MLSU, Udaipur from session 1990-91 onwards. After the establishment of the State Law University the college is now under affiliation of Dr. Bhimrao Ambedkar Law University, Jaipur.

As per the terms of MOU signed with Bhamashah K.P. Sanghvi Charitable Trust, Pavapuri for construction of new campus building, the name of the college is now changed to Maa Ambe K.P. Sanghvi Government Law College, Sirohi.

In compliance of budget declaration for the year 2023-24, the College is upgraded to post graduation level. Therefore, at present, the institute offers 3 year LL.B and 2 year LL.M course.

About Sirohi District:

The Sirohi region is described as Arbuda in Vedic literature. The Guru Shikhar, the highest peak of Aravalli mountain, is situated at Mt. Abu (the tourist attraction of Sirohi). The District is famous pilgrimage centre for the Hindu and Jain community. The Palaeolithic pieces of evidence are reported from the West Banas River. It is having seventh century-old Sun Temple at Varman. The ruins of the famous medieval township Chandrawati, Mawal, and Rishikesh are situated in the District. Earlier the district was ruled by Parmars. Later in the 15th century, Deora Chauhan occupied the Sirohi area and paved the foundation of Sirohi. The name Sirohi from Sir=head; rohi=desert (Col Tod, 1909). Others think that the Sirohi literally means sword. After independence, the present Sirohi region is amalgamated in Rajasthan.

CONCEPT NOTE

Indigenous communities have unique culture and with their tradition deeply interwoven natural environment including land and forest. Regardless of their cultural differences tribal groups around the world face similar problems concerning the protection of their identities and rights. This has become an alarming issue for several national and international organizations including the United Nation as they declared their recognition of the rights of the indigenous people for self-governance.

In India, tribal population constitutes about 8.6 per cent of the total population of the country as per Census 2011 . Various laws and provisions meant for the protection of tribal rights could not render protection from exploitation and discrimination leading to their marginalization as a result of lackadaisical of governance approaches and administrative presentation. In the context of southern Rajasthan grea, the tribal population reside in place of paradoxes. Its rich in minerals but the people are living in abject poverty, both legal and illegal mining led to severe environmental degradation and means of livelihood. The tribal land traditional alienation besides acquisitions and resource displacement are severe cases of Human Right violation. The objective of the conference is to highlights these issues and suggest various steps to promote access to justice for tribals.
